Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Old Dominion University Research Foundation Tax-Sheltered Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of June 30, 2025, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Old Dominion University Research Foundation Tax-Sheltered Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by Old Dominion University Research Foundation (the Foundation or Employer) in January 1976, which was most recently amended and restated effective January 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration: The Plan is administered by the Foundation, which serves without compensation. The Plan Administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The Foundation has designated a committee to administer the Plan. The Foundation has outsourced the recordkeeping function of the Plan to Principal Financial Group (Principal), Teachers Insurance and Annuity Association and College Foundation Retirement and Equities Fund (TIAA and CREF), AXA Equitable Life Insurance Company (AXA-Equitable), Lincoln Financial Group (Lincoln), The Variable Annuity Life Insurance Company (VALIC), and Metropolitan Life Insurance Company (MetLife), the Custodians.

Amendments: The Plan was amended effective June 1, 2024 to allow for ROTH elective contributions, ROTH rollover contributions, and small account balances to be automatically distributed. In addition, the loan provisions were changed to limit participants to one outstanding loan and setting the minimum loan amount to \$1,000.

Contributions: As described in the Plan document, the Plan provides for two types of contributions: (1) 403(b) elective deferral contributions made by employees; and (2) qualified nonelective contributions made by the Employer. All employees are eligible to make elective deferral contributions. Certain employees are also eligible to receive allocations of employer qualified nonelective contributions. Regular employees hired during or after 2009, or who became regular employees during or after 2009, are eligible to receive allocations of qualified nonelective contributions after attaining age 21. Employees classified for purposes of the Plan as students, highly compensated employees or deemed highly compensated employees, as well as employees classified for the Employer's personnel purposes as visiting scholars, Old Dominion University faculty members, or post-doctoral associates, are ineligible to receive allocations of qualified nonelective contributions. Employees classified by the Employer as regular employees and temporary employees are also ineligible to receive allocations of qualified nonelective contributions if hired before 2009. Temporary employees, other than employees in excluded classes described above, who were hired during or after 2009, become eligible to receive allocations of qualified nonelective contributions after completing one year of eligible service and attaining age 21.

Participants may contribute pre-tax, annual compensation subject to certain Internal Revenue Code (IRC) limitations. Participants may also contribute amounts representing distributions from other qualified retirement plans, 403(b) tax sheltered annuity plans, government 457(b) plans, and traditional individual retirement accounts. Unless the employee is part of an excluded class of employees noted in the above paragraph, the employee is eligible to receive nonelective contributions made by the Foundation. The Foundation contributes 11% of employee compensation, as defined in the Plan document, as qualified nonelective contributions.

Note 1. Description of Plan (Continued)

Catch-up contributions: If a participant is eligible to make deferrals and reaches age 50 before the end of any calendar year, the participant may defer an additional amount into the Plan as a pre-tax contribution subject to certain IRC limitations. The maximum catch-up contribution is subject to change each year for cost of living changes.

Participant accounts: Each participant's account is credited with the participant's contributions, Foundation qualified nonelective contributions, and Plan earnings (losses) and charged with participant distributions and allocation of administrative expenses, if not paid by the Foundation. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options: Upon enrollment in the Plan during or after 2009, a participant may direct 100% of their allocation of contributions with Principal. Within Principal, participants may select between multiple investment options. Contributions made before 2009 may continue to be invested in annuity contract products of TIAA and CREF, AXA-Equitable, Lincoln, VALIC, and MetLife. The Plan Administrator decides which investments are available for participant accounts.

The investment options are limited to annuity contracts and mutual funds purchased through a custodial account. Each participant decides which of the investment options to use for participant contributions and related Foundation nonelective contributions.

Vesting requirements: Participants are immediately fully vested in their contributions, including catch-up contributions, rollover contributions from other plans, Employer qualified nonelective contributions, and earnings thereon.

Notes receivable from participants: Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms are up to five years, although longer term loans are available to finance the purchase of a participant's primary residence. Participants are limited to one outstanding loan at a time and the minimum loan amount is \$1,000. The loans are secured by the balance in the participant's account. The loans outstanding as of June 30, 2025, bear interest rates ranging from 8.25% to 9.50% and mature through 2035. Principal and interest is paid ratably over the term of the loan, not less frequently than quarterly.

Plan loans: Participants may borrow directly from funds held by Lincoln, secured by the balance in the participant's account, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The Plan loans bear interest rates of 7.0% as of June 30, 2025, with maturities through July 2028. Principal and interest is paid directly to Lincoln by the participant. Since Plan loans are borrowed directly from funds held by Lincoln, and not from participant accounts, they are not considered an asset of the Plan and are not included on the statements of net assets available for benefits. Outstanding Plan loans amounted to \$26,545 and \$10,520 as of June 30, 2025 and 2024, respectively.

Benefits paid to participants: The normal form of distribution under the Plan is a Single Life Annuity or Qualified Joint and Survivor Annuity (for participants with a spouse). Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or receive partial payment, installment payments, or an annuity. For termination of service for other reasons, distribution of the value of the participant's vested interest in his or her account will begin as soon as possible after the participant's request. Hardship distributions are permitted if certain conditions are met. In-service distributions are also available to those participants who have attained age 59½.

Note 2. Summary of Significant Accounting Policies

Basis of presentation: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's management determines the Plan's valuation policies utilizing information provided by the Custodians. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Participant and employer contributions that are determined from eligible compensation are recognized when compensation is incurred.

Benefits paid to participants: Benefits payments to participants are recorded when paid.

Administration expenses: Certain expenses of maintaining the Plan are paid directly by the Foundation and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses are reduced by amounts paid to the Plan under revenue sharing agreements in place.

Notes receivable from participants: Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of June 30, 2025 and 2024. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Subsequent events: The Plan has evaluated subsequent events through February 16, 2026, the date the financial statements were available to be issued.

Note 3. Information Certified by Custodians

The following is a summary of the Plan's information as of June 30, 2025 and 2024, and for the year ended June 30, 2025, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Principal, TIAA and CREF, AXA-Equitable, Lincoln, VALIC, and MetLife, the Custodians of the Plan. The Plan Administrator has obtained certifications from the Custodians that the information provided to the Plan Administrator by them related to the following assets and income, is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following:

Note 4. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 of the fair value hierarchy.

Insurance contracts (unallocated contracts): These investments are guaranteed fixed income annuities backed by individual custodian's claims paying ability whereby the annuity guarantees principal and a minimum interest rate, plus opportunity for additional amounts in excess of the guaranteed rate. Annuity contracts are not traded, and significant other observable inputs are not available. The contracts are reported at fair value determined using an income approach by discounting the related cash flows based on current yields or similar investments with comparable durations considering the credit worthiness of the issuer. As such, these investments are classified within Level 3 of the valuation hierarchy.

Pooled separate accounts: Pooled separate accounts represent ownership of units of participation (units), rather than ownership of specific assets. The value of any one pooled separate account is determined by aggregating the value of all of the units held by the Plan. The value of a single unit is the total value of the pooled separate accounts underlying investments plus other assets less liabilities divided by the total number of units outstanding. The fair values of the investments in this class have been estimated using the NAV per share (or its equivalent) as a practical expedient. There are no participant redemption restrictions for these investments.

Note 5. Fully Benefit-Responsive Investment Contracts

The Plan holds a portfolio of investment contracts that comprises traditional investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rates are based on a formula established by the contract issuer and are reviewed on a quarterly basis for resetting. The contracts cannot be terminated before the scheduled maturity date. The crediting rates are described in the following table for the year ended June 30, 2025:

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts are dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
- Premature termination of the contracts.
- Plan termination or merger.
- Changes to the Plan's prohibition on competing investment options.
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreements without the consent of the issuer.

Note 6. Party-in-Interest Transactions

Plan investments are shares of mutual funds, pooled separate accounts, insurance company's general accounts (unallocated contracts), and investment contracts, for which investments are managed by Principal, TIAA and CREF, AXA-Equitable, Lincoln, VALIC, and MetLife, the Custodians of the Plan, for the year ended June 30, 2025 and 2024.

Notes receivable from participants and related interest income qualify as party-in-interest transactions.

Fees paid by the Plan for the investment management and administrative services of Principal, AXA-Equitable, Lincoln, VALIC, and MetLife amounted to \$126,680 for the year ended June 30, 2025.

The Plan also paid indirect fees for the year ended June 30, 2025, which are included within net appreciation in fair value of investments on the statement of changes in net assets available for benefits. Indirect fees of \$45,734 were paid to Resource 1, Inc., the Plan's investment broker, for investment advisory services. Indirect fees of \$2,101 were paid to AXA Equitable Life Insurance Company, one of the Plan's Custodians, for recordkeeping.

Note 7. Tax Status

Effective June 1, 2024, the Plan adopted a Volume Submitter 403(b) Plan sponsored by Principal Life Insurance Company. The volume submitter plan provider has received an advisory letter from the Internal Revenue Service (IRS), dated March 31, 2017, as to the volume submitter plan's qualified status. The volume submitter advisory letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 9. Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
