To Whom It May Concern:

Enclosed is a copy of your notice dated February 16, 2026, assessing a penalty for Form 5500, in the amount of \$19,000.00. After reviewing our records, I believe the penalty resulted from an inadvertent administrative oversight rather than willful negligence.

Our Form 5500 filing process is handled by ADP, our 401(k) Plan Administrator. Each year, ADP sends a notification to our President when the filing is ready for review and submission. However, our President, Michelle Anderson, retired during 2024, and the notification email was not seen or acted upon during this transition. Consequently, the filing was unintentionally delayed. As soon as I became aware of the situation, I contacted ADP to update our administrative information. We changed the plan administrator designation to myself and updated the contact email address. These corrective steps ensure proper routing of future filing notifications and prevent recurrence of this issue.

Given that the late filing was due to reasonable cause and not willful negligence, I respectfully request abatement of the \$19,000.00 penalty. Please contact me if you need any additional information.
