Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Russell Sage Foundation Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended September 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from the qualified institutions as of September 30, 2025 and 2024 and for the year ended September 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of Russell Sage Foundation Retirement Plan (the "Plan") is provided for general information purposes only. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established in 1925, is a defined contribution plan which is available to eligible employees (as defined in the Plan document) of Russell Sage Foundation (the "Foundation"). Participation to make elective deferrals is voluntary and employees may enroll in the Plan at any time during their employment with the Foundation beginning with the first day of the month following their employment. There are no special age or service requirements to be satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Elective deferrals may be made to this Plan as either a pre-tax deferral or a Roth deferral. All employees are eligible to make elective deferral contributions. In November 2025, the Board of Trustees voted and approved that newly eligible employees and employees who are not currently participating will be automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3% of their eligible compensation. Each year, the deferral percentage will increase by 1% until the participant reaches 8% of their eligible compensation. The Foundation will implement this change on September 1, 2026. Employer contributions are allocated to the individual accounts of qualifying participants each Plan year equal to 12% of compensation as defined in the Plan document. Employees are eligible to receive employer contributions except for certain individuals such as visiting scholars, interns, independent contractors and student part timers. In no event will compensation in excess of a maximum set by the Internal Revenue Service ("IRS") each year be considered under the Plan. Participants may also contribute amounts representing distributions from other qualified plans.

Vesting

Participants are 100% vested in their elective deferrals, rollover contributions and any allocated earnings or losses thereon. Non-elective employer contributions and the earnings or losses thereon will fully vest after two years of service. Eligible active staff members become vested in the Plan after two years of service. Effective October 1, 2025, non-elective employer contributions and the earnings or losses thereon will vest immediately.

Participants will also be fully vested if employed on or after normal retirement age, upon death or disability, the Plan is terminated, contributions to the Plan are discontinued, or the requirement for early retirement age is met.

Participant Accounts

Each participant's account is credited with the participant's allocation of the participant's contributions, employer contributions, and allocations of the Plan earnings on his or her specific investments. Allocations of Plan earnings are based on each participant's account balance and charged with any applicable withdrawals, fund losses and administrative expenses, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance. All investments of the Plan are participant directed.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account as permitted by the Plan. In addition, participants may request distributions due to disability, after reaching age 65, and at any time with respect to employer contributions in annuity contracts issued prior to 2009. The Plan's policy is to make payments in lump sum, partial or installment payments, annuity contract (if assets are held in a custodial account), or conversion to an income option (if assets are invested in an annuity contract).

A participant may apply for a hardship withdrawal at any time from participant deferrals contributed to the Plan. This withdrawal must be for an immediate financial need for which funds are not reasonably available from other resources. Hardships include post-secondary educational expenses for the participant or their dependents, medical expenses, the purchase of a principal residence or major alteration thereto, to prevent eviction from or foreclosure on a principal residence or to pay for funeral or burial expenses or immediate and heavy financial need as determined based on IRS regulations.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000 (whichever is less). Participants may only have three outstanding loans at a time. The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence, or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

Loans to Participants/Collateralized Assets

Loans with Teachers Insurance and Annuity Association of America ("TIAA") are issued directly from funds owned by TIAA and not directly from a participant's account. Interest and principal are paid by the participant directly to TIAA. The loans are not considered assets of the Plan and, therefore, are not reported in the statements of net assets available for benefits. Adequate security is required and a portion of the participant's account is reserved, or held as collateral, to cover 110% of the outstanding loan in case of default. The collateral for the loan is maintained as part of the participant's TIAA Traditional Annuity account. The collateral securing the loan continues to earn interest. The collateralized balance is not available for transfer, withdrawal, retirement income benefits or survivor benefits.

The loan interest rate for these loans may be fixed or variable and the initial rate is determined by the terms of the controlling contract, as are the rate adjustment details and frequency. Principal repayments are transferred to the investment options chosen under the terms of the Plan.

Effective January 1, 2022, collateralized loans are no longer offered to Plan participants.

Loans to Participants/Collateralized Assets (continued)

At September 30, 2025 and 2024, there was 1 collateralized loan outstanding with total principal balances due of \$51,024 and \$48,488 which also represents a collateralization of participant accounts. Of these loan balances, there was 1 deemed distributed balance of \$51,024 and \$48,488 at September 30, 2025 and 2024. At September 30, 2025 and 2024, interest rate on the loan outstanding was 4.31% with maturity in 2025.

Forfeitures

Forfeiture accounts can be used to reduce future employer contributions and administrative expenses. As of September 30, 2025 and 2024, there were no forfeited non-vested accounts. During fiscal 2025, \$0 was forfeited from non-vested accounts and no forfeitures were used to reduce employer contributions and administrative expenses.

Other Income - Revenue Credit Account

The Plan and TIAA entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for payment of permitted Plan expenses or can be allocated to participants. In order for the Plan to receive credits as a result of this revenue sharing arrangement, the Plan created the Revenue Credit Account. The Revenue Credit Account is a non-participant directed cash account within the Plan and is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$9 and \$9 at September 30, 2025 and 2024. During fiscal 2024, no amounts were used from the Revenue Credit Account.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The TIAA Traditional Annuity Account is an unallocated contract and is segregated into non-benefit and benefit responsive categories. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). The contract value, which is derived from a discounted cash flow analysis and other factors, approximates fair value. Fair value approximates contract value for non-benefit responsive categories of the TIAA Traditional Annuity Account. Investments in registered investment companies are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. The registered investment companies are deemed to be actively traded. The pooled separate account is valued at the NAV of units held by the Plan. The NAV, as provided by TIAA and College Retirement Equities Fund ("CREF"), is used as a practical expedient to estimate fair value. The NAV based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the Plan are deducted from the value of the participants' assets and certain expenses are paid by the Foundation on behalf of the Plan. Expenses relating to investment management are paid directly by the representative investment vehicle and are included as a reduction to net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is February 4, 2026.

The TIAA Traditional Annuity Account is comprised of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity ("GSRA"), the Supplemental Retirement Annuity ("SRA"), and the Retirement Choice Plus ("RCP") contracts. The non-benefit responsive contracts are: the Group Retirement Annuity ("GRA"), the Retirement Annuity ("RA") and the Retirement Choice ("RC") contracts. The Plan utilizes the GSRA and SRA contracts, which are reported at contract value, and the RA and RC contracts which are reported at fair value. The contract value is the aggregation of contributions, plus interest, plus investment gains (realized and unrealized), plus transfers in from other investments, less withdrawals, fees, and transfers to other investments. Contract value approximates a discounted cash flow value calculated using a risk-adjusted market discount rate which correlates closely with the TIAA Traditional Annuity's historical crediting rates. Unobservable inputs include the discount rate applied and the range of significant input values are as follows: GSRA – 4.00%-4.50%; SRA – 4.00%-4.50%; RCP – 4.25%-4.75%; RC – 5.00%-5.50%; and RA – 4.75%-5.25%.

Under the GSRA, SRA and RCP contracts, lump-sum withdrawals and transfers can be done at any time without any surrender charges. Under the RC contract, lump-sum withdrawals and transfers can be done only within 120 days after termination of employment and is subject to a 2.5% surrender charge. All remaining withdrawals and transfers must be paid in 84 monthly installments. Under the RA contract, lump-sum cash withdrawals are not allowed and transfers must be paid in 10 annual installments.

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The Vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in-rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion.

4. Investments (*continued*)

The guaranteed portion represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

The TIAA Traditional Annuity, at fair value and contract value, represents approximately 19% and 20% of the Plan's net assets available for benefits as of September 30, 2025 and 2024, and represents an obligation from TIAA to repay as amounts come due. The plan administrator does not believe that any events would limit the Plan's ability to transact at contract value.

TIAA Real Estate (Pooled Separate Account)

The TIAA Real Estate Account generally invests in real estate properties and real estate-related investments. The TIAA Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. While redemptions from the TIAA Real Estate Account may occur daily, transfers out are limited to one per calendar quarter.

There are no unfunded commitments on the Pooled Separate Account.

5. Plan Termination

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participant accounts would become 100% vested.

6. Tax Status

The Foundation has adopted a restated prototype plan document effective January 1, 2010 which is intended to satisfy the Internal Revenue Service's final 403(b) regulations. The prototype plan document preparer received an opinion letter dated August 7, 2017 from the Internal Revenue Service. The Foundation believes that the Plan is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

Certain investments are managed by TIAA, the record-keeper and custodian, and CREF, a custodian. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

7. Party-in-Interest Transactions (*continued*)

Certain employees of the Foundation may also participate in the Plan or perform administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
