We have audited the financial statements of Ocusoft, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit), for the year ended December 31, 2024 and we have issued our report thereon dated September 12, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Reliance Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter dated February 18, 2025. Professional standards also require that we communicate to you the following information related to our audit.

### Significant Audit Matters

#### *Qualitative Aspects of Accounting Practices*

You are responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Ocusoft, Inc. 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

The financial statement disclosures are neutral, consistent, and clear.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in performing and completing our audit.

### *Uncorrected Misstatements*

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. None were noted during our audit.

### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### *Other Audit Findings*

During our testing during the prior year December 31, 2023 audit, we noted some differences for certain employees between the 2023 wages that were used to calculate the 2023 ER match (paid in 2024) per the match calculation spreadsheet and the payroll reports for those employees. We understood that these differences were being reviewed by the plan's TPA and plan sponsor and that any adjustments that result from this review, if any were required, would be made to the participants' accounts in 2024. During our 2024 audit, we noted that at least one employee's account did not appear to have been fully corrected. While this difference was not material to the plan's financial statements, we strongly recommend that match calculations be reviewed and reconciled carefully to supporting reports to ensure that match calculations are made correctly for all employees so that their participant accounts reflect all funds due to them.

During our current year testing during the December 31, 2024 audit, we again noted some differences for certain employees between the 2024 wages that were used to calculate the 2024 ER match (to be paid in 2025) per the match calculation spreadsheet and the payroll reports for those employees. We understand that these differences are being reviewed by the plan's TPA and plan sponsor and that any adjustments that result from this review, if any are required, will be made in 2025. We again strongly recommend that match reports be reviewed and reconciled carefully to ensure that match calculations are made with correct wages for all employees so that their participant accounts reflect all funds that are due to them.

### *Other Matters*

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use of the Board of Trustees of Ocusoft, Inc. 401(k) Plan and is not intended to be, and should not be used by anyone other than these specified parties.
