Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Cognia ERISA 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Cognia ERISA 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Opinion

NOTE A--DESCRIPTION OF PLAN

The following description of the Cognia ERISA 403(b) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Cognia, Inc. ("the Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. There are no age or length of service requirements to participate in the Plan.

Effective October 28, 2024, the CenterPoint Education Solutions 403(b) Plan (the "CES Plan") merged with the Plan. All assets of the CES Plan totaling \$5,805,414 were transferred to the Plan effective October 28, 2024.

Contributions: All participants who work full-time are required to make a mandatory contribution to the Plan of 2.5% of their pre-tax compensation, and the Plan provides for supplemental employee elective contributions of up to 100% of their remaining compensation, not to exceed the Federal statutory maximum. Subject to certain limits, participants are also allowed to make voluntary, non-deductible after-tax contributions to the Plan. The Employer makes a fixed, non-elective contribution to the Plan equal to 12.5% of eligible compensation of all participants who work full-time. Participants working part-time, as defined, are eligible for elective contributions to the Plan, but are excluded from the mandatory contribution and are not eligible for the employer non-elective contribution.

Participant Accounts: Each participant's account is credited with their contributions, the Employer's fixed, non-elective contributions, and their account's earnings or losses, less an allocation of administration expenses. All investments are participant directed.

Investments: Participants are able to allocate their contributions and employer contributions among a selection of equity and fixed income mutual funds and fixed rate and variable annuity contracts.

Vesting: Participants are immediately vested in their contributions and employer contributions, and allocated earnings thereon.

Notes Receivable from Participants: Participants are able to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. With the exception of loans included in rollover contributions

into the Plan, only one loan can be outstanding at any time. Loans are repaid through payroll deductions over periods of up to thirty years, depending on the purpose of the loan. The loans are secured by the vested balance in the participant's account. At June 30, 2025, the interest rates on outstanding participant loans ranged from 4.5% to 10.5%.

Payment of Benefits: Participants are entitled to receive a distribution of their vested account balance upon termination of employment, normal retirement (age 59½), or retirement due to permanent disability. The Plan allows for in-service distributions to participants that have reached age 59½, or in the event of a financial hardship.

Administration: The Plan is administered by the Employer. All funds in the Plan are held by the custodians of the Plan's assets, Security Financial Resources, Inc. ("Security Benefit") as agent for UMB Bank, n.a., Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equities Fund ("CREF"), and Corebridge Financial as agent for The Variable Annuity Life Insurance Company ("VALIC") (collectively, "the Custodians"). The Custodians invest contributions, as directed by the participants. During the year ended June 30, 2025, all contributions were invested with Security Benefit.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan follows the Financial Accounting Standards Board Accounting Standards Codification as its sole source of authoritative guidance.

The financial statements of the Plan are prepared using the accrual basis of accounting.

The Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* (FAB 2009-02). If the identified contracts, as reported by the Custodians, were included, net assets available for benefits would increase by \$1,285,110 and \$1,360,939 as of June 30, 2025 and 2024, respectively. Further, investment gains of \$129,402 and benefits paid to participants of \$205,231 for the year ended June 30, 2025 related to such accounts, as identified by the Custodians, have also been excluded in the accompanying statement of changes in net assets available for benefits. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

NOTES TO FINANCIAL STATEMENTS--Continued

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

The Plan's investments are reported at fair value, except for fully benefit responsive investment contracts which are reported at contract value, as more fully described in Notes C and D. Investments are exposed to various risks, including credit, interest, and overall market volatility risks. Due to the level of risk associated with certain investments, it is possible that changes in values of investments will occur and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments sold as well as the change in unrealized gains/losses for investments held at the end of the year.

Notes receivable from participants are reported separately from Plan investments and are measured at their unpaid principal balance.

Contributions are recorded on the accrual basis, which recognizes participants' contributions and Employer non-elective contributions at the time the participants' contributions are withheld from their wages.

Benefits are recorded when paid.

Certain administrative expenses of the Plan are paid for by the Employer.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated through February 4, 2026, which is the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

Current accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the accounting guidance are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025:

Mutual funds: The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are valued at the quoted market prices of the underlying investments and are classified within Level 1 of the fair value hierarchy.

Variable annuities: The Plan invests in variable annuity accounts through open-ended registered investment companies. These variable annuity accounts are valued at the quoted market prices of the underlying investments and are classified within Level 1 of the fair value hierarchy.

Pooled separate account: The TIAA Real Estate Account is a pooled separate account and is a registered investment company. The account's value is based on the market values of the underlying holdings, primarily real estate. The account is classified within Level 1 of the fair value hierarchy.

Fixed annuity contracts: The non-fully benefit responsive TIAA Traditional Annuity contracts are reported at fair value, which approximates contract value. Contract value is the aggregation of contributions, plus interest, and less withdrawals. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Contract value approximates a discounted cash flow value calculated using a risk-adjusted market discount rate. This investment is classified within level 3 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the year ended June 30, 2025, participant initiated sales of TIAA Traditional Fixed Annuity contracts resulted in the transfer of \$46,374 out of Level 3 of the fair value hierarchy.

Fixed annuity contracts which are not fully benefit responsive are valued using the discounted cash flow method utilizing risk-adjusted discount rates. Quantitative information regarding this significant unobservable input was as follows for the years ended June 30, 2025 and 2024:

NOTE D--INVESTMENT CONTRACTS

The Plan has investment contracts issued by TIAA and Security Benefit. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the contracts. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Certain TIAA Traditional Annuity contracts are considered not fully benefit responsive and are included in the financial statements at fair value, as more fully described in Note C.

TIAA Traditional Annuity contracts provide participants with specified lifetime income payments and are guaranteed by TIAA's claims paying ability. These payments are based on the participants' contributions to this investment option and the contractual rate schedule in effect at the time the contributions (premiums) were paid. The contract value of the participant balances invested in the fully benefit responsive TIAA Traditional Annuity was \$133,096 and \$135,009 as of June 30, 2025 and 2024, respectively.

TIAA Traditional Annuity contracts provide for a minimum guaranteed interest rate, as defined. Crediting rates are determined by the issuer annually on January 1st for contracts in payout status and March 1st for contracts that remain in the accumulation phase. The applicable interest rate will be credited to all monies invested in the account during the period. In no event will the declared rate of interest be less than the contract's minimum guaranteed interest rate of 1%.

The Security Benefit Fixed Account Option provides participants with a specified return on invested funds, guaranteed by the claims paying ability of Security Benefit Life Insurance Company, an affiliate of Security Benefit. Investment returns are based on crediting rates which are declared on a quarterly basis. The contract value of participant balances invested in the Security Benefit Fixed Account Option was \$3,535,735 and \$3,268,273 as of June 30, 2025 and 2024, respectively.

The Security Benefit Fixed Account Option provides for a minimum guaranteed interest rate, as defined. Crediting rates are determined by the issuer on a quarterly basis. The applicable interest rate will be credited to all monies invested in the account during the period. In no event will the declared rate of interest be less than the contract's minimum guaranteed interest rate of 1%. As of June 30, 2025, the declared crediting rate for the quarter was 1.95%.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. Examples of such events include: premature termination of the contract by the Plan; termination or merger of the Plan; changes to the Plan's prohibition on competing investment options; bankruptcy or changes in ownership of the Plan Sponsor; failure of the Plan to satisfy tax qualification requirements as more fully described in Note F.

In addition, certain events allow the contract issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include: uncured violations of the Plan's investment guidelines; a breach of a material obligation under the contract; material misrepresentation; and a material amendment to agreements without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

NOTE E--TRANSACTIONS WITH PARTIES IN INTEREST

The Plan has agreements with the Custodians to maintain the investments of the Plan and to provide administrative and participant record keeping services for the Plan. For the year ended June 30, 2025, contributions and transfers to the Plan of \$7,632,727 and \$5,805,414, respectively, were deposited with Security Benefit for investment, and participants of the Plan received distributions of \$7,752,607 from funds held by the

Custodians. Additionally, for the year ended June 30, 2025, the Plan recorded \$581,508 in administrative expenses paid to Security Benefit. At June 30, 2025 and 2024, the Plan had \$101,580,326 and \$84,926,628, respectively, of assets under the Custodians' custody.

NOTE F--TAX STATUS

The Plan is intended to satisfy the tax qualification requirements under Section 403(b) of the Internal Revenue Code; therefore, the custodial accounts of the Plan are intended to be exempt from Federal income taxes. The Plan has not requested a favorable determination letter from the IRS since the prototype on which the Plan is based has been determined to be qualified under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE G--PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and terminate the Plan, subject to the provisions of ERISA.

NOTE H--RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For year ended June 30, 2025, there were no significant differences between the financial statements and the Internal Revenue Service Form 5500.

NOTE I--SUMMARY OF INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The total value of the Plan's net assets was \$101,580,326 and \$84,926,628 at June 30, 2025 and 2024, respectively. Qualified institutions (the Custodians more fully described in Note A) have supplied the Plan Administrator with certifications as to the completeness and accuracy of all information presented in the accompanying statements of net assets available for benefits as of June 30, 2025 and 2024, and in the statement of changes in net assets available for benefits for the year ended June 30, 2025, with regard to investment activity. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.
