**Note 1 - Description of the Plan**

**General** - Bost, Inc. 401(k) Retirement Plan (the Plan) is a defined contribution plan established July 1, 1998. Participants in the Plan are full-time employees of Bost, Inc. (the Organization), have one year of service, and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Each year, participants may contribute a discretionary amount of annual compensation as defined in the Plan. The amount that can be contributed is set by law each year and was limited to \$23,500 and \$23,000 for the calendar years 2025 and 2024, respectively. Participants age 50 or over may contribute an additional amount, known as a “catch-up” contribution, limited to \$7,500 for the calendar years 2025 and 2024. In 2025, participants age 60 to 63 were allowed to contribute an additional amount, known as a “super catch-up” contribution, limited to \$3,750. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. The Organization makes a discretionary contribution of 4% of the annual contributions. These employer contributions are invested in the same manner as employee contributions.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization’s contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service, with the participant vesting 20% per year of service after the first year.

**Payment of Benefits** - If the Plan is terminated, the trustees shall apply the trust funds in payment of, or provide for the payment of, any and all obligations of the Plan in accordance with the provisions of the Plan and all participants will become 100% vested. No part of the assets shall be returned to the Organization. Distributions from the Plan may be made as a lump sum payment.

**Forfeited Accounts** - The forfeiture balance was \$1,173 and \$0 at June 30, 2025 and 2024, respectively. The account is used to pay plan administrative expenses or restore non-vested benefits to eligible rehired employees. Forfeitures were used to pay plan administration expenses in the amount of \$9,525 and \$2,300 during the years ended June 30, 2025 and 2024, respectively.

**Administrative fees** - The plan sponsor may, at its discretion, pay the administrative costs of the Plan.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting generally accepted in the United States of America.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrators to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan’s investments are stated at fair value as determined by quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Benefits are recorded when paid.

**Funding Policy**

It is the policy of Bost, Inc. to pay employee contributions to the Plan as soon as it is administratively possible to segregate the payroll data. Bost, Inc. funds its accrued discretionary contribution on or before the due date of Bost, Inc.’s Form 990, including extensions.

**Note 3 - Fair Value Measurement**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no Plan investments requiring the use of Level 2 or Level 3 inputs for the periods presented.

**Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

**Note 6 - Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Organization may determine.

**Note 8 - Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Organization by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 9 - Concentrations of Credit Risk**

All investments of the Plan are held by American Trust Company, and the Plan does not require collateral.

**Note 10 - Subsequent Events**

The plan administrator has evaluated subsequent events through February 2, 2026, the date which the financial statements were available for issue.

**Note 1 - Description of the Plan**

**General** - Bost, Inc. 401(k) Retirement Plan (the Plan) is a defined contribution plan established July 1, 1998. Participants in the Plan are full-time employees of Bost, Inc. (the Organization), have one year of service, and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Each year, participants may contribute a discretionary amount of annual compensation as defined in the Plan. The amount that can be contributed is set by law each year and was limited to \$23,500 and \$23,000 for the calendar years 2025 and 2024, respectively. Participants age 50 or over may contribute an additional amount, known as a “catch-up” contribution, limited to \$7,500 for the calendar years 2025 and 2024. In 2025, participants age 60 to 63 were allowed to contribute an additional amount, known as a “super catch-up” contribution, limited to \$3,750. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. The Organization makes a discretionary contribution of 4% of the annual contributions. These employer contributions are invested in the same manner as employee contributions.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization’s contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service, with the participant vesting 20% per year of service after the first year.

**Payment of Benefits** - If the Plan is terminated, the trustees shall apply the trust funds in payment of, or provide for the payment of, any and all obligations of the Plan in accordance with the provisions of the Plan and all participants will become 100% vested. No part of the assets shall be returned to the Organization. Distributions from the Plan may be made as a lump sum payment.

**Forfeited Accounts** - The forfeiture balance was \$1,173 and \$0 at June 30, 2025 and 2024, respectively. The account is used to pay plan administrative expenses or restore non-vested benefits to eligible rehired employees. Forfeitures were used to pay plan administration expenses in the amount of \$9,525 and \$2,300 during the years ended June 30, 2025 and 2024, respectively.

**Administrative fees** - The plan sponsor may, at its discretion, pay the administrative costs of the Plan.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting generally accepted in the United States of America.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrators to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan’s investments are stated at fair value as determined by quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Benefits are recorded when paid.

**Funding Policy**

It is the policy of Bost, Inc. to pay employee contributions to the Plan as soon as it is administratively possible to segregate the payroll data. Bost, Inc. funds its accrued discretionary contribution on or before the due date of Bost, Inc.’s Form 990, including extensions.

**Note 3 - Fair Value Measurement**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no Plan investments requiring the use of Level 2 or Level 3 inputs for the periods presented.

**Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

**Note 6 - Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Organization may determine.

**Note 8 - Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Organization by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 9 - Concentrations of Credit Risk**

All investments of the Plan are held by American Trust Company, and the Plan does not require collateral.

**Note 10 - Subsequent Events**

The plan administrator has evaluated subsequent events through February 2, 2026, the date which the financial statements were available for issue.
