Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of Planned Parenthood of Northern, Central and Southern New Jersey, Inc. Group Medical Plan (formerly Planned Parenthood of Northern, Central and Southern New Jersey, Inc. Employee Benefit Plan) (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan provides health benefits to eligible employees of Planned Parenthood of Northern, Central and Southern New Jersey (the Company) and covered dependents. An Employee of the Company who regularly works 21 or more hours of service per week will be eligible to enroll for coverage under this Plan once he/she completes a waiting period of 30 days from the first day he or she reports for employment with the Company. Participation in the Plan will begin as of the first day of the month following completion of the waiting period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2023 the Plan name was changed from Planned Parenthood of Northern, Central and Southern New Jersey Medical Plan to Planned Parenthood of Northern, Central and Southern New Jersey, Inc. Group Medical Plan.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Company makes contributions to the Plan as needed to fund claims and expenses in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Benefits

The Plan provides medical and prescription drug benefits to all eligible enrolled employees and enrolled dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Self-insured Benefits

All Plan benefits are self-insured, including medical and prescription drug benefits. The claims for self-insured medical benefits are processed by Meritain under administrative services only (ASO) arrangements. The claims for self-insured prescription drug benefits are processed by Rx Valet. Meritain and Rx Valet pay claims directly to or on behalf of participants and are then reimbursed by the Plan's trust. Veris Benefits Consortium, LLC (Veris) pays claims directly to or on behalf of participants from the claims funding account held by Veris. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Self-insured Benefits (Continued)

The Plan has a health reimbursement arrangement (HRA) that is funded solely through Company contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The Company is not permitted to refund any part of the balance to the employee, the account cannot be used for anything other than reimbursements for qualified medical expenses, and remaining amounts are not portable upon termination once the employee leaves the Company.

Stop-Loss Coverage

The Company has entered into a stop-loss insurance arrangement in an effort to limit their exposure for self-insured benefits (individual participant claims over a specified dollar amount, as well as aggregate exposure for all claims). The premiums are being paid by the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Contributions

Contributions from the Company to cover administrative expenses are recorded in the period in which such expenses are incurred. Contributions from the Company to cover claims are recorded in the period in which the claims are paid by the Plan. Contributions from the Company are paid based upon the amount required to be funded under the provisions of the Plan. Employee contributions are recorded in the period in which they are withheld from payroll.

Benefits

Claim payments are recorded when paid by the third-party claims processors. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Stop Loss Coverage

Stop loss premiums are recorded when paid. Stop loss reimbursements are not recognized in the financial statements as the Company is the policy holder. Any stop loss reimbursements entitled by the Company contributed to the Plan are recorded as Company contributions in the statement of changes in net assets available for benefits.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Benefit Obligations

As of December 31, 2024 and 2023, there are many self-funded claims that have been incurred on which benefit payments have been and/or will be made subsequent to that date. Estimated claims payable represents unpaid claims at year-end that have been reported to the claims administrator and is based on information available regarding claims paid subsequent to the Plan year-end. Estimated claims incurred but not reported as of December 31, 2024 is based on information available to an actuary regarding claims incurred during the Plan year, claims lag history of the Plan, anticipated stop-loss coverage and similar restrictions on benefits, and other trend factors. As of December 31, 2023, the liability was estimated by management using actual claims lag reports from service providers. The Plan does not provide postretirement benefits.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan and are excluded from these financial statements.

Concentration of Credit Risk

The Plan's cash balances are held at one financial institution. Accounts at this institution are insured by a government agency up to \$250,000. At times, the balances in these accounts may exceed the insured limit.

Subsequent Events

The Plan has evaluated subsequent events through August 5, 2025, the date the financial statements were available to be issued.

NOTE 3 TAX STATUS

The trust of the Plan is structured as a taxable trust to serve as a funding vehicle for the Plan under appropriate sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC. The trust has not generated taxable income during the year ended December 31, 2024.

Accounting policies generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 6 RISKS AND UNCERTAINTIES

The liability for claims payable and claims incurred but not reported (IBNR) at December 31, 2024 was estimated by management using reporting from an actuary whom used a reserve factor to a credible best estimate volume measurement of paid claims. The actuary utilized information available regarding claims incurred during the year, claims history of the plan, and other trend factors. The liability for claims payable and claims (IBNR) at December 31, 2023, was estimated by management using actual claims lag reports from service providers. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
