**Note 1 – Description of Plan**

---

The following brief description of the Brown, Edwards & Company, L.L.P. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

*General*

The Plan is a defined contribution section 401(k) Plan covering substantially all employees of Brown, Edwards & Company, L.L.P. (the “Firm”), excluding interns. Employee elective contributions are permitted as early as the first pay period following commencement of service with the firm provided the employee is age 21 or older. The Plan provides recognition of service with any entity or business the firm acquires whether by asset or stock purchase, but only with respect to individuals who are employees of the acquired entity at the time of the acquisition for purposes of eligibility, vesting, and contribution allocation. Employer matching contributions are made for those participants who elect to make contributions to the Plan and are age 21 or older. Profit sharing contributions are made for those participants who have one year of service, are age 21 or older, and are employed by the Firm at Plan year end. Established in 1984, the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As required by ERISA, both the Trustee and the Administrator of the Plan are covered by fidelity bonds.

The Plan was amended effective October 31, 2024 to exclude reimbursements or other expense allowances, fringe benefits, moving expenses, deferred compensation, and welfare benefits as well as holiday bonuses for purposes of elective deferrals and employer match contributions.

*Contributions*

The Plan provides for elective employee salary reduction contributions, discretionary firm profit sharing contributions, discretionary firm matching contributions, and after-tax voluntary employee contributions. Participants are permitted to elect pre-tax salary deferrals and after-tax ROTH deferrals, subject to calendar year limits as defined in the *Internal Revenue Code*. Employee deferrals up to 9% of compensation were matched at a 1/3 rate. Discretionary profit sharing contributions may be made annually. For the year ended May 31, 2025, discretionary profit sharing contributions of \$1,903,631 were allocated to employees and partners.

*Participant Accounts*

The Plan provides for each participant’s account to be credited with the participant’s contribution and allocation of the Firm’s contributions and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The Plan’s investments are participant directed. Participants direct their contributions to a combination of investments with Alerus Financial Corporation or in a self-directed brokerage account through Charles Schwab.

*Vesting Requirements*

The Plan provides for immediate vesting of participant contributions and earnings thereon. With respect to profit sharing and matching contributions, the Plan provides for graded vesting of 20% for each year of credited service following the year the employee begins participation in the Plan. Participants are 100% vested after six years of credited service.

*Administration*

The Plan is administered through Alerus Financial Corporation who serves as Trustee and Custodian of participant directed investments, and Charles Schwab who serves as Custodian of self-directed brokerage accounts.

*Distribution of Benefits*

On termination of service a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments.

*Forfeitures*

If a participant terminates employment prior to becoming fully vested, the non-vested portion of the participant's account, as defined by the Plan, is forfeited. Forfeitures are added to the Firm's profit sharing contribution and are allocated to eligible participants. At May 31, 2025 and 2024, forfeited non-vested accounts totaled \$109,974 and \$80,098, respectively. During 2025, \$80,098 was allocated to participant accounts.

*Termination*

The Firm has the right to amend or terminate the Plan subject to the provisions of ERISA. Upon termination, participant accounts become fully vested and nonforfeitable.

*Administrative Expenses*

Expenses of Plan administration not paid by the Plan Sponsor may be paid by the Plan.

*Notes Receivable from Participants*

Participants may borrow from their accounts up to \$50,000, not to exceed 50% of the participant's nonforfeitable account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from 1-5 years or longer for the purchase of a primary residence. The loans are secured by the balance of the participant's account and bear a market rate of interest. At May 31, 2025, outstanding loans carried interest rates of 4.25% to 9.5% which remain fixed during the term of the loan. Principal and interest are paid ratably through payroll deductions. Interest earned through loan repayments are recorded as interest income.

**Note 2 – Summary of Significant Accounting Policies**

*Basis of Accounting*

The Plan maintains its records on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 31, 2025 or 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced (if loan balance is allowed to be offset) and a benefit payment is recorded.

*Benefit Payments*

Benefits are recorded when paid.

**Note 4 – Tax Status**

---

The Plan is a prototype plan which received a favorable opinion letter from the IRS dated June 30, 2020 stating it is a qualified plan under Section 401(a) of the *Internal Revenue Code (IRC)*. The Plan has been restated and amended, and although the Plan was amended to the Plan Sponsor’s specifications, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the *IRC*.

Generally accepted accounting principles requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of May 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5 – Related Party Transactions**

---

Alerus Financial Corporation, the Trustee and Custodian, held and invested mutual funds and contracted with Charles Schwab, a Custodian, to maintain self-directed brokerage accounts as requested by Plan participants. For the period ended May 31, 2025, fees totaling \$144,867 were paid by the Plan, \$46,933 to the Trustee and Custodian and \$97,934 to Focus Partners Advisor Solutions to provide investment management and advisory services.

---

**Note 6 – Fair Value Measurements**

---

The Plan follows Accounting Standards Codification (ASC) 820, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The categorization of each investment type within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. ASC 820 establishes three levels of inputs that may be used to measure fair value:

**Level 1** – quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability and can be corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – unobservable inputs that are supported by little or no market activity and reflect the Plan’s own assumptions about market participants and investment prices.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

*Self-Directed Brokerage Accounts – Mutual Funds, ETFs, Common Stocks, and Corporate Bonds*

The investments in mutual funds, ETFs, and common stocks are valued based on quoted market prices and are classified as Level 1 in the fair value hierarchy.

The investments in corporate bonds are based on observable market data that is not readily available through a quoted price but is based on observable inputs for similar comparable securities such as interest rates and yield curves.

Six participants had accounts in self-directed brokerage accounts during the years ended May 31, 2025 and 2024.

*Mutual Funds*

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year-end and are classified as Level 1 in the fair value hierarchy.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
