NOTES TO FINANCIAL STATEMENTS

1. Description Of The Plan

The following description of the Thompson Truck & Trailer, LLC 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all full-time employees of Thompson Truck and Trailer, LLC, Thompson Tire & Retread, Inc., Thompson Leasing, LLC d/b/a Thompson Idealease and Riggs Towing, LLC d/b/a Big 10 University Towing (collectively, the Employer) who have completed three months of service for elective deferrals and one year of service for employer contributions. Union employees of Thompson Truck and Trailer, LLC are not eligible for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100% of eligible compensation in the form of pre-tax or after-tax (ROTH) contributions not to exceed Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Under the provisions of the Plan, the Employer has the option to make discretionary matching contributions equal to a percentage of eligible participants' elective deferral contributions. Participants who are not covered under a collective bargaining agreement are eligible for the discretionary match upon completing one year of service. The Employer elected to make matching contributions equal to 100% of each participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the participant's elective deferrals in excess of 3% of the participant's compensation, limited to 5% of the participant's compensation for the year ended December 31, 2024.

Under the provisions of the Plan, the Employer has the option to make discretionary profit-sharing contributions. Participants who are not covered under a collective bargaining agreement are eligible for the discretionary profit-sharing contributions. The Employer elected to not make any discretionary profit-sharing contributions to the Plan for the year ended December 31, 2024.

Notes To Financial Statements (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and discretionary employer matching and profit-sharing contributions as well as allocations of the Plan's earnings and expenses. Allocations are based on the participant's eligible compensation, the value of account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their rollover and voluntary contributions, plus actual earnings thereon. Participants are 10% vested in the employer discretionary matching and profit-sharing contributions upon completion of one year of credited service and vesting occurs at a rate of 20% for each year of credited service thereafter. Participants are fully vested after six years of credited service or upon death, disability or attainment of normal retirement age of 65.

Hardship Withdrawals

Participants may elect to withdraw all or a portion of their pre-tax and ROTH elective deferral contribution balances if they incur a financial hardship. Hardship withdrawals are subject to the terms of the plan agreement and provisions of the IRC.

Payment Of Benefits

Upon termination of service due to death, disability or retirement, participants with an account balance greater than \$7,000 may elect to receive either a lump-sum amount equal to the value of their account, receive installments over a period of time or leave their balance in the Plan subject to minimum distribution requirements. Under the default automatic rollover provisions, distributions less than \$7,000 will be made to an Individual Retirement Account without participant consent if a participant does not make a different distribution election after receiving the required notification.

In-Service Withdrawals

Active participants who reach age 59½ may withdraw all or part of their participant contributions.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited accounts totaled \$17,344 and \$41,376, respectively. These accounts may be used to reduce employer contributions or to pay administrative expenses. In 2024, employer contributions of \$48,439 were paid from forfeited accounts.

2. Summary Of Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use Of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's fiduciary committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions

Contributions from plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Profit-sharing contributions are recorded in the year in which they are declared by the Employer.

Payment Of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through February 17, 2026, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

5. Investment Contract With Insurance Company

The Plan holds a traditional investment contract under a group annuity contract issued by Standard Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount that would be received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value. The issuer of the contract is contractually obligated to repay the principal and interest at a specific interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer but may not be less than the guaranteed minimum interest rate as set forth in the contract. The minimum interest rate of the guaranteed investment contract was 1% at December 31, 2024 and 2023. The crediting rate is reviewed on a semiannual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at the contract value with the contract issuer. These events include, but may not be limited to, the following: (1) termination of the contract, (2) spin-offs, (3) divestitures, (4) layoffs, (5) corporate relocation or (6) partial or total plan termination. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at the contract value with the issuer or participants, is probable.

In addition, certain events as outlined in the contract allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

7. Prohibited Transactions

As required by ERISA Section 2510.3-102, the Employer is required to segregate employee contributions to the Plan from its general assets as soon as practicable. The Plan had contributions totaling \$66,353, all of which represented employee salary deferrals, that were not remitted timely during 2023 and 2024. These contributions are considered prohibited transactions.

For lost earnings that have yet to be corrected as of December 31, 2024, the Employer will calculate lost investment earnings and compensate the Plan for such amounts in 2026.

8. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's legal counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks And Uncertainties

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

10. Subsequent Events

The Securing a Strong Retirement Act (SECURE 2.0) was signed into law on December 29, 2022 and includes mandatory and optional provisions with effective dates in 2025 and later. The plan administrator will determine the optional provisions to elect and amend the plan document accordingly.

Effective February 7, 2025, sponsorship of the Plan was transferred from Thompson Truck & Trailer, LLC to Riggs Towing, LLC d/b/a Big 10 University Towing and the name of the Plan was changed to Riggs Towing & Recovery LLC 401(k) Plan.

In addition, effective February 7, 2025, certain assets of Thompson Truck & Trailer, LLC were sold to an unrelated entity, leading to a significant reduction in workforce. As a result, the Plan incurred a partial termination which required the acceleration of 100% vesting of all affected participants account balances effective February 7, 2025.
