### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the December 31, 2024 financial statements of Chosen Foods LLC 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Chosen Foods LLC 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1. DESCRIPTION OF THE PLAN

Chosen Foods LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) is sponsored by Chosen Foods, LLC (the “Company”). The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General

The Plan is a defined-contribution plan covering substantially all employees of the Company. The Plan was originally formed effective January 1, 2015. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”) and the provisions of the Internal Revenue Code (the “Code”). The Plan operated as a safe harbor plan for the years ended December 31, 2024 and 2023, which exempts the Plan from anti-discrimination requirements by mandating that the Company make minimum contributions to all participant accounts. The Company is the Plan’s sponsor and serves as plan administrator.

Eligibility

Employees who are at least 21 years of age are generally eligible to participate in the Plan. Individuals who are (a) union employees, (b) leased employees, or (c) nonresident aliens are not eligible to participate in the Plan. Eligible employees may enter the Plan on the first day of the month following satisfaction of the eligibility requirements.

Contributions

Each year, participants may contribute a portion of annual compensation, subject to certain statutory limitations, and may designate their contributions as either pre-tax or Roth contributions, as defined. Participants who are age 50 or older are eligible to defer additional amounts (“catch-up contributions”) to the Plan up to the maximum allowed by the Code. Participants may also contribute amounts representing distributions from other qualified sources (“rollover contributions”).

The Plan includes a provision for Company safe harbor contributions for the year ending December 31, 2024. The safe harbor contributions were equal to 3% of the eligible participants’ compensation. The safe harbor contributions for December 31, 2024 were \$319,854.

Contributions (continued)

The Company may also elect to make discretionary matching contributions and discretionary profit-sharing contributions. The amount is determined each year. The Company did not make any discretionary matching or profit-sharing contributions during the year ended December 31, 2024.

Vesting

Participants are immediately vested in their own contributions and the Company's safe harbor contributions, and the earnings or losses thereon. Vesting in the Company's discretionary matching and profit-sharing portion of their accounts is based on continuous years of service, as defined in the Plan, according to the following schedule:

A participant is 100% vested after two years of credited service, attainment of normal retirement age, death, or disability.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor contributions, discretionary matching contributions, and discretionary profit-sharing contributions. The allocation of Company profit-sharing contributions is determined by the Company subject to a general non-discrimination test. Each participant has an individual investment account and is credited with the earnings from that account.

Administrative charges related to participant loans and distributions are deducted directly from the transacting participant's account.

Note 1. DESCRIPTION OF THE PLAN (continued)

Benefits

Upon termination of service, attainment of normal retirement age, disability or death, the participant will receive the value of the vested interest in his or her account as a lump-sum distribution or other distribution methods elected by the participant. Participants may also be eligible to request a distribution from their vested portion of their elective deferral and Roth contribution accounts in the event of undue financial hardship subject to certain conditions and limitations as defined in the Plan.

Notes Receivable from Participants

Participants may borrow against their accounts a minimum of \$1,000 up to a maximum, generally equal to the lesser of 50% of their vested account balance or \$50,000. Participants may have only one loan outstanding at a time. The loans are issued by the Plan and secured by the vested balance of the participant's account. Loan terms may not exceed 5 years unless the loan is to be used to acquire the principal residence of the participant, for which the loan term may not exceed 10 years. Interest is at 1% over the prime rate when the loan is originated and is fixed for the life of the loan. Interest rates on outstanding participant loans ranged from 9.00% to 9.50% at December 31, 2024 and 2023.

Investments

The Plan allows participants to direct their account balance to any combination of a variety of investment funds. The number of such funds and the type of investments therein may be changed at any time by the Plan. Participants may change their investment options at any time.

Forfeitures

Forfeitures of non-vested Company contributions may be used to pay administrative expenses or reduce the Company's contributions. The balance in the forfeitures account was \$19,895 as of December 31, 2024.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company.

Note 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Pooled separate accounts are valued based on the number of units held by the Plan multiplied by the unit value (which factors in dividends and realized and unrealized gains and losses for the underlying funds), as determined by Voya Retirement Insurance and Annuity Company.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a settlement date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year as well as held at year end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as a distribution based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Note 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1 Fair Value Measurements*

Fair values are based on publicly quoted prices in active markets for identical assets or liabilities. The fair value of investments in pooled separate accounts is based on the publicly quoted net asset value of the shares held by the Plan at year-end.

*Level 2 Fair Value Measurements*

Fair values are based on observable inputs other than publicly quoted prices in active markets for identical assets.

*Level 3 Fair Value Measurements*

Fair values are based on unobservable inputs used for valuing the asset.

Note 4. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan invests in a fully benefit-responsive guaranteed investment contract, the Voya Fixed Account, through a group annuity contract with Voya Retirement Insurance and Annuity Company. The Voya Fixed Account is an obligation of Voya Retirement Insurance and Annuity Company's general account, which supports all of its insurance and annuity commitments. The Voya Fixed Account guarantees principal and a minimum rate of interest. The current interest rate credited under the contract may be higher than the guaranteed minimum interest rate and may be changed at any time. As of December 31, 2024 and 2023, the contract value of the Voya Fixed Account was \$79,014 and \$112,981, respectively, and the interest rate equaled the guaranteed minimum interest rate of 1.00% per annum. All guarantees are based on the financial strength and claims-paying ability of Voya Retirement Insurance and Annuity Company, who is solely responsible for all obligations under its contracts. Certain events may limit the Plan's ability to execute transactions at contract value with the issuer (e.g., premature termination of the contract by the Plan, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives, among others); however, the Plan Administrator has determined that those events that would limit the ability of the Plan to transact at contract value with plan participants are not probable of occurring.

Note 6. PARTY-IN-INTEREST

The Company pays certain administrative costs of the Plan. The Company is the sponsor of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. The most significant of these costs paid by the Company are the salaries for the employees responsible for plan administration.

Voya Retirement Insurance and Annuity Company, as custodian and investment manager for the Plan's assets, disburses benefit payments and executes all investment transactions. As a result, certain investment transactions qualify as party-in-interest transactions.

Note 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account balance.

Note 8. FEDERAL INCOME TAX STATUS

The Plan is operated pursuant to a prototype non-standardized 401(k) plan offered by Voya Retirement Insurance and Annuity Company. The prototype plan received a determination letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, indicating that the Plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receipt of the determination letter, the plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt. No provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for an uncertain position if it is not more likely than not that the position would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 10. SUBSEQUENT EVENTS

Subsequent events were evaluated for accrual and disclosure through February 18, 2026, which is the date the 2024 financial statements were available to be issued.
