### Note 1 - Plan Description

The following description of Chicago Symphony Orchestra Association 403(b) Plan for Administrative Employees (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a 403(b) defined contribution plan that covers certain administrative employees of Chicago Symphony Orchestra (the "Corporation") who are not represented by the collective bargaining agreements (CBA) with members of the orchestra or stagehands. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Ascensus, LLC provided record-keeping and administrative services for the Plan.

#### **Contributions**

Each year, participants may elect to defer up to 100 percent of pretax annual compensation up to the dollar limitation set forth in Internal Revenue Code Section 402(g). Participants may also elect to contribute Roth deferrals on an after-tax basis. Participants who have attained age 50 before the end of the plan year are eligible to make an additional elective deferral. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover contributions). For certain eligible participants, the Corporation contributes 50 percent of up to the first 2 percent of eligible compensation that a participant contributes to the Plan. In addition, the Corporation allows for a fixed contribution to the Plan for each plan year in the amount equal to 3 percent of each eligible participant's annual compensation. Participants direct the investment of their contributions into various investment options offered by the Plan.

Certain employee deferrals during plan year 2025 were paid after the time frame required by the Department of Labor. The Corporation remitted these contributions and related lost earnings to the Plan during plan year 2025.

#### **Participant Accounts**

Each participant's account is credited with (a) the participant's contribution; (b) the Corporation's contribution, if applicable; and (c) plan earnings attributable to the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Corporation's contribution portion of their accounts, if applicable, is only achieved after three whole years of service. Regardless of the above vesting schedule, participants who become disabled or reach normal retirement age will become fully vested on that date. Normal retirement age under the Plan is 65.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the sum of participants' vested account balances or \$50,000. The loans are secured by the vested balance in the participant's account and bear interest at 1 percent above prime. Principal and interest are paid ratably over the life of the loan.

**Note 1 - Plan Description (Continued)**

***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, active participants may also begin taking penalty-free distributions from the Plan upon reaching the age of 59½.

Participants may also request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Forfeited Amounts***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future corporation contributions or to pay administrative expenses of the Plan. As of June 30, 2025, there is no balance in the forfeited account. As of June 30, 2024, the forfeited account balance totaled \$8,500.

***Party-in-interest Transactions***

Certain administrative expenses of the Plan are paid by the Corporation; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Corporation has the right under the Plan to amend or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

**Note 2 - Summary of Significant Accounting Policies**

***Investments***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Mutual funds, money market fund, and self-directed brokerage accounts are valued at quoted prices reported in active markets. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### ***Plan Expenses***

Various administrative costs and expenses of maintaining the Plan are paid by the Corporation. Expenses of maintaining the Plan are paid by the Corporation with the exception of investment fees (deducted directly from investment returns); record-keeping fees (charged against the participant's account based on assets); and transaction-based fees, such as those related to plan loans (charged against the participant's account).

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported unrealized gains and losses during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

Subsequent events were evaluated through January 26, 2026, which is the date the financial statements were available to be issued.

### Note 3 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### ***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### Note 4 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated March 31, 2017. The Plan has not individually sought its own determination letter.

### Note 5 - Certified Information

Ascensus Trust Company holds the Plan's investments and participant notes receivable and executes all investment transactions, other than the self-directed brokerage account. The investment balances and participant notes receivable balances and related investment results included in the accompanying financial statements and supplemental schedule of assets held at end of year, other than the self-directed brokerage account, are based solely on information certified by Ascensus, LLC, on behalf of Ascensus Trust Company.

The self-directed brokerage account investments totaling \$73,550 and \$63,112 at June 30, 2025 and 2024, respectively, and related investment gains (losses) of \$10,438 and \$12,237 for the years ended June 30, 2025 and 2024, respectively, were not certified.
