

Notes to Financial Statements

1. **Description of the Plan** The following description of the Galeana Chrysler Jeep, Inc. FL 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Galeana Chrysler Jeep, Inc. (the "Company") who are at least 21 years old and who have completed one year of service of at least 1,000 hours, except for nonresident aliens, reclassified and leased employees. Employees may enter the Plan on the first day of the quarter subsequent to satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The account balances of certain participants employed by the Company, who were previously employed by an affiliated company, were transferred into the Plan from the affiliated company plan during the year ended December 31, 2021, and are reported as transfer in from affiliated company plan in the statement of changes in net assets.

Contributions: Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined by the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company contributes 100 percent of the first two percent of compensation that a participant contributes to the Plan. Employer discretionary amounts may also be contributed by the Company. Participants must be employed on the last day of the Plan year to receive an allocation of any discretionary contributions. No such contributions were made in 2021. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's matching contributions, the Company's discretionary contributions, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary contributions, if any, are based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Payment of benefits: Benefits are payable upon retirement at age 65, early retirement at age 55 with 6 years of service, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum payments, installments, ad-hoc payments, or if qualified, as an annuity.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company matching and discretionary contributions is based on years of continuous service of at least 1,000 hours. A participant is 20 percent vested after two years of service is completed, and vests an additional 20 percent per year until full vesting after six years.

Forfeited accounts: At December 31, 2021 and 2020, forfeited nonvested accounts totaled \$- and \$40,566, respectively. These accounts can be used to reduce future Company contributions and to pay Plan expenses. During 2021, \$63,320 of forfeited nonvested accounts were used to reduce Company matching contributions and no amount was used to pay administrative expenses.

Administrative expenses: The Company pays a significant portion of the administrative expenses of the Plan.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes to Financial Statements

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through February 4, 2026, which is the date the financial statements were available to be issued.

- 3. Certified information** Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2021 and 2020, and net appreciation in fair value of investments and interest income for the year ended December 31, 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Sentry Life Insurance Company, the insurance company of the Plan.
- 4. Fair value measurements** Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

The fair value of the units of pooled separate accounts is based on the net asset value ("NAV") on the last business day of the Plan year provided by the insurance company of the Plan. The NAV is used as a practical expedient to estimate fair value and is determined by Sentry Life Insurance Company based on the fair value of the underlying assets in the accounts, less the liabilities.

All pooled separate account investments of the Plan are measured using net asset value as a practical expedient to estimate fair value and therefore, are not subject to the fair value hierarchy. Investments in all pooled separate accounts can be redeemed immediately at the current net asset value. There are no withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2021 and 2020.

5. Guaranteed investment contract

The Plan participates in a traditional benefit responsive investment contract with Sentry Life Insurance Company ("Sentry") via an investment in a Guaranteed Investment Contract ("GIC"). Sentry commingles the assets of the GIC with other assets in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Sentry is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by Sentry, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. A market value adjustment may be assessed if the contract is cancelled or more than 20% of assets in the contract are transferred out in any 12 month period. Sentry reserves the right to cancel the contract upon the occurrence of certain events, including the Plan's failure to pay any expense charges or provide Sentry with information, the Plan's loss of qualified plan status, failure to make at least \$75,000 in contributions in three consecutive years or complete or partial termination of the Plan.

6. Risks and uncertainties

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

- 7. Tax status** The Plan is a prototype plan of Sentry Life Insurance Company, which received an opinion letter on March 31, 2014, in which the Internal Revenue Service (“IRS”) stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
- Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
- 8. Plan termination** The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. See Note 11.
- 9. Party-in-interest transactions** Certain Plan investments are managed by Sentry Life Insurance Company (“Sentry”). Sentry is the insurance company and recordkeeper as defined by the Plan. During 2021, the Plan paid Sentry for recordkeeping services. These transactions qualify as exempt party-in-interest transactions.
- During 2021, the Company failed to remit to the insurance company certain employee contributions totaling \$15,250 within the period prescribed by Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions.

- 11. Subsequent events** The Plan was amended and restated effective January 1, 2022 to adopt a defined contribution pre-approved plan of Sentry and incorporate recent legislation. No significant plan provisions were modified as a result of the amendment and restatement.

The Plan was further amended effective January 1, 2023 to change the age requirement for participation to age 19 and to change the service requirement to 1,000 hours within the six month period following the date of hire.

Effective December 12, 2025, the Company elected to terminate the Plan. Participants became fully vested in their accounts. Distributions will be made to Plan participants in accordance with the plan provisions.
