## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Jasco Products Company, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Jasco Products Company, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering employees of Jasco Products Company, LLC (the Company) who are at least 18 years of age, with 60 consecutive days of service as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. Administration

The Plan Administrator has the overall responsibility for the Plan. This includes the power to interpret the provisions of the Plan and to determine questions concerning eligibility, participation, and benefits and such other powers and duties as are necessary to the operation and administration of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

C. Contributions

Participants are allowed to contribute to the Plan up to 80% of eligible compensation, as defined, subject to certain other limitations imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Company makes a safe harbor matching contribution to the Plan for those participants who satisfy the eligibility requirements applicable to such safe harbor matching contribution equal to 100% of the amount of eligible compensation the participant contributes to the Plan for each payroll period up to 6% of eligible compensation. New employees are automatically enrolled in the Plan with their deferral rates set at 6%, unless the employee elects otherwise. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Additional discretionary profit sharing contributions may be made at the option of the Company's Board of Directors and shall be allocated based on participant classifications. Within the classification, the contribution will be allocated on a pro rata basis as a uniform percentage of compensation of the participants in the classification. There have been no discretionary profit sharing contributions made to the Plan.

D. Participant accounts

Each participant's account is credited with the participant's contributions and Company safe harbor matching contributions as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of plan earnings and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Cont'd)

A. Investment options

Upon enrollment in the Plan, a participant directs contributions among the investment options provided by the Plan. Participants may change their investment options anytime throughout the year via the internet or direct phone access to the Plan's third-party administrator.

B. Notes receivable from participants

Participants may borrow from their fund accounts, a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at a time. Loan terms may not exceed five years, except for loans used to acquire a primary residence (up to 30 years). Loans are secured by the balance in the participant's account and bear interest at fixed rates approximating rates charged for similar types of loans by other lenders. Loan repayments, including interest, must be made through payroll deduction. When a participant becomes eligible for a distribution, the remaining balance of the loan is due immediately. The loans outstanding at December 31, 2024, bear interest rates of 7.50% to 10.50% and mature through September 2034. Principal and interest are paid ratably through payroll deductions.

C. Payment of benefits

On termination of service, if the participant's account balance is less than \$5,000, the Plan will distribute that portion in a lump sum, subject to the automatic rollover provisions, as defined, as soon as administratively practicable. If the participant's vested account balance is greater than \$5,000, the participant may elect to receive distribution either in a lump sum or in installments over a specified period of time. The Plan also allows in-service distributions when certain requirements defined in the Plan document are met by participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of accounting

The accompanying financial statements of the Plan have been prepared using the accrual method of accounting.

B. Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment valuation and income recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for discussion of the fully benefit-responsive investment contract held by the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

D. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments, and the Plan's management deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded based upon the terms of the Plan document.

Notes receivable from participants have been classified as an investment asset for Form 5500, *Annual Return/Report of Employee Benefit Plan*, reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, Line 4i—schedule of assets (held at end of year).

E. Payment of benefits

Benefits are recorded when paid.

F. Administrative expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to certain administrative functions are charged directly to the affected participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

G. Subsequent events

The Plan's management have evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of the provisions within SECURE 2.0 vary through 2026. Management has elected to adopt SECURE 2.0 with an effective date of January 1, 2025

3. INFORMATION CERTIFIED OR PROVIDED BY THE CUSTODIAN

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Nationwide Trust Company, FSB, the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears through the financial statements and ERISA-required supplemental schedule related to the following assets:

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies

Registered investment companies are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

At December 31, 2024 and 2023, the Plan holds a traditional investment contract, the Nationwide Fixed Selection Option, with Nationwide Financial Services, Inc. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the contract issuer, represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specific interest rate that is guaranteed to the Plan. The annual crediting rate is based on a formula established by the contract issuer and may not be less than 0%. The annual crediting rate for the years ended December 31, 2024 and 2023, was 2.56% and 2.42%, respectively. The crediting rate is reviewed quarterly for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following: (1) the Plan's failure to qualify under section 401(a) of the IRC or the failure of the trust to be tax exempt under section 501(a) of the IRC, (2) premature termination of the contract, (3) Plan termination or merger, (4) changes to the Plan's prohibition on changing investment options, or (5) bankruptcy of the Company or other company events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidance, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

6. PLAN TERMINATION

Although it has not expressed an intent to do so, the Employer has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. RISKS AND UNCERTAINTIES

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the 2024 statement of net assets available for plan benefits.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Nationwide Trust Company, FSB, a division of Nationwide Bank (Nationwide), who is also the trustee of the Plan's assets, and therefore, the transactions related to investments managed by Nationwide qualify as party-in-interest transactions as defined by ERISA.

9. INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved plan sponsored by Pension Solutions, Inc. Pension Solutions, Inc. has received an opinion letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
