The Plan is a defined contribution plan that was established August 1, 2004 by The Heritage Foundation (the “Foundation”) to provide benefits to eligible employees. The Plan covers all employees of the Foundation. Employees are eligible to participate in the Plan immediately upon employment without age restrictions. Effective January 1, 2024, the Plan adopted a restated Plan document and adoption agreement. During 2024, the Plan was amended to allow employees of The Daily Signal Institute to participate in the Plan. The Plan is subject to the provisions of ERISA.

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Administration - Under the terms of the Plan, a group of designated officers of the Foundation act as trustees. A third-party administrator processes and maintains the records of participant data. The Foundation has contracted with Charles Schwab Trust Bank (Charles Schwab) to act as custodian. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Foundation. Expenses that are paid by the Foundation are excluded from these financial statements. Fees related to administrative services, investment management services, as well as fees related to the administration of distributions, which are charged directly to the participants' accounts, are included in administrative expenses.

Investment valuation and income recognition - Investments of the Plan are held by Charles Schwab and are invested solely based upon instructions received from participants. Plan assets are stated at fair value as of the last day of the Plan year, as reported by Charles Schwab. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Note 1: The Plan and its significant accounting policies: (continued)

Income taxes - The Plan is a volume submitter plan sponsored by MAP Retirement (formerly Gorrellick, Tievy & Associates, Inc.). The Plan obtained its most recent determination letter on March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since then; however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Plan assets may have decreased in value since December 31, 2024 due to normal market fluctuations.

Note 1: The Plan and its significant accounting policies: (continued)

Adoption of new accounting policy - On January 1, 2024, the Plan adopted ASU 2016-13 *Financial Instruments – Credit Losses (topic 326): Measurement of Credit Losses on Financial Instruments*, as amended, which replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The measurement of expected credit losses under CECL methodology is applicable to financial assets measured at amortized costs, including contribution receivables and held-to-maturity debt securities. The Plan adopted ASC 326 using the modified method for all financial assets measured at amortized costs. The Plan has analyzed its financial assets and deemed that no adjustment is necessary. Therefore, net assets available for benefits and changes in net assets available for benefits are unchanged due to the adoption of this new standard. The Plan will continue to analyze its financial assets for expected credit loss under this new standard.

Note 2: Participation and benefits:

Participant contributions - Participants may elect to have the Foundation contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Participants who elect to have the Foundation contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants may also elect to make Roth elective deferrals. Roth elective deferrals are made after taxes have been withheld. Participants may contribute a combination of pre-tax elective deferrals and Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions withheld are invested in accordance with the participant's direction. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions - Employer contributions are not permitted by the Plan.

Participant accounts - Each participant's account is credited with the participant's contributions, Plan earnings or losses, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in the salary deferral and rollover contributions and related earnings.

Note 2: Participation and benefits: (continued)

Payment of benefits - Upon termination of service due to death, disability, retirement, or other reasons, the participant or beneficiary can elect to immediately receive the benefits in a lump sum amount equal to the value of the participant's vested interest in his or her account or defer the benefits until reaching normal retirement age. The Plan allows for an automatic lump sum distribution to an individual retirement account established by the trustee in the name of the participant for participant vested account balances which do not exceed \$5,000.

Note 3: Certified information:

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab, the custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. In addition, the information in the Form 5500 Supplemental Attachment to Schedule H has been certified by Charles Schwab as of December 31, 2024.

Note 4: Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4: Fair value measurements: (continued)

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5: Related party transactions and party in interest transactions:

Certain Plan investments are shares of mutual funds managed by Charles Schwab. Charles Schwab is the custodian and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in administrative expenses.

Note 6: Plan termination and/or modification:

The Foundation intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate and/or modify the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7: Prohibited transactions:

During 2024, the Plan sponsor did not remit certain participant contributions to the Plan in a timely manner, as defined by ERISA. These contributions were considered nonexempt party in-interest transactions which may have resulted in an imposition of a 15 percent excise tax to the Plan sponsor on the amount of the transactions.

The Plan sponsor compensated participants for lost earnings resulting from the delay in contributions. These nonexempt transactions did not affect the tax status determination of the Plan.
