**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of P97 Networks 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. Description of the Plan**

The following description of the P97 Networks 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan, that provides benefits to eligible employees, covering substantially all employees of P97 Networks, L.L.C. (the "Company" or "Plan Sponsor") who have attained the age of 21 years and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Committee has the responsibility of supervising and directing the administrative activities of the Plan and is the plan fiduciary.

Effective January 15, 2024, the Plan switched custodians and recordkeepers from Voya Retirement Insurance and Annuity Company ("Voya") to Principal Trust Company ("Principal"). As part of this transition, the Plan's assets were liquidated and transferred to Principal in January 2024. This change was made to enhance the administrative and custodial services provided to the Plan and its participants. The transfer of assets and records was completed without interruption to participant access and benefits.

**Administration**

Until January 15, 2024 the Company was responsible for the administration and operation of the Plan. The Chief Executive Officer and VP of Finance of the Company served as the trustees of the Plan and Voya served as the custodian and recordkeeper.

As of January 15, 2024 the Company changed to Principal but maintained responsibility for the administration and operation of the Plan, while Principal serves as the trustee, custodian, and recordkeeper.

**1. Description of the Plan, Continued**

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company makes Safe Harbor basic matching contributions equal to 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation plus 50% of compensation from 3% to 5% for each payroll period. Additional profit sharing amounts may be contributed at the option of the Company's plan committee. During the year ended December 31, 2024, the Company did not make any profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their elective contributions, rollover contributions, safe-harbor Company matching contributions, and earnings thereon.

Vesting in Company discretionary matching contributions and non-elective profit-sharing contributions is based on a participant's years of continuous service as follows:

**Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest is paid ratably through semi-monthly payroll deductions. During the year ended December 31, 2024, the notes bore interest at rates which ranged from 5.25% to 10.50%.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**In-Service Withdrawals**

A participant may take an in-service withdrawal of all or any portion of the balance of their pre-tax elective deferrals, roth elective deferrals and/or rollover accounts as described in the Plan document. Once age 59 1/2 is attained, a participant may withdraw some or all of the vested amounts in his or her accounts. Certain participants, as specified in the Plan document, may make a hardship withdrawal from their pre-tax elective deferrals, roth elective deferrals, rollovers and earnings thereon. A hardship withdrawal shall only be made in the event of a financial need constituting a hardship, as defined in the Plan document.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The investments in pooled separate accounts and guaranteed investment account are valued at fair value and contract value, respectively. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See *Note 3* for discussion of fair value and *Note 4* for guaranteed investment account.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Benefits and Withdrawals**

Benefits are recorded when paid.

**Administrative and Investment Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. During the year ended December 31, 2024, the Plan Sponsor paid \$15,575 in administrative expenses. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included within "Net appreciation in fair value of investments" on the accompanying Statement of Changes in Net Assets Available for Benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through December 18, 2025, which is the date the financial statements were available to be issued, and has determined that the following significant event has occurred:

During 2025 the plan was terminated with an effective date of March 31, 2025, payouts beginning June 24, 2025, and a force out date of September 4, 2025. See *Note 7*.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  - If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining the fair value of assets and liabilities, the Plan generally uses the market approach, which uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

*Pooled separate accounts:* Valued at the net asset value (“NAV”) of units based on the quoted market price of the underlying securities and the number of units owned by the Plan at year end. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with ASU No. 2015-07, *Fair Value Measurements (Topic 820): Disclosures for Investments in Certain Entities that Calculate Net Asset Value per Share (or Its Equivalent)*, investments measured at NAV per share (or its equivalent) as a practical expedient, are not classified in the fair value hierarchy. At both December 31, 2024 and 2023, all investments are either reported at contract value or are in pooled separate accounts and are measured at fair value, using NAV as a practical expedient. Accordingly, no fair value hierarchy is presented.

For the investments in pooled separate accounts, as of December 31, 2024 and 2023, there were not any unfunded commitments or redemption notice period and the redemption frequency was daily. Pooled separate accounts invest primarily in long-term bonds, domestic and international stocks, or single mutual funds. These funds seek both capital and appreciation and include a combination of assets, such as aggressive stocks, international stocks, large-company stocks, government bonds, foreign bonds or money markets. The allocation percentage to each asset type may be fixed, bounded by a range, or determined at the discretion of the manager. Managers of these funds review market conditions regularly and refine the asset allocation mixture they believe will achieve the best risk adjusted performance based on the stated objectives and target allocations of the particular fund. The underlying investments held by each pooled separate account are traded on an active market.

**4. Guaranteed Investment Account**

Ending on January 15, 2024 (with the change from Voya to Principal) the Plan had entered into a traditional fully benefit-responsive guaranteed investment contract with Voya. Voya maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment account issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer and could not be less than 1 percent. The interest yield as of January 15, 2024 was 1%.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this represents the amount to be received by participants if they are to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value approximates fair value.

Effective January 15, 2024 the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a semiannual basis for resetting. The net crediting rate as of December 31, 2024 was 4.85%.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this represents the amount to be received by participants if they are to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants can ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value approximates fair value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments. Certain events could limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. Other than the plan termination, no events occurred that limited the ability of the Plan to transact at contract value with the contract issuers or the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**5. Information Certified by the Plan's Custodian (Unaudited)**

The Plan Administrator has elected the method of annual reporting and compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya and Principal, respectively.

In addition, the information contained in the Schedule of Assets (Held at End of Year), December 31, 2024, has also been certified as complete and accurate by Principal.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**6. Party-in-Interest Transactions**

Certain Plan investments are in accounts managed by Principal (Voya until January 15, 2024) and the Plan issues notes receivable from participants. As described in *Note 2*, the Plan paid expenses related to the plan operations and investment activity to various service providers. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

**7. Plan Termination**

As described in *Note 2*, the Plan was terminated in 2025 in accordance with the applicable provisions of ERISA. Upon termination, all participant accounts were fully vested and distributed in accordance with plan provisions and regulatory requirements.

**8. Tax Status**

The Plan adopted by the Company is a volume submitter (“VS”) plan (Voya prior to January 15, 2024, and Principal subsequent) that is designed to comply with provisions of the Internal Revenue Code’s Economic Growth and Tax Reconciliation Act of 2001 (“EGTRRA”). The VS plan received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the VS plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (the "Code"). Because the Plan is a VS plan, the Company is not authorized to amend the Plan except to comply with changes in the Cumulative List of Changes in Plan Qualification Requirements provided under EGTRRA. Therefore, the Plan administrator believes that the Plan continues to be designed and operated in all material respects in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

**11. Delinquent Participant Contributions**

For the year ended December 31, 2024, the Company determined that certain employee deferrals aggregating \$102,171 had not been remitted to the Plan in a timely manner, according to DOL regulations. Although these remittances were made, they fell outside the normal processing time the Company allows. An investigation was held to determine the root cause of the delinquent contributions, and corrective measures are being conducted. The Plan Administrator is in the process of calculating the lost earnings, if any, from these delinquent contributions and will process and deposit any lost earnings to participant accounts as soon as is practical.
