INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Plan Participants of the
Jones/Covey Group, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jones/Covey Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jones/Covey Group, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

NOTE 1. DESCRIPTION OF PLAN

The following description of the Jones/Covey Group, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan was effective November 1, 2023. Jones/Covey Group, Inc. (the Company) is the plan sponsor. The plan sponsor established the Plan to provide retirement income for its employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Employees are eligible to enter the Plan after completing at least 1 month of service and an additional month before receiving matching contributions.

On October 1, 2023, the Plan moved from Newport Trust Company to John Hancock. On November 1, 2023, the accounts were transferred out of the Plan Assets to the previously mentioned Plan. Plan Trustees chose to terminate the original Plan as of May 1, 2024.

Contributions to the Plan - The Plan is a contributory plan whereby participants may contribute pre-tax annual compensation, up to 100% of their salary, not to exceed \$23,000 and \$22,500 for the year ended December 31, 2024 and December 31, 2023, respectively. All employees who are eligible to make elective deferrals under the Plan and who have attained the age of 55 before the close of the Plan year are eligible to make catch-up contributions up to \$7,500 and \$6,500 for the year ended December 31, 2024 and December 31, 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The plan sponsor also makes safe harbor matching contributions to the Plan. The matching contribution is an amount equal to 100% of the amount of participant contributions to the plan for each payroll period up to 4% of the Plan compensation. Employer safe harbor matching contributions for the year ended December 31, 2024 were \$601,873.

Hardship Withdrawals - Active participants may withdraw any part of their account in a single sum in the event of undue financial hardship or attainment of age 59 ½.

Participant Accounts - Separate accounts are maintained for each participant. Each participant account is credited with the participant's contribution, allocations of the Company's contribution, plan earnings, and charged with an allocation of administrative expenses. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements for the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Accounting Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results differ from those estimates.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Payment of Benefits - Benefits are recorded when paid.

Non-Distributed Benefits - The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan, but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

Notes Receivable from Participants - Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and must be repaid at a fixed interest rate which is commensurate with local prevailing rates as determined by the Plan. Generally, loans must be repaid within five years, unless the loan was for the purchase of a principal residence. In this case, the repayment period may be extended. Principal and interest is paid ratably through payroll deductions. Delinquent or defaulted notes receivables from participants are written off as "deemed" distributions at the end of the quarter following the quarter in which the default occurs.

The Plan classifies participant loans as notes receivable from participants in the statements of net assets available for benefits and measures them at their unpaid principal balance plus any accrued interest.

Expenses - Certain expenses of maintaining the Plan are paid by the plan sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution fees are charged directly to the participant's account and are included in the administrative expenses. Investment-related expenses are included in net depreciation of the fair value of investments.

Subsequent Events - Subsequent events have been evaluated through January 8, 2025, the date the financial statements were available for issuance

NOTE 3. INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by John Hancock, the trustee of the Plan, as complete and accurate, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule:

NOTE 4. FAIR VALUE MEASUREMENTS

Fair value measurements are based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4. FAIR VALUE MEASUREMENTS (continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - These investments are valued at the closing quoted market price reported on the active market on which the public investment securities are traded.

Pooled Separate Accounts - Valued at the net asset value (NAV) of shares held by the fund at the period end. The account values of pooled separate accounts are not publicly quoted but use NAV as the practical expedient, therefore are not classified in the fair value hierarchy.

Money Market Fund - These investments are valued at the closing quoted market price reported on the active market on which the public investment securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 6. INCOME TAX STATUS

The Plan obtained its latest prototype plan opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's tax returns generally remain open for Federal tax audits for three years from the filing date.

NOTE 7. RELATED PARTY AND PARTY IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. For the year ended December 31, 2024, the Plan paid \$21,404 in fees for services provided by parties in interest service providers; of which \$10,953 was paid to the Plan's custodian and \$10,451 was paid to the Plan's third-party administrator.

The Plan allows participants to borrow from their accounts. These notes receivable are secured by the vested balances in the participants' accounts, therefore, these transactions qualify as parties in interest transactions; a statutory exception exemption exists.

Certain plan investments are pooled separate accounts consisting of shares of mutual funds managed by John Hancock, the Plan's custodian. These transactions qualify as party-in-interest transactions; a statutory exception exists.

NOTE 8. PROHIBITED TRANSACTIONS

In 2024, the Plan sponsor inadvertently failed to deposit \$2,087 in participant deferrals within the required ERISA timeframe. These deferrals were deposited later than the administratively possible periods set by contribution remittances of other pay periods. Under ERISA, late deposits are considered to be prohibited transactions. The Plan sponsor is required to file Form 5330 and pay the excise tax relating to the prohibited transactions from the Plan sponsor's assets and not from assets of the Plan, in addition to calculating the lost earnings on these deferrals and loan payments. The Plan sponsor deposited the lost earnings calculated on the late remittances related to the 2024 plan.
