## Notes to Financial Statements

#### **Note 1 - Description of Plan**

The following description of the Elliott Oil Company (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

*General* - The Plan was established August 1, 1981 and is a defined contribution plan covering substantially all employees of the Company who are 21 years of age and have one year of service (based on 1,000 hours of service during the year). Effective October 15, 2024, employees of Cobb Oil Company, Inc. can participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Elliot Oil Company is the Plan Sponsor.

*Contributions* - Participants may contribute up to 100% of their eligible compensation, not to exceed the maximum amount allowable under the Internal Revenue Code, to the Plan in the form of a salary deferral. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various interest-bearing cash accounts, pooled separate accounts and an insurance investment contract as investment options for participants. The Company matches 100% of participant contributions, up to the first 6% of base compensation. The matching Company contribution is invested into one of the available funds according to the participant’s direction. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors and are invested in one of the available funds according to the participant’s direction. Contributions are subject to certain limitations. Profit sharing contributions for the years ended July 31, 2025 and 2024 were \$357,888 and \$265,057, respectively.

*Participant Accounts* - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

*Participant Loans* - The Plan does not permit participant loans.

*Payment of Benefits* - On termination of service due to death, disability, or retirement, a participant may receive either the value of the vested interest in his or her account as a lump-sum distribution, or periodic payments over a period of time not to exceed the life expectancy of the participant, or the joint life and last survivor expectancy of the participant and his/her designated beneficiary. Vested interests less than \$5,000 will be paid as a lump-sum distribution. At July 31, 2025, \$618,218 in vested contributions was owed to participants who terminated employment with the Plan Sponsor before July 31, 2025. The Plan permits hardship withdrawals and will be based on the safe harbor method.

*Administrative Expenses* - Certain administrative expenses are paid directly by the Sponsor, while other expenses are paid by the Plan.

**Note 1 - Description of Plan (Continued)**

*Forfeited Accounts* - At July 31, 2025 and 2024, forfeited non-vested accounts totaled \$9,099 and \$7,338, respectively. These accounts are used to reduce the employer contribution that is received by the Plan subsequent to its year end. Amounts allocated to participant accounts during the years ending July 31, 2025 and 2024 were \$42,841 and \$18,223.

**Note 2 - Summary of Accounting Policies**

*Basis of Accounting* - The financial statements of the Plan are prepared in accordance with the accrual basis of accounting.

*Investment Valuation and Income Recognition* - The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* - Benefits are recorded when paid.

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and revenues and expenses during the reporting period. Actual results could differ from those estimates.

*Date of Management Review* - Management has evaluated subsequent events through February 19, 2026, the date which the financial statements were available to be issued.

**Note 3 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

**Note 4 - Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan's administrator and the Plan's tax counsel believe that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax exempt. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Fair Value Measurement**

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Basis of Fair Value Measurement**

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

*Registered investment companies* - Valued at quoted market prices which represent the fair value of shares held by the Plan at year end.

*Pooled separate accounts* - Pooled separate accounts are valued at fair value by the insurance company. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only.

*Common collective trusts* - The collective investment trust (CIT) invests in collective trust funds as well as a variety of separate accounts and mutual funds. The fair value of the collective investment trusts and the separate accounts are not publicly quoted pricing inputs. The fair value of mutual funds held by the CIT are publicly quoted pricing inputs. The fair value of all of these investments is used in determining the value of the CIT, which is not publicly quoted but is available to current investors.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value, as of July 31, 2025 and 2024. Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

**Note 7 - Contract with Insurance Company**

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at July 31, 2025 and 2024 was \$39,755 and \$9,363, respectively. A composite crediting rate contractually guaranteed by Principal is credited to account balances. The net crediting rate is after the deduction for fees for administrative and recordkeeping services provided to the Plan. Currently, this net crediting rate is a 4.75% effective annual rate, until May 31, 2026. The rate will be reset June 1, 2026, and semiannually thereafter.

Certain events might limit the ability of the Plan to transact at contract value with Principal. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without Principal's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 8 - Related Party Transactions**

Elliott Oil Company 401(k) Profit Sharing Plan investments are managed by Principal Life Insurance Company for the years ended July 31, 2025 and 2024, respectively. Principal Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Contract administration fees of the Plan totaled \$42,550 for the year ended July 31, 2025. Elliott Oil Company provides the Plan with certain accounting and administrative services for which no fees are charged.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

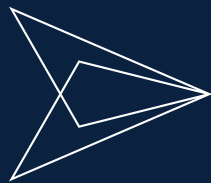
