#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Retirement Plan for Action Pathways, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Retirement Plan for Action Pathways, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

1. DESCRIPTION OF PLAN

The following description of The Retirement Plan for Action Pathways, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- a. General – The Plan is a defined contribution plan established by Action Pathways, Inc. (the "Plan Sponsor" or "Company") in July 1968, which was amended and restated effective March 31, 2020. The Plan covers all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b. Contributions – Each year, participants may contribute between 1% and 100% of annual compensation, as defined by the Plan. Annual contributions to the Plan may not exceed the amount permitted under Section 415 of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

All employees are eligible for employer contributions with the completion of three months of service with the Company. Three months of service is defined as working over 480 hours during the eligibility measuring period. After completing three months of service, the Plan Sponsor contributes a safe harbor matching contribution equal to 100% of elective deferrals up to 5% of employee compensation as defined in the Plan.

There is no service requirement for an employee to defer a portion of their compensation as a pre-tax deferral. The service requirement listed above, however, will apply to pre-tax deferrals only if the participant can defer pre-tax deferrals into another plan maintained by the Plan Sponsor that does not have age or service requirements. Participants direct the investments of their contributions into various investment options offered by the Plan.

- c. Participant Accounts – Each participant's account is credited with the participant's contributions, employer contributions, and allocations of Plan earnings and administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which participants are entitled is the vested portion of their accounts.
- d. Vesting – Participants are 100% vested at all times in both their elective contributions and all employer contributions.
- e. Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates at 5.25% as of December 31, 2024 and 2023. Loans must generally be repaid within five years. Principal and interest are paid ratably through payroll deductions.
- f. Payment of benefits – Upon termination of employment, retirement, death, disability, or early retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or receive partial payment, installment payments, or an annuity. For termination of service for other reasons, distribution value of the participant's vested interest in his or her account will begin as soon as possible after the participant's request.

- g. Forfeited Accounts – Forfeitures of terminated participants' nonvested accounts are used to reduce future employer contributions or pay Plan expenses. As of December 31, 2024 and 2023, the Plan had \$0 and \$6,900, respectively, in nonvested forfeited accounts. During the years ended December 31, 2024 and 2023, \$7,462 and \$14,400 were used to reduce Plan Sponsor contributions and pay administrative expenses, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the term of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document and loan agreement.

Payment of Benefits

Benefits are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. ADMINISTRATIVE INFORMATION

The Plan is administered by the Company, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The Company outsources the recordkeeping function of the Plan to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust Company"), the "Trustee" or "qualified institution" of the Plan.

4. FAIR VALUE MEASUREMENTS

The Plan follows FASB ASC 820, *Fair Value Measurements*, which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

FASB ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The categorization of each investment type within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

FASB ASC 820 establishes three levels of inputs that may be used to measure fair value: Level 1: Quoted prices in active markets for identical assets or liabilities at the measurement date; Level 2: Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active market for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or Level 3: Unobservable inputs that are supported by little or no market activity and that reflect the Plan's own assumptions about market participants and prices.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. There have been no changes in the fair value methodology used at December 31, 2024 and 2023.

6. INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan invests in a fully benefit-responsive investment contract with Principal Trust Company. Principal Trust Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by Principal Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than the guaranteed minimum interest rate. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Principal Trust Company. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the Principal Trust Company to terminate the agreement prior to the scheduled maturity date.

7. PLAN TERMINATION

Although the Plan Sponsor intends to continue the Plan, it reserves the right to amend or terminate the Plan at any time.

8. INCOME TAX STATUS

The Internal Revenue Services ("IRS") has determined and informed the Plan prototype sponsor by a letter dated March 31, 2017, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Company has chosen to rely on the determination letter issued to the Plan prototype sponsor. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

9. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are shares of mutual funds and guaranteed investment contract managed by Principal Trust Company. Fees paid by the Plan for the investment management services of Principal Trust Company amounted to \$4,466 for the year ended December 31, 2024. Notes receivable from participants qualify as party-in-interest transactions.

10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. NONEXEMPT TRANSACTIONS

Participant contributions of \$21,425 were withheld from participants' pay throughout the plan year ending December 31, 2024, and were not remitted to the Plan timely. Each remittance constituted a loan from the Plan to the Plan Sponsor. The late contributions were remitted from three to four business days after the date the contributions could have reasonably been remitted. Lost earnings on these participant contributions were determined to be immaterial, and the Plan Sponsor remitted these lost earnings in 2026 (see attached Schedule H, line 4a – Schedule of Delinquent Participant Contributions).

12. SUBSEQUENT EVENTS

The Plan has evaluated events and transactions that occurred between December 31, 2024 and February 23, 2026, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.
