### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform an audit of the financial statements of Aspire Indiana Employer Sponsored 403(b) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Aspire Indiana Employer Sponsored 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of Aspire Indiana Employer Sponsored 403(b) Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

As described in Note 1 to the financial statements, Aspire Indiana Employer Sponsored 403(b) Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

### ***Responsibilities of Management***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Aspire Indiana Employer Sponsored 403(b) Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Note 1. Description of the Plan**

The following description of Aspire Indiana Employer Sponsored 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

**General**

The Plan is a defined-contribution plan, sponsored by Aspire Indiana, Inc. (Organization). Aspire Indiana Health, Inc. and Progress House, Inc. are participating employers of the Plan. Effective February 1, 2025, Aspire Indiana PEO, LLC became a participating employer of the Plan. Employees are immediately eligible upon hire to voluntarily defer to the Plan if they work greater than 20 hours per week. Employees need one year of service to be eligible for Organization contributions and, prior to December 1, 2024, entry was immediate after one year of service. Effective December 1, 2024, entry is quarterly after one year of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). American United Life Insurance Company (AUL) served as the Plan custodian through December 1, 2024.

Effective December 1, 2024, the Plan changed to be covered under the volume submitter prototype document sponsored by Principal Life Insurance Company. Principal Trust Company (Principal) became the custodian of the Plan. Plan assets transferred to Principal on December 13, 2024 and were transferred into funds comparable to those offered by AUL. The conversion initiated a "Black Out" period beginning December 6, 2024 and continued through December 30, 2024. During this period, funds could not be applied to the employee-selected funds with Principal or withdrawn from the Plan until Principal had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions and the contributions were deposited and held in a money market fund until the completion of the Black Out period. At the end of the Black Out period, these funds were transferred to Principal and invested in funds as requested by each participant. Approximately \$662,000 remained with AUL in the AUL Fixed Account which has withdrawal restrictions in place.

As permitted by the Department of Labor Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*, the Organization has not maintained sufficient accounting records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to July 1, 2009. The Plan has excluded these assets from net assets available for benefits as of June 30, 2025 and 2024. Investment income, distribution and expense activity pertaining to these contracts was also excluded from the statements of changes in net assets available for benefits for the years ended June 30, 2025 and 2024. The amount of these excluded assets and the related income and distributions is not determinable.

**Contributions**

The Plan permits eligible employees through a salary deferral election to have the Organization make annual contributions of up to the maximum allowable under the Internal Revenue Code. Roth, catch-up and rollover contributions are also permitted. The Plan also allows for special code section 403(b) catch-up contributions for those participants with 15 years of service and who qualify based on historical Plan contributions. The Organization's matching and profit-sharing contributions are discretionary as determined by the Organization's Board of Directors annually. Contributions are subject to certain limitations. The Organization's Board of Directors elected to make matching contributions of 100% of participants' salary deferral amounts on the first 6% of participants' eligible compensation for the years ended June 30, 2025 and 2024.

Prior to July 1, 2024, the Organization could make an additional discretionary nonelective contribution for participants with student loans or participants with ongoing education expenses according to a policy established by the Organization calculated on a quarterly basis. Effective July 1, 2024, the Organization may make an additional discretionary nonelective contribution for any reason according to a policy established by the Organization calculated on a quarterly basis.

The Plan Document includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant makes an affirmative election otherwise.

***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Organization's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Discretionary Organization contributions are vested at the rate of 20% after the first year of service and 20% each year thereafter for a total of 100% after five years of credited service. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce Organization contributions.

***Forfeited Accounts***

At June 30, 2025 and 2024, the forfeited nonvested account totals \$8,531 and \$0, respectively. This account will be used to reduce future Organization contributions or pay Plan administrative expenses. Forfeitures of \$1,329 and \$0 were used to pay administrative fees in 2025 and 2024, respectively. Forfeitures of \$61,383 and \$66,894 were used to offset Organization contributions during 2025 and 2024, respectively. Employer contributions receivable, as of June 30, 2025, is net of \$7,803 of forfeitures used to offset the employer contribution deposited on July 1, 2025.

***Payment of Benefits***

Upon termination of service, an employee may elect to receive a lump-sum amount equal to the value of his account. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

***Notes Receivable to Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000 and there can be no more than one loan outstanding at a time. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans cannot be taken from a participant's account balance that contains Roth contributions. Effective December 1, 2024, loans are available from all vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on reasonable rates as determined by the Plan Administrator and is prime rate + 2%.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Plan Termination***

Although it has not expressed an intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Prior to December 1, 2024, the pooled separate accounts under the group annuity contract were valued at fair value as determined by AUL utilizing quoted market prices of the underlying mutual funds on the last business day of the Plan year. The unit prices of the pooled separate accounts were published daily by AUL.

Effective December 1, 2024, mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The fair value of the guaranteed investment contracts are calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Tax Status***

Effective December 1, 2024, the Plan operates under a volume submitter prototype 403(b) plan document sponsored by Principal Life Insurance Company. Prior to December 1, 2024, the Plan operated under a volume submitter adoption agreement in connection with a prototype retirement plan 403(b) document sponsored by One America Financial Partners, Inc. The Plan has not obtained or requested an individual determination letter. The Plan has been amended since the prototypes received favorable opinion letters. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

**Note 3. Certification of Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL and Principal, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of June 30, 2025 and 2024
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended June 30, 2025 and 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year end) as of June 30, 2025

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended June 30, 2025. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Effective December 1, 2024, Level 1 includes mutual funds. Prior to December 1, 2024, there were no Level 1 securities held by the Plan. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. Effective December 1, 2024, there were no Level 2 securities held by the Plan. Prior to December 1, 2024, Level 2 securities include pooled separate accounts. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3. There are no Level 3 securities held by the Plan.

**Note 5. Investment Contracts With Insurance Company**

The Plan entered into a fully benefit-responsive investment contract with AUL. AUL Fixed Account maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

As described in the basis of accounting disclosure, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed-upon with the issuer, but it may not be less than 4.0%. Such interest rates are reviewed on a quarterly basis for resetting.

Effective February 1, 2022, the AUL Fixed Account was frozen for all new contributions. This account remained in the Plan as of June 30, 2025.

Effective February 1, 2022, the Plan entered into a fully benefit-responsive investment contract with AUL. Effective December 1, 2024, the Plan terminated the AUL contract and entered into a fully benefit-responsive investment contract with Principal Life Insurance Company.

The AUL Stable Value Account was a fixed-dollar annuity and investment product offered by AUL, an insurance company. The AUL Stable Value Account was maintained in the AUL general account. Contributions to the AUL Stable Value Account purchase a contractual or guaranteed amount of future benefits for the participants and were secured by the general assets of AUL. The AUL Stable Value Account was recorded at contract value by AUL. Contract value, as reported to the Plan by AUL represented contributions made under the contract, plus interest at the contract rate, less funds to pay withdrawal benefits and administrative expenses. Participants ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value. Minimum guaranteed rate was 0%. The rate was the Stable Value Market rate that was set by AUL. The rate was 1.25% for the Plan year ended June 30, 2024.

For the Principal Fixed Guaranteed Option, Principal maintains the contributions in their general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The guaranteed investment contract is fully benefit-responsive (FBRIC). Contract value, as reported by Principal Life Insurance Company, is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The rate is the market rate set by Principal Life Insurance Company. The rate was 4.70% for the plan year ended June 30,

The guaranteed investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by American United Life Insurance Company and Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against the contract value for credit risk of the contract issuer or otherwise.

The guaranteed investment contracts permit the insurance company to terminate the agreement prior to the scheduled maturity date.

For the AUL Fixed Account, AUL Stable Value Account and the Principal Fixed Guaranteed Option, certain events limit and limited the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### **Note 6. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$4,440 and \$6,593 of recordkeeping fees to AUL and the investment advisor during 2025 and 2024, respectively. The Plan paid Principal \$33,239 of administrative fees during the year ended June 30, 2025. The Organization provides certain administrative services at no cost to the Plan.

### **Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the Organization's general assets. During the year ended June 30, 2025, employee contributions of \$89 were not remitted to the Plan.

**Note 9. Subsequent Events**

On December 14, 2025, approximately \$666,000 of Plan assets transferred from AUL to Principal for the remaining Fixed Account balance that was maintained with AUL as of June 30, 2025.

The entry date for employer contributions eligibility will be amended to be immediate eligibility after meeting a one-year of service requirement versus quarterly entry date.

Subsequent events have been evaluated through January 13, 2026, which is the date the financial statements were available to be issued.
