#### **Note 1 - Description of Plan**

The following description of the B.R. Kreider & Son, Inc. 401(k) Retirement Trust (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

##### **General**

The Plan is a defined contribution 401(k) plan covering substantially all employees of B.R. Kreider & Son, Inc. (the Company). To be eligible to make salary deferrals and receive the employer match, employees must complete one month of service and be age 18 or older. To be eligible to receive the employer nonelective contribution, employees must complete one year of service and be age 18 or older. Employees who are covered by a collective bargaining agreement, certain nonresident aliens, leased employees, or temporary or seasonal employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Contributions**

Each year, participants may contribute a portion of their pre-tax annual compensation, as defined in the Plan. The Plan also allows participants to make after-tax Roth contributions. These contributions are subject to limitations under applicable federal regulations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants will be automatically enrolled in the Plan on the plan entry date, as defined in the plan document, unless they elect to opt out. Participants who are automatically enrolled will have 4% of their eligible compensation withheld and remitted to the Plan and their contributions invested in a designated balance fund until changed by the participant.

The Company may make a discretionary matching contribution. The discretionary matching contribution for the years ended June 30, 2025 and 2024 was equal to 25% of the participant's contributions up to 4% of each participant's salary deferral contributions. The discretionary matching contribution is invested as directed by the participant into the same investment options offered by the Plan. The Company may make a discretionary employer nonelective contribution. There were no discretionary employer nonelective contributions made for the years ended June 30, 2025 and 2024. Contributions are subject to certain IRS limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's matching contribution, as well as allocations of (a) Company's nonelective contributions, (b) plan earnings, (c) forfeitures of terminated participants' nonvested accounts, and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after six years of credited service, based on the following vesting schedule:

##### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, the Plan allows for in-service distributions, including hardship distributions, if certain criteria are met.

##### **Forfeited Accounts**

Forfeited nonvested accounts totaled \$10,424 and \$23,697 at June 30, 2025 and 2024, respectively. These accounts can be used at the discretion of the plan sponsor to pay the Plan's administrative expenses or as an additional Company contribution or to reduce the Company contributions under the Plan. During 2025 and 2024, \$24,817 and \$7,159, respectively, of forfeited nonvested accounts were used to reduce the Company contribution to the Plan.

#### **Note 2 - Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to September 15, 2024. There were no excess contributions payable as of June 30, 2025.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the distribution of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **Note 3 - Information Certified and Provided by Matrix Trust Company**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to cash and investments held as of June 30, 2025 and 2024, and net appreciation in fair value of investments, and interest and dividends for the years ended June 30, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, the custodian of the Plan.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at June 30, 2025 and 2024.

Registered investment companies and money market funds are valued at the net asset value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 - Tax Status

The Company has adopted a pre-approved plan document that was sponsored by Fulton Bank, N.A. The pre-approved document has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company contribution portion of their account.

#### **Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 8 - Related Party Transactions and Party-In-Interest Transactions**

The Plan pays certain expenses related to plan operations and investment activity to various service providers. Fees paid by the Plan amounted to \$85,495 and \$85,343 for the years ended June 30, 2025 and 2024, respectively. These transactions are party-in-interest transactions under ERISA.

Fee rebates of \$8,350 and \$6,485, respectively, are netted against fees paid by the Plan and are included in administrative expenses in the statement of changes in net assets available for benefits for the years ended June 30, 2025 and 2024.

#### **Note 9 - Concentrations of Cash Risk**

At times during the years ended June 30, 2025 and 2024, the Plan's cash balances may have exceeded federally insured limits.

Excess contributions payable are recorded as a reduction of participant contributions on the financial statements. This amount will be reported on the Form 5500 separately as corrective distributions on Schedule H, Line 2f in the plan year the amounts are paid to participants.

#### **Note 11 - Subsequent Events**

Plan management has evaluated subsequent events through February 2, 2026. This date is the date the financial statements were available to be issued. The following material events subsequent to June 30, 2025 were noted:

Effective July 1, 2025, the Plan will allow active participants between the ages of 60 and 63 to increase their catch-up contributions to the greater of \$10,000 or 150% of the regular catch-up limit.

Fulton Financial Advisors, the recordkeeper, strategically partnered with Alerus Retirement to provide recordkeeping and other services to the Plan starting in 2026. The blackout period began on January 28, 2026 and is scheduled to end on February 4, 2026.

No other material events subsequent to June 30, 2025 were noted.
