1. DESCRIPTION OF PLAN:

The following description of the GCR acquisition Company, LLC DBA Civix 401(k) and Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. This Plan is intended to be a qualified retirement plan under Internal Revenue Code Section 401. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General:

The Plan was adopted effective February 2, 1980.

The Plan was restated effective January 1, 2017. The restatement merged the PCC Technology 401(k) and the Quest Information System, Inc. Profit Sharing and Salary Deferral Plan into this Plan. Additionally, the Plan named Principal Trust Company as the Trustee of the Plan effective January 1, 2017.

Effective April 1, 2021, the Plan was restated to adopt the Automatic Data Processing Defined Contribution Plan Non-Standardized 401(k) Profit Sharing Plan and change the Trustee to Reliance Trust Company. On October 12, 2021, the Plan was amended to implement the hardship distribution provisions of the Bipartisan Budget Act of 2018.

Eligibility:

The Plan has no age requirement. To be eligible for employer contributions, employees must have one month of service and no minimum hours of service. Prior to April 1, 2021, employees must have six months of service and no minimum hours of service. Employees may participate in the Plan and begin making contributions on the 1<sup>st</sup> of the month after thirty days of employment.

Contributions:

Salary deferral contributions may be made by each participant who elects to defer a percentage, up to 90% of each year’s compensation, subject to the limitations prescribed by law. Salary deferral contributions prior to April 1, 2021 were limited to 60% of each year’s compensation. The limitations include a dollar maximum amount which was \$23,000 and \$22,500 in 2024 and 2023, respectively. Those participants who are age 50 or older by the end of the calendar year were eligible to make a catch-up contribution of up to \$7,500 in 2024 and 2023.

Contributions: (Continued)

The employer makes discretionary matching employer contributions to the Plan on behalf of each eligible participant in an amount equal to 2.50% of the eligible contributions made by each eligible participant during the contribution period. Additional profit-sharing amounts may be contributed at the option of the Employer.

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of the Company's matching contribution and Plan earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer match contributions and non-elective profit sharing contributions are vested at 100% upon entry into the Plan effective April 1, 2021. Prior to April 1, 2021, the Plan used a graduated vesting schedule in which participants are fully vested after three years of service.

Notes Receivable:

Participants may borrow from their fund accounts a maximum of the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates between 4.25% and 9.50%, which follows local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through bi-monthly payroll deductions. Prior to April 1, 2021, the loan approval process was performed online between the participant and Plan Trustee. Effective April 1, 2021, participant loans must be approved by the plan administrator.

Payment of Benefits (Distributions):

The normal retirement age under the Plan is 55. Disability retirement benefits are also allowed under the Plan. Prior to termination of employment at age 59½, participants are allowed to receive an "in-service" distribution of all or any portion of their vested accounts. Effective October 15, 2015, Electronic certification for hardship withdrawals are permitted under the Plan.

Payment of Benefits (Distributions): (Continued)

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures:

Any forfeiture occurring during a Plan year shall be applied to employer contributions and to the administrative cost of the Plan.

At December 31, 2024 and 2023, there were no forfeited non-vested accounts available for future reductions of employer contributions or administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a distribution based on the terms of the Plan document.

Investment Valuation and Income Recognition:

Investments are reported at fair value, except for the common collective trust and stable value account. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of pooled separate accounts are valued at quoted market prices that represent the net asset value of share of the underlying assets held by the Plan at year-end. The Trustees invest the contributions in cash equivalents, mutual funds, stable value account and common collective trusts as directed by the participants. See Note 3 for a discussion of fair value measurements. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See Note 4 for a discussion of contract value measurements. Common collective trusts are valued at the net asset value. See Note 5 for additional information.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments held during the year.

Payment of Benefits:

Benefits are recorded when paid.

Expenses:

All operating expenses of the Plan are paid by the Company and are therefore excluded from these financial statements.

Compensation Exclusions:

Compensation excludes differential wages for deferral contributions and differential wages, overtime pay, bonuses, and commissions for qualified non-elective employer contributions and matching employer contributions.

3. FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future values. Furthermore,

although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy under Accounting Standards Codification (“ASC”) 820 that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 were not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds and self-directed brokerage accounts are based on quoted net asset values of the shares held by the Plan at year-end.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

Because of the use of net asset value as a practical expedient, the common collective trust investments are no longer classified in the fair value hierarchy. This resulted from a recent change in GAAP guidance on the presentation of fair value measurements when net asset value is used as a practical expedient.

4. STABLE VALUE ACCOUNT:

The Morley Stable Value Fund Class 25 (the "Fund") is Collective Investment Trust maintained by Principal Global Investors Trust Company. The Fund is not a deposit, obligation, guaranteed or insured and not insured by the Federal Deposit Insurance Corporation (FDIC) or any other federal or state government agency. Neither the Fund nor the offering of the Units has been registered under the U.S. securities laws. Therefore, investors will not have the benefit of the protections for registered securities afforded by the Securities and Exchange Commission ("SEC").

The Fund primarily consists of a diversified portfolio of Stable Value Investment Contracts (Investment Contracts) issued by life insurance companies, banks and other financial institutions, the performance of which may be predicated on underlying fixed income investments. The principal value of these assets is designed to remain stable regardless of stock and bond market fluctuations. The Fund is typically appropriate for investors who desire low volatility, stable principal value, and returns commensurate with a capital preservation objective for a component of their retirement savings. The Fund is designed for long-term retirement investing. The interest earned on the Stable Value Investment was 2.6% and 1.8% for the years ended December 31, 2024 and 2023.

The Fund's contract value as of December 31, 2024 and 2023 was \$379,256 and \$340,227, respectively.

5. INVESTMENTS CALCULATED AT NET ASSET VALUE:

The Plan is invested in a common collective trust that calculates net asset value per share. This investment does not have a readily determinable fair (i.e., shares of these investments are not actively traded in financial markets).

6. NOTES RECEIVABLE:

Notes receivable consists of loans to participants and are valued at the outstanding principal amount plus any accrued and unpaid interest. Notes receivable from participants were \$169,739 and \$206,477 at December 31, 2024 and 2023, respectively. Notes receivable carry interest in a range of 4.25% - 9.50% with maturities ranging from March 2025 through August 2029.

7. ADMINISTRATION OF PLAN ASSETS:

Employer and participant contributions are held and managed by the trustee and the custodian which invests cash received, interest, and dividend income, and makes distributions to participants. Plan administration and recordkeeping services for the Plan were provided by ADP Retirement Services and Principal. Administrative fees of \$61,072 and \$67,033 for the years ended December 31, 2024 and 2023, respectively, reported by the Plan were charges related to individual participant accounts and charged against those accounts.

8. TRANSACTIONS WITH PARTIES-IN-INTEREST:

There were no known prohibited transactions with parties-in-interest.

9. TERMINATED EMPLOYEES:

As of December 31, 2024 and 2023, there was \$8,882,246 and \$7,785,844, respectively, in funds which represented separated participants with deferred vested benefits due a refund or future payment to them.

10. PLAN TERMINATION:

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In the event the Plan should terminate, the Plan Administrator will facilitate the distribution of account balances under the provisions of the Plan and Trust Agreement until all assets have been administered and distributed by the Trustee.

11. TAX STATUS:

The IRS has determined and informed the Plan sponsors, ADP, LLP, for the years ended December 31, 2024 and 2023, respectively, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan's Annual Return/Report of Employee Benefit Plan, (Form 5500) for 2024, 2023, 2022, and 2021 are subject to examination by the IRS, generally for three years after they are filed.
