### ***Opinion***

We have audited the financial statements of H & M Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



***Supplemental Schedules Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The ERISA-required supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 and the supplemental Schedule H (Form 5500), Line 4j - Schedule of Reportable Transactions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying supplemental schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

The following description of H & M Employee Stock Ownership Plan (the Plan) is provided for general information only. Participants should refer to the Plan document for complete information.

#### *General*

H & M Fashion USA, Inc., previously known as H & M Hennes & Mauritz, LP (the Company or Employer), established the Plan, effective January 1, 2011, which operates, in relevant part, as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is non-participant directed and covers eligible employees of the Company. There were no unallocated shares at December 31, 2024 and 2023. The Plan was established to provide retirement benefits to employees primarily through capital ownership in H & M Hennes & Mauritz AB (the Parent Company). The Plan is administered by the ESOP Administrative Committee of H & M Fashion USA, Inc. (the ESOP Committee).

GreatBanc Trust Company (the Trustee) is the Plan's trustee.

#### *Eligibility*

All employees of the Company, except for collectively bargained employees (if coverage under this Plan was not agreed to under such bargaining), individuals not on the payroll of the Company, and non-resident aliens who receive no earned income in the United States, are eligible to participate in the Plan on the first day of the month following 12 months of service, with at least 1,000 hours of service during the Plan year, and attainment of age 18.

#### *Plan Contributions*

The Parent Company may contribute cash or company stock to the Plan, at its discretion, subject to certain legal requirements and certain Internal Revenue Service (IRS) limitations. Contributions may be made in one or more installments, without interest, during a Plan year. Employee contributions are not permitted.

#### *Participant Accounts*

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account will be credited as of the last day of each Plan year with the allocation of Parent Company contributions and Plan earnings and charged with an allocation of certain administrative expenses. Parent Company contribution allocations are based on hours worked, as defined, for each eligible participant. Plan earnings and expenses will be allocated based on the ratio of the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Payment of Benefits*

Employees may receive the value of their vested account upon retirement, death, disability, or separation of service from the Company in a lump-sum payment or in a direct rollover distribution to an eligible retirement plan. The amount to be distributed is based upon the immediately

preceding valuation date. Parent Company stock distributions may be made over a period of no longer than five years or, in the case of a participant with a vested account balance in excess of \$985,000, as defined by the Plan, over an additional five years, at the discretion of the Company. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

### ***Vesting***

Employees participating in the Plan are eligible to receive a benefit upon suffering a participant disability (as defined under the Company's long-term disability plan) or death, or after reaching age 62. Employee accounts are vested as follows:

If the Plan is terminated or discontinued, participants will become fully vested in their accounts, provided they are employed by the Company at that time.

### ***Put Option***

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. A participant may exercise their put option at any time during two put option periods, as defined in the Plan document. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### ***Forfeitures***

The unvested portion of accounts of participants who are not 100% vested at the time of separation of service from the Company will, generally, be forfeited upon the earlier of the participant receipt of the vested amount of their account balance or the completion of five consecutive breaks in service years.

Former Plan participants who suffer a forfeiture of their account balance and are re-employed by the Company before the expiration of five consecutive breaks in service years after separation of service from employment, may have their forfeited account balance restored to their account upon repayment to the Plan of the full amount previously distributed to the Plan participant, if any.

Forfeitures may be used by the Company (i) to reinstate previously forfeited account balances of former participants who again became participants, (ii) to reduce the Parent Company's contribution for the Plan year in question, or (iii) to pay any reasonable administrative expenses of

the Plan. If there are any remaining forfeitures, they shall be distributed among the remaining participants' accounts in the same manner that discretionary Parent Company contributions are allocated. Unclaimed account balances may be forfeited and available for reallocation or reduction of the employer's contribution. Forfeitures of terminated nonvested balances allocated to remaining participants at December 31, 2024 and 2023 totaled \$118,322 and \$94,391, respectively.

### ***Voting Rights***

Each participant may direct the Trustee on how to vote their share of allocated Parent Company stock and American Depository Share (ADS) held in their Company Stock Account, as defined in the Plan, with respect to any and all matters on which shareholders may vote. The Trustee solicits the participant's vote in advance of the shareholders' meeting and the ESOP Committee directs the Trustee to vote based on the outcome of the participant's election.

### ***Investment Options***

The Plan is designed to invest primarily in Parent Company stock.

### ***Administrative Expenses***

The ESOP Committee directs the Trustee to pay Plan administrative expenses, which may be paid by either the Plan or by the Company. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### ***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investments in the Parent Company's common stock and ADS into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

## **2. Administration of Plan Assets**

The Plan's assets, which include Parent Company common shares, are held by the Trustee of the Plan. Cash contributions received by the Plan can be invested in Parent Company stock, as directed by the ESOP Committee.

### 3. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The shares of the Parent Company's stock are valued at fair value. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

### 4. Risks and Uncertainties

The Plan's investments include the Parent Company's common stock, which is exposed to various risks, such as interest rate, credit, and overall market volatility risks, as well as valuation assumptions based on earnings, cash flows, and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in participant accounts and the financial statements.

### 5. Investment in the Parent Company's Common Stock

### 6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Common Stock* - Common stock is valued at the closing price reported in the active market on which the common stock is traded.

*Interest-Bearing Cash* - Interest-bearing cash is valued at the daily closing price, as reported by the financial institution.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 7. Related Party and Party-in-Interest Transactions

The Plan's assets include common stock of the Parent Company. The Parent Company paid cash dividends to the Plan of \$44,425 and \$59,848 during the year ended December 31, 2024 and 2023, respectively. These are related party and party-in-interest transactions. The Plan also has a number of service providers. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

## 8. Plan Termination

Although it has not expressed any intent to do so, the Parent Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## 9. Tax Status

The Plan received a determination letter from the IRS dated August 19, 2016, which states that it is in compliance with the appropriate sections of the IRC, and therefore, the related trust is exempt from taxation. Continued qualification is dependent on operation of the Plan within ERISA and IRS guidelines. The Plan has been amended since the date of the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
