Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of 401(k) Profit-Sharing Plan for Employees of Lake Region Corporation, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Note 1 - Description of Plan

The following brief description of the 401(k) Profit-Sharing Plan for Employees of Lake Region Corporation (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering qualified employees of Lake Region Corporation (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan.

Eligibility

Employees are eligible to participate in the Plan upon their employment commencement date for elective deferrals. Eligibility for employer matching and nonelective contributions requires completion of one year of service, defined as at least 1,000 hours of service during the eligibility computation period, which is measured as the employee's anniversary year beginning on their employment commencement date. Eligibility for employer discretionary nonelective contributions requires 1,000 hours of service and employment on the last day of the Plan year. Certain employees are excluded from participation, including non-resident aliens, custodians, and residents of Puerto Rico.

Entry Date

Employees may enter the Plan on the first day of the month following or coincident with satisfaction of the Plan's eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Organization contributes a fixed matching contribution equal to 50% of the first 4% of eligible compensation that a participant contributes to the Plan. In addition, the Organization makes a fixed nonelective contribution equal to 2% of each eligible participant's compensation. Additional discretionary matching or nonelective contributions may be made at the discretion of the Organization; however, no such additional discretionary contributions were made for the year ended June 30, 2025.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated targeted fund until changed by the participant.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Organization's matching contributions, fixed nonelective contributions, as well as any allocation of additional discretionary contributions, if made, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct deferrals and employer contributions in any of the investment funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their contributions, including both pre-tax and Roth elective deferrals, plus actual earnings thereon. Vesting in the employer's contributions, including matching and nonelective contributions, is based on years of credited service. A participant becomes 100% vested after five years of credited service. Participants are also 100% vested upon reaching early retirement age (age 55), death, or disability.

The following table summarizes the vesting schedule based on years of credited service:

Forfeitures

At June 30, 2025 and 2024, forfeited non-vested accounts totaled \$5 and \$306, respectively. These accounts will be used to reduce future employer contributions and/or offset plan expenses. During the year ended June 30, 2025, plan expenses were reduced by \$8,492 from forfeited non-vested accounts.

Notes Receivable from Participants

Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The interest rate is determined monthly and is set at 1% above the prime rate. Principal and interest are repaid ratably through payroll deductions over a period not to exceed five years, except that if the loan proceeds are used to acquire the participant's primary residence, the repayment period may extend up to 10 years. A participant may have no more than one outstanding loan at any time.

Payment of Benefits

Participants may elect to receive a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan Document upon retirement, termination of service, death, or disability. A terminated participant with a balance of less than \$5,000 is automatically paid out and their balance is rolled into a qualified Individual Retirement Account. Distributions may also be made at the participant's election prior to termination upon attainment of age 59½ or hardship as defined in the Plan document.

Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statement is prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Organization determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions and the related employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits

Benefit payments to participants are recorded upon distribution. Amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$8,107 and \$0 at June 30, 2025 and 2024, respectively.

Expenses

The Plan's expenses are paid by either the Plan or the Organization, as provided by the Plan document. Expenses that are paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Separate accounts – mutual funds – Valued at fair value based on the NAV of units as determined by the insurance company. The NAV is based on the observable market prices of the underlying assets within the account less liabilities. The NAV for the underlying assets of the account is a readily determinable measure of their fair value and is the basis for current transactions.

Common collective fund – Valued at fair value based on the NAV of units held of the collective fund. The NAV, as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Guaranteed interest account – The fair value of the non-fully-benefit responsive guaranteed interest account is measured using an income approach and discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Note 4 - Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company (MOA) (the trustee of the Plan) as of June 30, 2024 and for the period July 1, 2024 to August 12, 2024 and Alerus Financial, N.A. (the Plan's trustee) as of June 30, 2025 and for the period August 13, 2024 to June 30, 2025.

Note 5 - Tax Status

The Plan uses a pre-approved plan document sponsored by Alerus Financial, N.A., which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Investment with Insurance Company

The Plan has entered into a non-fully benefit-responsive guaranteed interest account with MOA. MOA maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. MOA is contractually obligated to repay the principal and specific interest rate that is guaranteed to the Plan. The guaranteed interest contract is included in the financial statements at fair value.

Note 7 - Related Party and Party-in-Interest Transactions

Certain Plan investment, for the year ended June 30, 2024, consisted of a guaranteed interest account managed by MOA, the previous trustee, as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Plan Amendments

The Plan switched trustees from Mutual of America Life Insurance Company to Alerus Financial, N.A. in August of 2025.

Note 10 - Subsequent Events

Effective November 1, 2025, the Plan changed its trustee and record keeper from Alerus Financial, N.A. to Mutual of America Life Insurance Company.

Effective November 1, 2025, the Plan document had the following amendments to the Plan:

- Part-time employees are excluded from participating, which are defined as participants whose regularly scheduled service is less than 20 hours of service in the relevant computation period.
- The Plan was amended to remove the automatic-enrollment provision.
- A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination.

The Organization has evaluated subsequent events through February 13, 2026, the date which the financial statements were available to be issued.
