To Whom It May Concern:

This letter is to request a waiver of penalty for the late filing of 2024 Form 5500-EZ.

We have always used the ADP Retirement Services to help us with our account. We hired them and relied on their tax knowledge to make sure we comply with tax law.


I contacted ADP Retirement Services in June 2025 to find out if I was required to file a Form 5500-EZ for the year 2024 because there was a zero balance in the account. I would normally see this prepared form on my home page when I signed into the Ryan Harrison Enterprises Inc. ADP account. I was told that I would see any filing reports that needed to be completed on my home page and there was nothing there. I told the ADP tax representative that I did not see anything and they said that the account was all caught up with filings.

As I said above, we had a zero balance at the end of 2024. All the assets of the account were distributed on September 13, 2024 and this account is no longer being used.

We received a Filing requirement reminder in the mail on February 23, 2026 from the IRS. I again called ADP Retirement Services to find out why we have received this notice. The person informed me that we should have filed a final Form 5500-EZ and that ADP should have notified us about this but we did not receive any notifications. I was given the wrong information about filing and this is why it did not get filed.

Please except this request to waive any penalty.
