### **Reasonable Cause for Late Filing**

The plan sponsor respectfully requests waiver of any late-filing penalties based on reasonable cause.

The plan sponsor timely attempted to comply with the Form 5500 filing requirements by submitting Form 5558, Application for Extension of Time to File Certain Employee Plan Returns, on January 13, 2026, which was prior to the original due date for the plan year ended June 30, 2025. Due to an administrative error, the Form 5558 incorrectly listed the plan year end as December 31, 2024 instead of June 30, 2025. As a result of this clerical error, the Internal Revenue Service denied the extension request.

The denial was not the result of willful neglect or an intent to delay filing. The plan sponsor exercised ordinary business care and prudence and made a good-faith effort to file a timely extension prior to the actual original due date applicable to the plan. Upon becoming aware of the error, the plan sponsor promptly proceeded with filing the Form 5500 well before the date that would have applied had the extension been correctly prepared.

Given these facts, the plan sponsor believes reasonable cause exists and respectfully requests that any penalties associated with the denied extension be waived.
