We have performed audits of the accompanying financial statements of the Summit School Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of June 30, 2024, and June 30, 2023, the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

#### 1. **Description of the Plan**

The following is a brief description of the Summit School Retirement Plan (the “Plan”) and is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a qualified defined benefit pension plan covering eligible employees, who are members of a controlled group which includes the Jamaica Estate, NY campus, of the Summit School, Inc. (the “School”). The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Principal Life Insurance Company is the investment custodian of the Plan (the “Investment Custodian”). The Plan’s investments are held by the Plan’s Investment Custodian. The Investment Custodian and the Plan administrator are appointed by the School.

Effective September 15, 2024, the School froze the Plan to new entrants and accrued benefits to employees. The School elected on December 10, 2024, to liquidate and terminate the Plan, effective December 15, 2024, and management determined liquidation is imminent. Participants can elect a lump sum distribution of their benefits before the purchase of annuity contracts from an insurance company to satisfy any remaining benefit obligations. All assets have been liquidated with final benefit payment to participants made October 2025.

##### **Eligibility**

The Plan covers all eligible employees of the School who have attained the age of 21 years and who have completed one year of eligibility service, defined as a 12 consecutive month period beginning with the employees’ first day of employment with a minimum of 1,000 hours of service.

##### **Contributions**

The Plan’s funding policy is to make annual employer contributions in amounts actuarially determined. Contributions by participants are not permitted.

##### **Pension Benefits**

Participants, who have on the first month coincident with or next month following attainment of age 65 and completion of five years of Plan participation (“Normal Retirement”), are entitled to pension benefits for life upon retirement based on an annual service credit which varies based on job title, between \$30 and \$100, multiplied by the years of credited service up to 35 years, which equals the monthly benefit at retirement, as defined in the Plan document. The Plan does not permit early retirement; therefore, no special benefits are payable upon retirement at an age prior to the normal retirement age.

#### 1. Description of the Plan

##### **Pension Benefits**

If a married participant dies prior to retirement, their vested accrued benefits will be paid to their spouse. Otherwise, there is no provision in the Plan for payment to a surviving beneficiary. Eligible employees may elect to receive their pension benefits in a lump sum, if the actuarial equivalent value of the participants vested accrued retirement benefit does not exceed \$5,000, otherwise, the benefit will be in the form of a life annuity. A participant who was legally married throughout the one-year period before commencement of benefits may elect a joint and survivor annuity. Otherwise, any other form of benefit election will require spousal consent.

##### **Death Benefits**

In the event of the death of a participant while still employed, but prior to commencement of vested accrued retirement benefits, the Plan will provide a benefit to the spouse of the participant commencing on what would have been the participant's normal retirement date based on a qualified joint and survivor annuity form of benefit payment, with the condition that they were married throughout the one-year period ending on the date of death of the participant.

##### **Vesting**

Participants become 100% vested after five years of service with the School, the attainment of the normal retirement age, or the participant dies or becomes disabled while an employee. A participant shall be credited with one year of vesting service for each Plan year in which the participant completed 1,000 hours of service within a 12-consecutive month period.

##### **Administrative Expenses**

Any Plan expenses not paid by the School shall be paid by the Plan. All expenses directly relating to investments of the Plan shall be paid by the Plan. The School incurred certain administrative expenses relating to the Plan for the years ended June 30, 2024 and 2023, without charge to the Plan.

#### 2. Summary of Significant Accounting Policies

##### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

## 2. Summary of Significant Accounting Policies

### Use of Estimates and Assumptions

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the beginning of the Plan year and accompanying notes. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value except the investment contracts with insurance companies which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements. Investment contracts with insurance companies are valued at contract value which represents the amount of contributions deposited, plus interest credited daily as determined by the contract, less any participant withdrawals and administrative expenses paid. Purchases and sales of securities are recorded as of the trade date. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. The Plan presents, in the Statements of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) of the fair value of its investments, which includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, which are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to: (1) retired or terminated employees or their beneficiaries, (2) beneficiaries of employees who have died and (3) present employees or their beneficiaries. Benefits payable under all circumstances (retirement, death, disability and termination of employment) are included to the extent they are deemed attributable to employee service rendered to the valuation date. See Note 10 for the assumptions used in the actuarial valuations and further details.

### Payment of Benefits

Benefit payments to participants or beneficiaries are recorded upon distribution.

## 2. Summary of Significant Accounting Policies

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

### **Income Tax Status**

The Internal Revenue Service (“IRS”) has determined in an opinion letter dated March 30, 2018, that the volume submitter plan adopted by the School, qualifies under Section 401(a) of the Internal Revenue Code (“IRC”). The Plan has been amended since the date of the opinion letter but the School believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. No provision for income taxes has been included in the financial statements since the Plan has no unrelated business income tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the Department of Labor (“DOL”). The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the DOL and the IRS; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to July 1, 2021.

### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through February 13, 2026, which is the date the financial statements were available to be issued.

#### **3. Funding Policy**

Contributions to provide benefits under the Plan are made solely by the School. The School's policy is to make cash contributions to the Plan in amounts determined by the Plan's actuary. The School made contributions to the Plan of \$554,700 and \$435,300 for the years ended June 30, 2024 and 2023, respectively.

The School has met the minimum funding requirements of ERISA for the years ended June 30, 2024 and 2023. Although it has not expressed any intention to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA (see Note 4).

#### **4. Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA, which it elected to do, effective December 15, 2024. As discussed in Note 1, there were sufficient assets to either distribute to requesting participants or to purchase annuities contracts from an insurance company to satisfy any remaining benefit obligations.

#### **5. Investments**

For the years ended June 30, 2024, and 2023, the Plan's investments appreciated, including gains and losses on investments bought, sold, as well as held during the year, in value by \$989,950 and \$872,184, respectively.

#### 6. Fair Value Measurements

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024, and 2023:

**Pooled separate accounts:** Valued at the net asset value (“NAV”) of units of the underlying insurance company maintained pooled separate account. The NAV, as provided by the Investment Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

## Actuarial Basis

### A. Funding Method

The valuation method is the actuarial cost method prescribed under Section 430 of the Internal Revenue Code.

Under this method, the following terms are used:

The Funding Target is the sum of the present value of all benefits accrued or earned under the plan as of the beginning of the plan year.

The Applicable Funding Target is equal to the Funding Target multiplied by the applicable transition percentage under the Worker, Retiree, and Employer Recovery Act of 2008.

The Target Normal Cost is the sum of the present value of all benefits which are expected to accrue or be earned under the plan during the plan year.

The Carryover Balance maintained by the plan was set equal to the Credit Balance, if any, in the Funding Standard Account as of the final day of the 2007 plan year. It is decreased when used to reduce the minimum required contribution in succeeding plan years. The unused portion is adjusted to reflect the rate of return on plan assets in those succeeding plan years.

The Prefunding Balance is the accumulation of discounted contributions in excess of the minimum funding requirement for 2008 and later plan years. It is decreased when used, and adjusted for return on plan assets, similarly to the Carryover Balance.

The Funding Shortfall is equal to the Funding Target, less the Actuarial Value of Assets, reduced by the Prefunding Balance and the Carryover Balance.

The Adjusted Funding Shortfall is equal to the Applicable Funding Target, less the Actuarial Value of Assets, reduced by the Prefunding Balance and the Carryover Balance.

A Shortfall Amortization Base is established for a plan year equal to the Adjusted Funding Shortfall less the present value of the existing Shortfall Amortization Installments and Waiver Amortization Installments, if any. Under some circumstances, no Shortfall Amortization Base may need to be established and/or prior Shortfall Amortization Bases may be eliminated.

A Shortfall Amortization Installment is the amount necessary to amortize the Shortfall Amortization Base over the 7-plan-year period beginning with the plan year it is established. Under the Preservation of Access to Care for Medicare Beneficiaries and Pension Relief Act of 2010, an extended amortization period may be elected by the plan sponsor for certain plan years. Effective with the 2021 plan year, the American Rescue Plan Act (ARPA) allows the plan sponsor to eliminate all prior amortization installments and reamortize the Funding Shortfall over a period of 15 years. A 15-year period will then be used for any new Shortfall Amortization Installments established in future plan years. The sponsor may choose to reamortize in the 2020 or 2021 plan years but must do so by the 2022 plan year.
