To Whom It May Concern,

This letter is submitted to request waiver of any late filing penalties associated with the late filing of the above-referenced Form 5500. The late filing was due to reasonable cause and not willful neglect.

The Plan Sponsor has a history of good-faith compliance with all applicable ERISA and IRS reporting requirements. The delay in filing occurred as a result of administrative related circumstances that were outside of our normal filing process, including:

- Miscommunication regarding filing responsibility during internal personnel changes, which was identified and corrected as soon as discovered.

Upon identifying the oversight, the Plan Sponsor acted promptly and in good faith to complete and submit the Form 5500 as soon as practicable. Corrective steps have been implemented to ensure this does not occur in the future, including improved internal controls, clearer assignment of filing responsibility, and enhanced coordination with our service providers.

At all times, the Plan Sponsor intended to comply fully with its reporting obligations, and there was no intent to avoid or delay filing. Plan participants were not harmed, and all plan operations remained compliant during the period in question.

Based on the facts outlined above, we respectfully request that all late filing penalties be waived under the reasonable cause provisions.
