Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Puragain Water LLC 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the period March 1, 2024 through December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Puragain Water LLC 401(K) Plan, 's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Puragain Water LLC 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Puragain Water LLC 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A – DESCRIPTION OF THE PLAN

The following description of the Puragain Water LLC 401(K) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is available to eligible employees of Puragain Water LLC and its affiliate Puragain Water NV, Inc. The Company's adopted the plan effective March 1, 2024; calendar year 2024 is the first year of plan operations. The plan maintains a discretionary contribution will be allocated to each eligible, select group of employees or named contracts. The discretionary contribution will be given to those employees who have completed six months of service since their first day of employment. The Plan did not make any discretionary contributions during the plan year. The plan provides for automatic enrollment when the employee becomes eligible to participate in the plan. The initial contribution percentage is 3%, increasing 1% each successive year up to a maximum of 10%. Employees have the right to opt out of participating in the plan or the annual increases.

The Plan also contains an Internal Revenue Code (Code) Section 401(k) salary deferral arrangement covering eligible employees who have elected to participate beginning on their eligibility date, which is the first day of the month following their attaining six months employment with the Company. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan does not provide for a matching employer contribution.

Contributions

Contributions to the Plan include: salary reduction contributions authorized by participants, discretionary profit sharing contributions by the Company, rollovers from new participants from another qualified plan, and rollovers from an individual retirement account or annuity described in section 408(a) or 408(b) of the Code.

Participants may contribute up to the maximum percentage allowable, not to exceed the limits of the Code Sections 401(k), 404 and 415 of their annual compensation, by means of a salary deferral agreement. The contribution is subject to a maximum of \$23,000 for 2024. Eligible employees over the age of 50 may defer an additional \$7,500 as a catch-up in 2024.

Participant Accounts

Defined Contribution Profit Sharing - The Company's discretionary contribution will be allocated to each eligible, select group of employees or named contracts. The contribution will be given to those employees who have completed six months of service to the company. The employer did not make a profit sharing contribution for the period March 1, 2024 through December 31, 2024.

NOTE A – DESCRIPTION OF THE PLAN (CONTINUED)

401(k) - The Plan contains a Code Section 401(k) salary deferral arrangement covering eligible employees who have elected to participate beginning on their eligibility date. Each participant's account is credited with the participant's salary reduction contribution. Investments are based on participants' elections.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the discretionary profits sharing contributions, if any, is shown in the table below.

Payment of Benefits

On termination of service due to death, disability or retirement or other reasons, inactive participants or beneficiaries with a vested balance of \$5,000 or less will receive a mandatory cash distribution from the plan as soon as administratively possible after their termination of service date if they have not elected to take a distribution of their account. .

Forfeited Accounts

At the Company's discretion, the forfeited accounts will be used to reduce employer contributions or pay plan administrative expenses. During 2024 and as of December 31, 2024 the Company did not have any forfeited account balances. Forfeitures occur on the earlier of the last day of the Plan year in which the entire vested portion of a participant's account is distributed or the last day of the Plan year in which the participant incurs five consecutive one year breaks in service.

Participant Loans

The Plan provides that Participants may borrow from their fund accounts up to 50% of their vested account balance with a minimum loan of \$1,000 and a maximum of \$50,000. Loan repayments are made through payroll deductions and only two loans may be outstanding at one time. Loans are secured by the participant's account balance and bear interest at market interest rates established on a quarterly basis.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statement of the Plan are prepared under the accrual method of accounting, except for the cash basis recording of benefits paid.

Investment Valuation and Income Recognition

The Plan's investments in shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. The changes in market value from year to year are recorded as net appreciation in fair value of investments. Interest and dividends are recorded in the appropriate investment accounts when credited to the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The plan faces investment risks in providing appropriate investment options, safeguarding assets, maintaining complete and accurate records of employee investments and controlling operating costs. The plan sponsor minimizes the investment and record keeping risks by engaging a qualified third party administrator (TPA) to manage and invest the plan assets. The TPA has established extensive internal controls to ensure the accurate and complete accounting for funds under investment and engages an outside audit firm to audit and report on these internal controls. The plan trustees monitor plan fees and investment options by regular communications with the TPA.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through the date of the auditor's report, which is the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

Fair value accounting standards define fair value, establish a framework for measuring fair value, outline a fair value hierarchy based on inputs used to measure fair value and enhance disclosure requirements for fair value measurements. The fair value hierarchy distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Level 1 or 2 of the hierarchy) and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

Basis of Fair Value Measurement

Level 1 inputs are quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 inputs are inputs other than quoted prices in markets included within Level 1 that are observable for the investment, either directly or indirectly.

Level 3 inputs are unobservable inputs for the investment.

NOTE D – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE E – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE OF THE PLAN

In accordance with Section 2520.103-8 of the Department of Labor’s Rules and Regulations from Reporting and Disclosures under ERISA, the Plan administrator has elected to restrict the scope of the auditor’s examination with regard to statements or information prepared and certified by ADP, the custodian. The Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by ADP, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedules.

Principal also certified the completeness and accuracy of \$679 of net depreciation in fair value of investments and \$4,066 of interest and dividends related to the aforementioned investments for the ten months ended December 31, 2024.

NOTE F – RECONCILIATION OF AUDITED FINANCIAL STATEMENTS AND FORM 5500

The Plan did not pass 415 testing for the period ended December 31, 2024. As a result the plan refunded excess contributions made during 2024 totaling \$11,325 to two participants; the refunds were issued in October 2025. The refund of the excess contributions is material to these financial statements so a liability has been recorded on the Statement of Net Assets Available for Benefits. The Form 5500 instructions require the excess contributions to be recorded when paid in the subsequent year as participant distributions. As a result the Net Assets Available for Benefits and the Net Increase in Net Assets are both lower on the audited financial statements than the 5500 report by \$11,325.

NOTE G – TAX STATUS

The Plan intends to rely on the IRS Approval Letter issued to ADP LLC dated November 1, 2001 covering the group trust arrangement and a letter to the plan dated October 6, 2020 covering plan amendments made through that date. The Plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statement. The Plan administrator is not aware of any activity or transactions that may adversely affect the qualified status of the Plan. Calendar year 2024 is open and subject to examination by the Internal Revenue Service.

NOTE H – RELATED PARTY TRANSACTIONS

Certain Plan investments are registered investment companies issued by Fidelity and Vanguard. ADP is the trustee as defined by the Plan and, therefore, these transactions do not qualify as party-in-interest transactions. Administrative fees paid by the Plan totaled \$1,010 for the year ended December 31, 2024. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. Participant loans also qualify as party-in-interest transactions.
