Dears Sirs,

I lost my husband, Jeffrey Ulrich, in a tragic car accident in late February of last year. He was the owner and President of Hydro Fabrication, Inc. a small metal fabricating firm. He and his 2 employees maintained this business and the 401k plan for several years.

After my husband's death I contacted his 401k plan third-party administrator, Paychex, they were somewhat helpful in directing me to become the plan trustee for Hydro Fabrication's 401k plan, this was a very confusing process. I was told that they were producing and filing a necessary 5500 report for 2024. I was also told that in early 2026 that they would produce and file a final 5500 report because the plan was closed in 2025.

As a follow-up, I recently reached out to Paychex, to confirm that everything had been done, at that point I was notified by Paychex that the 5500 forms had not been filed for 2024. At that point they notified me that I was responsible for filing the report. They also notified me that there are significant penalties for late filing of the form 5500. They suggested I contact the e-fast help line; it is at that point that the good people at EFAST explained the filing process. They suggested that I set up a new User ID on their site and re-file the form 5500-SF for 2024 and submit a letter of explanation with that filing. Due to the stress of suddenly losing my husband, closing the business and the confusion created by Paychex, I would like to ask for lenience regarding any fines regarding the filing of the 2024 form 5500-SF, thank you for your consideration.
