### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Textile Industry Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### NOTE 1 - DESCRIPTION OF PLAN

The following description of Textile Industry Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a multiple employer defined contribution plan covering substantially all employees of Advanced Textiles Association (ATA) (the Plan sponsor) and its members (collectively, the Employers) that have elected to adopt the Plan and who have met the eligibility requirement as defined by the Employers' individual participant agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Textile Industry Retirement Plan Committee of Trustees oversees the governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Each year participants may contribute up to 100% of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts as investment options for participants.

The Employers may choose to make a discretionary matching and nonelective contributors each year as defined in the individual participation agreement. Contributions are subject to certain statutory limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Employers' matching contributions, as well as allocations of the Employers' discretionary nonelective contribution (when applicable) and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions, the Employers' safe harbor matching and nonelective contributions plus actual earnings thereon (as defined in the individual participation agreement). Vesting in the Employers' matching and discretionary nonelective contribution portion of their accounts was based on years of continuous service. Participants should refer to the Summary Plan Description of their Employer for a complete description of the vesting schedule. A participant will always become fully vested upon death, disability, attainment of normal age of 65, or attainment of early retirement age of 55 with five years of service.

### NOTE 1 - DESCRIPTION OF PLAN (Continued)

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at 5.75% to 9.5%, which are commensurate with local prevailing rates and is set at 1% above the prime rate. Principal and interest are paid through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments for a specific number of years not to exceed the life expectancy of the participant or beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the terminated participant's account balance does not exceed \$7,000, the vested account balance will be automatically paid out in a single lump sum payment.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15,143 and \$0. These accounts would be used to reduce the Plan's administrative expenses and future employer contributions. In 2024, approximately \$9,000 of forfeitures were used to reduce employer contributions.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Contributions Received and Receivable

Contributions from the Plan participants and the matching contributions from the Employers are recorded in the year in which the participant contributions are withheld from compensation.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Textile Industry Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the Participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

#### Subsequent Events

The plan has evaluated subsequent events through November 18, 2025, the date the financial statements were available to be issued. As discussed in Note 9, on August 1, 2025, Awning and Sign Contractors (an adopting employer) discontinued participation in the Plan and the related account balances were transferred out as of that date.

### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period February 9, 2024 to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan). Prior to February 9, 2024, information related to investments and notes receivable from participants was obtained management and agreed to or derived from information certified as complete and accurate by Transamerica Financial Life Insurance Company, Inc.

### NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Textile Industry Retirement Plan Committee determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Observable inputs such as unadjusted quoted prices in active markets and have the highest priority,

Level 2 - Inputs, other than quoted prices in active markets, which are observable either directly or indirectly; and,

Level 3 - Unobservable inputs where there is little or no market data, which requires the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at Net Asset Value (NAV) as the practical expedient to estimate fair value and are aggregated in the fair value hierarchy are as follows:

*Pooled Separate Accounts:* Valued at the net asset value per unit based on either the observable net asset value of the underlying investment or the net asset value of the underlying pool of securities. Net asset value is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

- (1) This class represents investments in actively managed pooled separate accounts registered investment company or variable separate accounts that invests in funds according to an asset allocation strategy designed for investors' projected retirement date.
- (2) This class represents investments in actively managed pooled separate accounts registered investment company or variable separate accounts that invests in funds seeking long-term growth of capital and can accept the relatively high levels of risk and volatility that typically accompany a broadly diversified portfolio constructed by investment professionals.
- (3) This class represents investments in actively managed pooled separate accounts registered investment company or variable separate accounts that invests in funds seeking long-term growth of capital and can accept the inherent risks of investing in stocks.
- (4) This class represents investments in actively managed pooled separate accounts registered investment company or variable separate accounts that invests in funds seeking long-term growth of capital with some protection against stock market volatility, but can accept the inherent risks of investing in stocks. Seeks to track the performance of a benchmark index that measures the investment return of the overall U.S. stock market with 60% of its assets. With the other 40% of its assets, the investment option seeks to track the performance of a broad market-weighted bond index.
- (5) This class represents investments in actively managed pooled separate accounts registered investment company or variable separate accounts that invest in funds seeking to offer a steady stream of investment income and some protection against stock market volatility. The portfolio is predominantly fixed income securities and broad, market-weighted bond index.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

### NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by John Hancock Life Insurance Company, the custodian, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than direct payment. As described in Note 2, the Plan made a direct payment to various parties in interest of the Plan for administration fees, of \$41,363 for the year ended December 31, 2024, which was not covered by revenue sharing. The Employers pays directly any other fees related to the Plan's operations.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### NOTE 6 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **NOTE 7 - TAX STATUS**

The Plan uses a Volume Submitter Profit Sharing Plan document sponsored by DWC THE 401(K) EXPERTS, which received an opinion letter from the IRS, dated June 30, 2020, which states that the volume submitter document plan satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **NOTE 9 - CHANGE IN PARTICIPATING EMPLOYERS**

Effective August 1, 2025, Awning and Sign Contractors (an adopting employer) discontinued participation in the Plan and the related account balances were transferred out as of that date.
