INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of the Arc-Com Fabrics, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Arc-Com Fabrics, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2025 (in liquidation) and December 31, 2024 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2025 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination Liquidation Basis of Accounting and Distributions

As further discussed in Note A[1] to the financial statements, pursuant to a resolution of the Board of Directors and shareholders of Arc-Com Fabrics, Inc. (the "Company"), the Plan was terminated effective July 7, 2025. As a result, the Plan changed to the liquidation basis of accounting during the year ended December 31, 2025. As discussed in Note A[1] to the financial statements, on October 7, 2025, the Plan sponsor issued distribution checks representing substantially all of the Plan's assets. As of December 31, 2025, certain of these checks had not been negotiated by participants, and the related amounts are reflected as liabilities in the accompanying financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Arc-Com Fabrics, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

[1] General and Plan Termination:

The Plan was a defined contribution plan covering all employees of Arc-Com Fabrics, Inc. (the "Company") who completed three months of service and were age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The recordkeeper of the Plan was Principal Life Insurance Company ("Principal").

Pursuant to a resolution of the Board of Directors and shareholders of the Company, in connection with the acquisition of substantially all of the assets of the Company by Arc-Com LLC, an entity owned by CF Stinson and American Pacific Group, the Plan was terminated effective July 7, 2025. As of the effective date of Plan termination, the Plan was frozen to the entry of new participants, all employee and employer contributions ceased, no new loans could be taken, and Plan participants became 100% vested in each participant's respective account balance. On October 7, 2025, the Plan sponsor issued distribution checks representing substantially all of the Plan's assets. As of December 31, 2025, a certain number of these checks had not been negotiated by participants, and the related amounts are reflected as liabilities on the statements of net assets available for benefits.

[2] Contributions:

Prior to termination, each eligible employee ("participant") in the Plan could have made pre-tax elective deferral contributions and Roth deferral contributions to the Plan as of the 1st of the month following the requirements of eligibility being met. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. In no event could participant pre-tax and Roth contributions exceed any statutory limitations. Participants could have contributed amounts representing distributions from other qualified defined benefit or contribution plans.

The Company could have made annual discretionary matching contributions of up to 6% of the participants' salary and/or discretionary profit-sharing contributions. To be eligible for discretionary profit-sharing contributions, a participant must have worked 1,000 hours in the given Plan year. Contributions were credited to individual accounts of each participant. For the year ended December 31, 2025, the Retirement Committee of the Plan suspended the discretionary matching contribution and profit-sharing contribution. The Plan allowed participants to direct the investment of their contributions and the Company's contributions into various investment options.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation. The Plan also had an escalation feature whereby the deferral rate increased each year by 1% up to a maximum of 10%.

[3] Participant accounts:

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's discretionary matching contributions, (b) Plan earnings, and may have been charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

[4] Vesting:

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts, plus actual earnings thereon, was as follows:

As of the effective date of Plan termination, Plan participants became 100% vested in each participant's respective account balance.

[5] Notes receivable from participants:

Notes receivable from participants were measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants could borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years; however, terms may have exceeded five years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates on outstanding loan balances ranged from 3.25% to 8.50% at December 31, 2024. Principal and interest were paid ratably through payroll deductions. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document.

[6] Payment of benefits:

At retirement, a participant was entitled to receive the vested amount in his or her separate account. The Plan provides that distributions at retirement could be made at the participant's option, either in one of several annuity options or in a lump-sum distribution. A participant's normal retirement age was 59-1/2. Early retirement was not permitted.

Upon the death or disability of a participant, the participant's vested contributions was distributed to his or her beneficiary either in the form of a life annuity or a lump sum, as the beneficiary could determine.

Upon termination, a participant was entitled to his or her vested interest in the amount credited to his or her account. As noted in Note A[1], the Plan has been terminated and all participant account balances were distributed as of October 7, 2025.

[7] Forfeitures:

Forfeited non-vested accounts could have been used to reduce future Company contributions and pay Plan expenses. During the year ended December 31, 2025, forfeitures of \$5,083 were used to pay Plan expenses. Forfeited non-vested accounts available at December 31, 2025 and 2024 were \$0 and \$4,566, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

As a result of the Plan termination effective July 7, 2025, the financial statements have been prepared under the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would exclude any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

[2] Subsequent events:

The Plan has evaluated subsequent events through February 16, 2026, the date the financial statements were available to be issued.

[3] Investment valuation and income recognition:

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation in value of investments included the Plan's gains and losses on investments bought and sold, as well as held during the year.

[4] Payment of benefits:

Benefits were recorded when paid.

[5] Plan expenses:

Substantially all expenses were paid by the Plan and charged to participant accounts.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

[7] Cash:

Cash represents amounts related to benefit distribution checks issued to participants in connection with the Plan's termination that had not been negotiated as of December 31, 2025. These amounts remain assets of the Plan until claimed.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Principal Life Insurance Company, and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, has certified to the completeness and accuracy of all investments and related investment activity as of October 7, 2025, and for the period January 1, 2025 to October 7, 2025, and as of December 31, 2024, which are included in the accompanying statements of net assets available for benefits as of December 31, 2025 (in liquidation) and December 31, 2024 (ongoing), and the statement of changes in net assets available for benefits for the year ended December 31, 2025 (in liquidation).

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2025 and 2024.

Stable value collective investment trust – A stable value fund that is composed primarily of fully benefit-responsive investment contracts and that is valued at the net asset value ("NAV") of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) could occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserved the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, required a twelve-month advance written notice. Included in this advance written notice requirement were full or partial withdrawals of assets invested in the trust resulting from Plan Sponsor directed actions. Such Plan Sponsor directed actions included but are not limited to: 1) trustee or Plan Sponsor directed reallocation of investments; 2) Company sponsored layoffs/terminations of groups of employees; 3) disposing of or selling a component of the business, which involved the transfer or termination of employees; 4) terminating the fund as an investment option of the Plan; and 5) terminating the Plan. There were no unfunded commitments.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Pooled separate accounts – Valued at NAV, as a practical expedient, based on the market value of the underlying investments. The NAV is not a publicly quoted price in an active market. The pooled separate accounts were comprised of a wide variety of underlying investments such as equities, preferred stock, bonds and real estate. The Plan's investment in pooled separate accounts had no restrictions on the NAV price or its equivalent. There were no known or anticipated redemptions, no unfunded commitments, and no notice was required to sell the shares/units at any given time.

Investments that were measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy.

The preceding methods described may have produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

NOTE E - TAX STATUS

The Plan had adopted a Prototype Non-standardized Profit Sharing Plan with CODA sponsored by Principal. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believed that the Plan was qualified, and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator had analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2025, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan was subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments consisted of pooled separate accounts and a collective investment trust managed by Principal. Principal was the Plan recordkeeper; therefore, transactions related to these investments qualified as party-in-interest transactions. Fees paid by the Plan to Principal were \$35,189 for the period ended December 31, 2025.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
