We have performed audits of the financial statements of Carvana, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

(1) Description of the Plan

The following description of the **Carvana, LLC 401(k) Plan** (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

A. **General** – The Plan was established as a defined contribution plan effective January 1, 2018. The Plan covers all employees over 18 years of age of Carvana, LLC (the “Company”) who are not subject to a collective bargaining agreement, leased employees or resident aliens as defined by the Plan document. Eligible employees of the Company may participate in the Plan immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended and the Internal Revenue Code (“IRC”).

B. **Contributions** – Participants may contribute up to 100% of their base earnings to the Plan up to the maximum allowed by the IRC Section 401(k) limits. The Plan provides for a Roth 401(k) contribution option. Participant contributions under the IRC Section 401(k) were subject to a maximum of \$23,000 for the year ended December 31, 2024. In addition, the Plan allows participants who have attained age 50 before the end of the Plan year to make additional catch-up contributions up to a maximum of \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans as rollover contributions, except those balances designated as after-tax employee contributions.

The Company may, at its discretion, elect to make a matching contribution to the Plan on behalf of eligible participants or a designated group of eligible participants. For the year ended December 31, 2024, the Company matched 40% of the first 6% of eligible compensation that a participant contributes.

C. **Participant accounts** – Each participant’s account is credited with the participant’s contributions, the Company’s discretionary match contribution, and an allocation of Plan earnings. Allocations of Plan earnings are determined by the percentage that a participant’s account balance bears to the total of all participant account balances in such funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. **Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon, and such amounts are not forfeitable. At the earliest of the following dates, participants are fully vested as to the Company’s discretionary match contributions and earnings thereon:

- Date participant reaches age 65
- Date participant incurs a total disability
- Date of plan termination or elimination of Company matching contributions
- Date of participant’s death

Otherwise, for new plan participants on or after January 1, 2022, those participants are 25% vested after the first year of service and vest an additional 25% each year until fully vested after 4 years of service. For new plan participants prior to January 1, 2022 (“Predecessor Employees”), those participants are 20% vested after the first year of service and vest an additional 20% each year until fully vested after 5 years of service. Employees included in the May 2022 Adesa acquisition from KAR are treated as Predecessor Employees under the plan for vesting purposes.

- E. **Forfeitures** – Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company discretionary match contributions or pay the Plan's administrative expenses. Forfeited non-vested accounts totaled \$982,610 and \$602,568 at December 31, 2024 and 2023, respectively. In 2024, no amount of forfeited non-vested accounts were used to pay the Plan's administrative expenses. The Company discretionary match contributions in 2024 were reduced by \$707,335 by the use of forfeitures.
- F. **Notes receivable from participants** – Participants may borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and may only have one outstanding loan at a time. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. Loans are secured by the vested balance in the participant's account and bear interest at a fixed rate commensurate with prevailing market rates at the time the loan is made as determined by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.
- G. **Distribution of benefits** – On termination of service, hardship, retirement, death, election at age 59½ or termination of the Plan, a participant may elect to receive a lump sum payment not to exceed the value of their vested account balance. Subject to Plan provisions, a participant may also elect to receive installment distributions. Domestic Relations order distributions are also available.
- H. **Plan termination** – Although the Company has not expressed any intention to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan is terminated, participants' accounts shall become 100% vested.
- I. **Administrative expenses** – Certain administrative expenses of the Plan are paid by the Company and are not reimbursed by the Plan.

(2) **Significant accounting policies**

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Management's use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of benefits – Benefits are recorded when paid.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued interest.

Risks and uncertainties – The Plan provide for various investment fund options, which in turn invest in any combination of stocks, bonds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent events – The Plan's management has evaluated subsequent events through October 15, 2025, which is the date the financial statements of the Plan were available to be issued, and noted no events.

(3) Information certified by the Plan's trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Plan's trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Total investments
- Notes receivable from participants
- Interest and dividend income on investments
- Interest income on notes receivable from participants
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

(4) Income tax status

The Plan is operating under a prototype plan sponsored by Fidelity Management & Research Company. The prototype plan has received an opinion letter for the Internal Revenue Service dated June 30, 2020, stating that the prototype plan, as designed, is qualified under Section 401(a) of the IRC and, therefore, the plan administrator has determined that the Plan and related trust are exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement dates. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the taxing jurisdictions. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Party-in-interest transactions

Certain Plan investments in mutual funds, money market fund, collective trust fund and the self-directed brokerage accounts are managed by Fidelity Management Trust Company or an affiliate thereof. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions represent party-in-interest transactions.

Certain administrative expenses of the Plan are paid by the Company. The Plan also has notes receivable from participants. Such transactions are permitted under provisions of the Plan and are exempt from the prohibited transaction rules under ERISA.

(6) Fair value measurements

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or collaborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the net asset value (“NAV”) of shares held by the Plan at year end, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Collective trust fund (stable value fund): The Morley Stable Value Fund is valued at the NAV of units of a bank collective trust. The NAV, as provided by the fund’s trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The fund, held in a collective trust, does not have any unfunded commitments relating to its investments. Participant-directed redemptions and exchanges can be made on any business day and do not have a redemption notice period.

Self-directed brokerage accounts: The self-directed brokerage accounts consist of common stocks, mutual funds, and money market fund. Common stocks are stated at fair value, which is based on the closing price reported on the active market which the common stock is traded. Mutual funds and money market fund are valued at the NAV of shares held by the Plan at year end, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As a result, excess participant contributions plus earnings thereon are recorded as a liability in the amounts of \$105,656 and \$1,447,898 in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, respectively. The Plan generally reimburses excess contributions to affected participants in the year following the year such contributions were withheld.
