### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Atlas Mechanical, Inc. 401(k)/Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1 - Description of Plan**

The following brief description of Atlas Mechanical, Inc. 401(k)/Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Atlas Mechanical, Inc. (the Company). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan.

**Eligibility**

Employees not covered under a collective bargaining arrangement and who are not non-resident aliens are immediately eligible to participate as there are no age or service requirements in the deferral provisions of the Plan. To be eligible for the discretionary matching contribution provisions of the Plan, an employee must be actively employed on the last day of the year and they must attain at least 1,000 hours of service in an eligibility computation period.

**Entry Date**

Effective January 1, 2024, via a retroactive amendment dated March 14, 2025, employees may enter the Plan immediately upon hire.

**Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company may make discretionary matching contributions. The Company made \$65,000 in discretionary matching contributions for the year ended December 31, 2024. Additional discretionary non-elective contributions are also allowed at the discretion of the Company's board of directors. No such additional discretionary non-elective contributions were made for the year ended December 31, 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at an auto escalating rate starting at 5%, which will increase 1% annually up to a maximum of 10% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company matching contributions, as well as allocations of the Company discretionary contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon, as well as any employer contributions.

**Forfeitures**

At December 31, 2024 and 2023, there were no significant forfeited non-vested account balances. During the year ended December 31, 2024, no forfeited non-vested accounts were used.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The interest rate, determined at loan inception, is set at 1% above the prime rate. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the note term may not exceed 15 years. A participant may have no more than two outstanding notes at any one time.

**Payment of Benefits**

Participants will receive a lump-sum amount equal to the value of their vested interest as defined in the Plan document upon retirement, termination of service, death or disability. A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$7,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions, with some limitations, may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

## **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan Sponsors determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings (losses) reported in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

Participant contributions are recorded in the year in which the employee contributions are withheld from compensation. Company matching contributions are recorded at year end as a receivable and allocated to eligible participants subsequent to year end.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivables are recorded as distributions based upon the terms of the Plan documents.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan Sponsor has evaluated subsequent events through February 24, 2026, the date which the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust – Valued at fair value based on the NAV of units held of the collective fund. The NAV, as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### Note 4 - Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, Empower), the custodian of the Plan.

#### Note 5 - Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract (GIC) with Great-West Life & Annuity Insurance Company (Great-West). Great-West maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. Either party to the contract may, upon thirty days advance written notice to the other party, declare a contract termination date which shall be any date on or after the expiration of the thirty-day notification period. Because the GIC is fully benefit-responsive, contract value is the relevant measure for the GIC, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by EAIC represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023, was \$70,499 and \$70,320, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**Note 6 - Tax Status**

The Plan uses a pre-approved Plan document sponsored by Empower Retirement, LLC, which received an opinion letter from the Internal Revenue Service (IRS), dated November 14, 2022, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Party-in-Interest Transactions**

Certain Plan investments consist of fixed annuity investment funds managed by Empower, the custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 - Delinquent Participant Contributions**

During 2024 and 2023, the Company failed to remit to the Plan's trustee certain employee contributions totaling approximately \$5,900 within the period prescribed by DOL regulations. Delays in remitting contributions to the trustee were due to administrative errors, and the Company has or will make contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delay.

Professional standards require that we advise you of the following information related to our audit.

### **Our Responsibility in Relation to the Financial Statement Audit**

As communicated in our discussion May 28, 2025 our responsibility, as described by professional standards is to conduct our audit in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution). For an ERISA Section 103(a)(3)(C) audit, the audit will not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirement of accounting principles generally accepted in the United States of America (GAAP). ### **Compliance with All Ethics Requirements Regarding Independence**

The engagement team, others in our firm, as appropriate, our firm, and our network firms, have complied with all relevant ethical requirements regarding independence.

### **Qualitative Aspects of the Plan's Significant Accounting Practices**

#### *Significant Accounting Policies*

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note 2 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

#### *Accounting Estimates and Related Disclosures*

Accounting estimates and related disclosures are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments.

No such estimates were identified for this plan.

#### *Financial Statement Disclosures*

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. There were no financial statement disclosures that we consider to be particularly sensitive or involve significant judgment.

### **Form 5500 Procedures**

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### **Significant Difficulties Encountered during the Audit**

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

### **Uncorrected and Corrected Misstatements**

For purposes of this communication, professional standards also require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. Uncorrected misstatements or matters underlying those uncorrected misstatements could potentially cause future-period financial statements to be materially misstated, even though the uncorrected misstatements are immaterial to the financial statements currently under audit. There were no uncorrected misstatements identified as a result of our audit procedures.

In some cases, management may decide to consult with other accountants about auditing and accounting matters. Management informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

## **Other Significant Matters, Findings, or Issues**

In the normal course of our professional association with the Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the year, business conditions affecting the plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.

## **Other Matters**

- a. An identified instance of noncompliance or suspected noncompliance with laws or regulations.
- b. A finding arising from the audit that is, in the auditor's professional judgment, significant and relevant to those charged with governance regarding their responsibility to oversee the financial reporting process.
- c. An indication of deficiencies in internal control identified during the audit that have not been communicated to management by other parties and that, in the auditor's professional judgment, are of sufficient importance to merit management's attention.

A reportable finding may be a material weakness, a significant deficiency, or a control deficiency defined as follows:

A material weakness is a deficiency, or a combination of deficiencies, in internal control over financial reporting, such that there is a reasonable possibility that a material misstatement of the plan's financial statements will not be prevented or detected and corrected on a timely basis. A reasonable possibility exists when the likelihood of an event occurring is either reasonably possible or probable as defined as follows:

- *Reasonably possible.* The chance of the future event or events occurring is more than remote but less than likely.
- *Probable.* The future event or events are likely to occur.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control over financial reporting that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

A control deficiency is a deficiency, or combination of deficiencies, in internal control that does not rise to the level of a material weakness or significant deficiency but is of sufficient importance to merit management's attention.

We consider the following reportable findings in the Plan's internal control to be significant deficiencies:

#### **Missed Deferrals**

During the course of the audit, it was discovered that several participants did not have employee contributions totaling \$460 withheld on eligible compensation due to manual checks being run during the year resulting in missed deferrals and related employer discretionary matching contributions. As a result, these participants' account balances are missing contributions and interest is not being earned on these amounts within the accounts. This error could expose the Plan Sponsor to make necessary corrective actions for the Plan to remain in compliance with regulations, and may include corrective contribution on behalf of the participant. Plan management has indicated they plan to correct these account deficiencies including lost earnings. We recommend that Plan management evaluate the procedures surrounding withholdings on the manual check process in order to ensure that deferrals are properly calculated, withheld, and remitted timely.

#### **Timeliness of Remittances**

The Department of Labor (DOL) requires that the Plan sponsor transfer participant contributions to the Plan by the earliest date contributions can be reasonably segregated from the Plan sponsor's general business assets, but in no event later than fifteen business days following the month in which the participant contributions were withheld or received by the Plan sponsor. In tests of the timeliness of remittances of participant contributions, it was discovered that the time taken to remit participant contributions generally ranged from zero to five days following each pay cycle during the current Plan year. During the 2024 audit, we noted that 21 participants who were hired in 2024 did not have their contributions totaling \$3,422 remitted within the stated DOL guidelines. This error could expose the Plan Sponsor to make necessary corrective actions for the Plan to remain in compliance with regulations, and may include corrective contributions on behalf of the participants. Plan management has indicated they plan to remit lost earnings on these late remittances.

The Plan sponsor has indicated that the delayed remittances are due to restrictions imposed by the Plan Custodian not accepting contributions for new employees within the first 30 days of employment. Subsequent to year end, and upon amending the Plan document, the Plan Custodian is now accepting contributions for participants immediately. We recommend that Plan management calculate and remit lost earnings on these late remittances.

### **Plan Entry**

Deferral amounts are being withheld immediately upon hire but are not remitted to the Plan until the following month. Prior to a 2025 amendment that was retroactive to January 1, 2024, the Plan document dictated that Plan entry occurs on the first day of the month following the participant's date of hire due to the Custodian's refusal to allow for immediate entry despite the Plan Sponsor's insistence. Amounts withheld were unable to be remitted to the Plan immediately as the Plan custodian did not allow remittances within the first thirty days of new employee hire in accordance with Plan documents. This resulted in Plan assets being deficient the lost earnings related to the late remittances. Subsequent to year end, the Custodian acquiesced and allowed the Plan sponsor to retroactively amend the Plan document to allow for immediate entry effective January 1, 2024.

### **Misallocation of Contribution into Wrong Participant Account**

During deferral and match testing it was discovered that one participant's account balance was higher than expected. It was determined that this participant had been the recipient of another participant's deferral. Upon discovery by Plan Management in March 2025, Plan Management worked with the Plan Custodian and moved the funds out of the wrong account and into the correct participant account; however, neglected to add lost earnings to the account. As such, the participant's account that was missing the contribution is deficient the earnings that would have accrued if the contribution had been made to the correct participant account. This error could expose the Plan Sponsor to make necessary corrective actions for the Plan to remain in compliance with regulations, and may include corrective contribution on behalf of the participant. We recommend Plan Management calculate and remit lost earnings to the participant whose account was not timely credited with the deferral. Additionally, we recommend that Plan management implement additional review of remittance transmission reports to ensure that contributions are remitted to the proper accounts.

### **Financial Reporting Process**

The financial statements contain complex accounting and reporting matters including many footnote disclosure considerations under generally accepted accounting principles. As auditors, we were requested to draft the financial statements and accompanying footnotes. As such, a more-than-remote likelihood exists that a material misstatement of the financial statements could occur absent our involvement in the financial statement preparation process. This circumstance is not unusual in a plan of your size nor has it changed from prior years. It is the responsibility of management and those charged with governance to make the decision whether to accept the degree of risk associated with this condition because of cost or other considerations.

### **Lack of Review and Approval**

The Company does not have a formal internal control process for the review and approval of Plan activity that includes evidence of approval. The lack of a formal review and approval process resulted in one instance of a participant being included on the census twice. This is because when he entered the Plan, he was entered with the wrong social security number as the submission was not reviewed or approved. The correction of his social security number resulted in a duplicate entry on the census. The oversight provided by an effective review and approval process is important to the Company as a result of the limited segregation of duties that exists due to the size of the accounting staff involved in Plan management. The lack of a formal review and approval process for remittances increases the risk of material misstatement in the financial statements, either due to error or fraud.

We consider the following reportable findings in the plan's internal control to be control deficiencies:

#### **Proper Remittance of Contributions**

During the Plan year, the Plan sponsor discovered that remittances were missed for multiple participants resulting in a deficiency in Plan assets. Upon discovery, the Plan sponsor made a corrective remittances of \$1,494 including lost earnings of \$48. We recommend that Plan management evaluate the procedures surrounding contribution remittances in order to ensure that deferrals are properly calculated and remitted timely.

#### **Plan Number**

During the course of the audit, it was discovered that the Plan number listed on the most recent Plan document is listed as "001" but should instead be listed as "002" to match historical Plan document and Form 5500 reporting. Having the wrong Plan number documented could lead to confusion in recordkeeping and reporting which could impact the Plan's ability to properly administer employee contributions and distributions. We recommend the Plan sponsor have the Plan document updated to reflect the correct Plan number.

#### **Segregation of Duties**

As is true of many smaller business entities, the Plan Sponsor may not be large enough to justify the economic cost and expense of installing an extensive segregation of duties in all phases of its accounting system so as to ensure a perfect system of internal control. The current concentration of closely related duties and responsibilities in a relatively small number of staff may make it difficult or impossible to establish such a perfect system of automatic internal checks so as to absolutely ensure the accuracy and reliability of all accounting records in all areas. The lack of segregation of duties increases the risk of fraud related to misappropriation of assets, financial statement misstatement, or both.

Because we recognize the Plan Sponsor's limitations, and that it may not be cost effective to justify implementing a full segregation of duties for an extensive system of internal control in all areas, we believe it is important that management be aware that some weaknesses may exist and that they should continue to apply diligent oversight and monitoring activities.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be considered reportable findings, including material weaknesses, significant deficiencies, or control deficiencies, and, therefore, reportable findings in these categories may exist that were not identified.
