Opinion

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion of the financial statements as a whole. The supplemental schedule of assets (held at end of year) as of June 30, 2025 (referred to as the “supplemental schedule”) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The National Hockey League Players' Pension Plan (the Plan) is a multi-employer, non-contributory defined contribution plan sponsored by all of the Member Clubs of the National Hockey League (the Member Clubs). The Plan is registered under the *Ontario Pension Benefits Act* (registration number: 0353623). The Plan was amended effective January 19, 2013, as a result of the 2013 collective bargaining agreement between the National Hockey League and the National Hockey League Players' Association (CBA), to provide that no additional Member Club contributions are to be made to the Plan on and after January 19, 2013. No participant contributions are permitted or required.

Players under contract with a Member Club on January 19, 2013, who were participants under this Plan or a participant in the National Hockey League Players U.S. 401(k) Plan and who are affected by the cessation of Member Club contributions as a result of the CBA amendment to the Plan, are fully vested in pension benefits under the Plan derived from Member Club contributions at such date. All other Players are fully vested in their account if they have been credited with an aggregate of 160 regular season games under this Plan and under the U.S. Players' Plan, or if they die while actively employed as a player by a Member Club, or as per applicable legislation. Employment as a non-player by a Member Club is recognized for vesting purposes. To the extent that a former player is still not vested after a five-year break in service, his account is then forfeited and the forfeited amount is used to pay Plan expenses.

Participants can elect to have their accounts invested amongst any of the available investment options.

The Board of Trustees is composed of eight trustees, four of whom are selected by the National Hockey League Players' Association and four of whom are selected by the National Hockey League. The Board of Trustees appointed the National Hockey League Pension Society (the Society) as its Administrative Agent to carry out the day-to-day administration and operations of the Plan.

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to terminate the Plan subject to both the terms of the collective bargaining agreement referred to above and the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA) and the *Pension Benefits Act (Ontario)*. In the event of termination, each participant shall become fully vested.

Participants should refer to the Plan document for a more complete description of the Plan's provisions. The foregoing description of the Plan provides only general information.

2. Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments

Valuation

In accordance with Accounting Standards Codification (ASC) 820, Fair Value Measurements, investments are stated at fair value which is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 3 for discussion of fair value measurements.

Investment Income

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Cash

Cash is held at a TD Bank that earns interest income.

Foreign Currency

The financial statements have been presented in United States dollars. The functional currency of the Plan is Canadian dollars. Accordingly, all assets and liabilities of the Plan, which are denominated in Canadian dollars, are translated at the year-end exchange rate and additions and deductions are translated using the average exchange rate for the year.

Foreign Exchange

Any exchange gains or losses resulting from the translation of the financial statements to U.S. dollars are presented as foreign exchange gain or loss in the Statements of Changes in Net Assets Available for Benefits.

The following exchange rates have been used in the preparation of these financial statements expressed as the Canadian dollar equivalent of one U.S. dollar:

3. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2: Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3: Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan.

Assets of the Plan are managed and administered by Sun Life Assurance Company of Canada (Sun Life). The Plan invests in a group annuity policy which is funded through Plan investments into segregated funds. The segregated funds are funds of assets owned by Sun Life and kept separate from its general fund. Contributions of the Plan are assigned “units” which have no separate legal existence but are means to track the investment participation in the segregated fund, and to determine resulting benefits under the group annuity policy. The underlying assets of the segregated fund are mutual fund trusts or pooled fund trusts. These assets are held solely in the name of Sun Life. Neither the Plan, nor the Plan members, own units of these assets. Sun Life directs the purchases and sales of these underlying assets. Fair value is determined by multiplying closing NAV for the underlying assets multiplied by the number of units held by the Plan, plus/minus cash flow in transit and accrued expenses, divided by the number of assigned “units”. These funds have no redemption restrictions.

The segregated funds were assessed as having a readily determinable fair value at June 30, 2025 and 2024. The Guaranteed Daily Interest Account (GDIA) is issued and backed by Sun Life. The GDIA credits interest on a daily basis. The competitive interest rate is based on similar yield rate in active markets.

4. Administration Expenses

Administration expenses were \$752 and \$697 for the years ended June 30, 2025 and 2024, respectively. Investment and custodial fees are paid for by a reduction in the net asset values of the investment funds made available under the Plan. Subject to the administrative services agreement between the Plan and the Society, and subject to the approval of the Plan's Board of Trustees, the Society gets reimbursed for direct expenses, which were paid by the Society, relating to the administration of the Plan up to the amount of the Plan's forfeitures and sales tax rebates. Any administration expenses in excess of these sources of income to the Plan are charged to the Member Clubs.

5. Due to National Hockey League Pension Society

Amounts due to the National Hockey League Pension Society are non-interest bearing and have no specific payment date.

6. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated December 15, 2016, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code), but the related trust is not exempt having not been created or organized in the United States. Subsequent to this determination by the IRS, the Plan was amended. Once qualified,

the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan is a registered pension plan as defined under both the *Pension Benefits Act* (Ontario) and the *Income Tax Act* (Canada) and the related trust is treated as exempt from taxation if all relevant legislative requirements are met. The Society believes that all such requirements have been met.

7. Party-In-Interest Transactions

Certain of the Plan's assets are invested in funds managed by the recordkeeper of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Contingencies

The Plan purchases annuity contracts for annuity distributions from the Plan. In order to comply with Canadian law requirements, the Plan purchases such annuity contracts from insurance companies licensed in Canada. Under ERISA, the Plan may relieve itself of liability for Plan benefits to the extent it purchases such annuity contracts from insurance companies licensed in the United States. Currently, the Plan is unable to find an insurance company licensed in both Canada and the United States that will satisfy the reporting and withholding requirements for both countries. By using the Canadian insurers, the Plan may be subject to ongoing liability for any unpaid annuitized benefits to annuitants covered by ERISA to the extent the Canadian insurance companies default on such annuity contracts. The insurance companies from which annuity contracts have been purchased are among the largest in Canada and the Society considers the likelihood of such defaults to be remote. Historically, the Plan has not made any such payments, and no amount has been accrued in the financial statements with respect to this potential liability.

10. Subsequent Events

The Society has evaluated subsequent events through January 21, 2026, the date the financial statements were available to be issued.
