### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We were engaged to perform audits of the financial statements of Hospice of Wake County, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Disclaimer of Opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### **Basis for Disclaimer of Opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

### **Other Matter-Supplemental Schedules Required by ERISA**

The supplemental schedules of Schedule H, line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. ## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the Hospice of Wake County, Inc. Retirement Savings Plan (the Plan) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a "Tax Deferred Annuity" or "403(b)" Plan. It was established on January 1, 1991 and restated January 1, 2024. The Plan covers all eligible employees of Hospice of Wake County, Inc, dba Transitions Life Care (the Plan Sponsor and Administrator). The Trustee and recordkeeper of the Plan is Corebridge Financial, Inc.

#### Eligibility

Participants are eligible to participate in the Plan when employed as long as they are 21 years of age. Full time employees become eligible to receive a match after one year of employment. Part time employees become eligible to receive a match after they have worked 1,000 hours during one year of service.

#### Contributions

Participants may make pre-tax or Roth contributions from their eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor contributions are discretionary, and for 2024 and 2023 they contributed 4% to all eligible employees.

Participants are automatically enrolled in an elective deferral contribution of 3% of compensation, unless the participant affirmatively elects a different percentage or elects not to make an elective deferral contribution. This percentage is automatically increased on or after each January 1 by 1% up to a maximum of 6%.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contribution, if any, and (b) Plan earnings, and charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes to the Financial Statements, continued

#### 1. Description of the Plan, continued

##### Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus earnings thereon is based on years of continuous service. Plan Sponsor discretionary contributions, if any, and earnings thereon are subject to a five-year graded vesting schedule based on the years of credited service. A participant vests according to this schedule for each calendar year in which the participant has worked at least 1,000 hours. A participant also becomes 100% vested if he or she attains age 65 while still employed by the Plan Sponsor, becomes permanently disabled, or dies.

##### Investment Options

Upon enrollment in the Plan, a participant may self-direct contributions into any of the wide array of investment options selected by the plan administrator. Participants may change their investment options at any time and all contributions are invested in assets as determined by the participant.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balances, less any outstanding loans, whichever is less. Loans made to married participants must have a signed Qualified Spousal Election obtained within the 90-day period ending on the date the loan is granted. Loans are secured by the participant's pledge of the vested portion of their account and bear interest at rates ranging from 2.75% to 9.50%, which were commensurate with local prevailing rates as determined by the plan administrator. Generally, loan terms are limited to five years, unless the proceeds are used to acquire a home that will be the primary residence of the participant. All interest paid in connection with the loan and all repayments of principal are credited to the participant's account. All loans may be prepaid at any time without penalty. Principal and interest are paid ratably with quarterly payments.

##### Payment of Benefits

On termination of service due to disability or retirement, a participant will normally be paid in the form of a qualified joint and survivor annuity over the life expectancies of the employee and spouse. If a qualified election to waive the qualified joint and survivor annuity is made, the participant shall be entitled to receive distributions under payout options that may be provided under his annuity contract. Rollovers to other plans are also available. Death benefits are paid out no later than ninety days following the later of the close of the Plan year within which the participant dies or the close of the Plan year in which the request is received. Participants may elect to roll over distributions to other qualified plans or to individual retirement accounts. Hardship withdrawals are permitted and in-service distributions after the Participant attains age 59½ are permitted.

### 1. Description of the Plan, continued

#### Forfeited Accounts

Forfeitures can be used to offset future employer matching contributions or administrative expenses of the Plan. Forfeitures available to offset these costs were \$40,344 and \$52,769 as of December 31, 2024 and 2023, respectively. Forfeitures of \$59,344 were used to reduce employer matching contributions for the year ended December 31, 2024.

#### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### Administrative Expenses

The Plan is responsible for its administrative expenses unless paid by the Plan Sponsor.

### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently applied by the Plan in the preparation of its financial statements:

#### Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on investments as well as from notes receivable from participants is recorded as earned on the accrual basis. The net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

#### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses had been recorded, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balance. If a participant does not make loan payments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan adoption agreement.

#### Payment of Benefits

Benefit payments to participants are recorded when paid.

#### Subsequent Events

Subsequent events have been evaluated for accounting and disclosure requirements through February 11, 2026, the date the financial statements were available to be issued.

### 3. Information Prepared and Certified by Custodians

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by The Variable Annuity Life Insurance Company and VALIC Trust Company Inc (VALIC), the custodians of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodians that asset information provided to the Plan Administrator by the custodians related to the asset information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedules.

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Fair Value Measurements, continued

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

#### 5. Investments

The Plan invests in guaranteed investment contracts and mutual funds with VALIC. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and expenses. The mutual funds are stated at quoted market prices.

#### 6. Guaranteed Investment Contract with Insurance Company

The Plan entered has a traditional fully benefit-responsive investment contract with VALIC. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$2,350,554 and \$3,090,346 at December 31, 2024 and 2023 respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the Plan's ability to transact at contract value with VALIC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact or contract value with Plan participants or the issuer are probable of occurring.

#### **6. Guaranteed Investment Contract with Insurance Company, continued**

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **7. Exempt Party-In-Interest Transactions**

Plan investments are managed by VALIC and therefore qualify as party-in-interest transactions. The Plan participants paid investment and loan fees of \$55,026, for the year ended December 31, 2024.

#### **8. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances, including employer contributions.

#### **9. Income Tax Status**

The Plan obtained the latest determination dated April 5, 2018, in which the Internal Revenue Service stated that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### **10. Prohibited Transactions**

During the year ended December 31, 2024, participant withholdings in the amount of \$125,455 were not remitted within the appropriate time period by the Plan Sponsor. These transactions constitute a prohibited transaction as defined by ERISA. The Plan Sponsor is aware of the occurrences and has taken the appropriate steps to correct the situation by implementing procedures to ensure all future remittances are completed within the prescribed time period.
