## 1. DESCRIPTION OF PLAN

The following description of the Cameron Regional Medical Center, Inc. Employee Health Care Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

### General

The Plan was established by Cameron Regional Medical Center, Inc. (the "Employer"), to provide medical income benefits (medical and prescription drug) for all full-time eligible employees. Eligible employees are regular full-time, active employees of the Employer working 30 or more hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

### Benefits

The Plan is self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims administrator, who pays claims directly to, or on behalf of, participants after they have satisfactorily complied with the claim procedures as described in the plan document. Benefits are paid to an eligible employee after he or she has satisfactorily complied with the claim procedures as described in the plan document.

### Contributions

The Plan is funded by contributions from the participants and the Employer. Participants contribute specified amounts based on their respective elections and applicable premiums, which are determined at the beginning of each plan year. The Employer periodically contributes amounts to the Plan in excess of employee contributions to fund approved claims for benefits, premiums due on stop-loss insurance contracts, and administrative expenses.

### Plan Termination

Under certain conditions, the Plan may be terminated. Upon termination, the assets then remaining shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement.

### Administrative Expense

The Employer absorbs significant costs of plan administration.

### Other

The Plan has unlimited specific stop-loss coverage for claims in excess of \$225,000 per person for the policy year. The insurance provider pays all claims in excess of this amount. The Plan has a maximum annual aggregate stop-loss limit of \$1,000,000.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Plan Benefit Obligations

Plan obligations for claims incurred but not reported are estimated based on claims data provided by the Plan's third-party claims administrator.

### Tax Status

The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan is qualified.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require disclosure in the accompanying financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial

statements through the date the financial statements are available to be issued, which is February 23, 2026.

### 3. COBRA RECEIPTS

Under the Comprehensive Omnibus Budget Reconciliation Act of 1986, employees who are enrolled in the Plan have the option of continuing their coverage at their own expense in certain cases when normally the coverage would cease. COBRA receipts are from former employees who qualify for continued coverage and have opted for continued coverage through the Plan.

### 4. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Professional fees were paid by the Employer and the majority of other administrative expenses of the Plan were paid by the Plan.

Blue Cross Blue Shield of Kansas City, Inc. is the third party administrator of the Plan and receives payment from the Plan for these services. Stealth Partner Group is the provider of the stop-loss insurance coverage for the Plan and receives payment from the Plan for these services. Blue & Co., LLC is the independent auditor of the Plan and receives payment from the Employer for these services.
