## Independent Auditor's Report

The Retirement Trustee Board and Plan Participants  
Fort McDowell Yavapai Nation Retirement Plan and Trust 401(k)

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Fort McDowell Yavapai Nation Retirement Plan and Trust 401(k) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for twelve months beyond the financial statement date, including any currently known information that may raise substantial doubt shortly thereafter.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Other Matter—Required Supplementary Information***

Management has omitted management's discussion and analysis that accounting principles generally accepted in the United States of America requires to be presented to supplement the basic financial statements. Such missing information, although not part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of the financial reporting for placing the basic financial statements in an appropriate operational, economic or historical context. Our opinion on the basic financial statements is not affected by the missing information.

***Other Matter—Supplemental Schedules Required by ERISA***

The supplemental schedule of Schedule H, Part IV, Line 4i – schedule of assets held at end of year as of December 31, 2024, and the supplemental schedule of Schedule H, Part IV, Line 4a – schedule of delinquent participant contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **1) Description of Plan and Significant Accounting Policies**

The following description of the Fort McDowell Yavapai Nation Retirement Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

### General

The Plan has been established by the Fort McDowell Yavapai Nation (the “Nation”) and operates under the authority of the Retirement Trustee Board, as delegated by Tribal Council. The Plan, which commenced on October 1, 1998, is a defined contribution plan covering all full-time employees of the Fort McDowell Yavapai Nation (the “Employer”) who have completed six months of service and have attained age 18 as well as long-term part-time employees as defined by the Plan. Participation commences on the entry date (monthly) after meeting eligibility requirements. Employees are eligible to receive Employer contributions once they have completed one year of service and have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2007, the Plan became subject to the provisions of Section 906 of the Pension Protection Act of 2006 (PPA). Although the Nation maintains that the Plan continues to be entitled to governmental status following the passage of the PPA, the Nation is operating this as a nongovernmental plan effective January 1, 2007, pending further guidance from the U.S. Departments of Treasury and Labor. The Nation is operating the Plan in accordance with its reasonable and good faith interpretation of the PPA, as required by IRS Notice 2006-89 and IRS Notice 2007-67. As of December 31, 2024 and 2023, there were a total of 1,387 and 1,441 participants, 1,134 and 1,102 of which had account balances, respectively.

### Contributions

Each year, participants may contribute annual pretax compensation, as defined by the Plan as well as after tax Roth contributions, limited to the annual statutory maximum as determined by the Internal Revenue Code. Additional catch-up contributions may be made by participants who have attained age 50 before the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan. Automatically enrolled participants have their deferral rate initially set at four percent of eligible compensation unless the participant elects a different percent or affirmatively opts out of the Plan.

Each year, the Employer may elect to make a basic matching contribution or a safe harbor matching contribution. For the Plan years ended December 31, 2024 and 2023, the Employer elected to make a safe harbor matching contribution equal to 100% of an employee’s elective contributions to the extent such elective contributions did not exceed 5% of the employee’s eligible compensation.

In addition, the Employer may elect to make a discretionary non-elective contribution. The Employer did not elect to make any basic contributions or a discretionary non-elective contributions to the Plan for the years ended December 31, 2024 and 2023. The Plan administrator may, at its sole discretion, choose to not make the safe harbor contribution available to certain “non-highly compensated employees.”

### Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer contributions, and allocations of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions, plus actual earnings thereon. Participants vest in basic matching contributions based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Interest</u>
1	0%
2	25%
3	50%
4	75%
5	100%

Notwithstanding the above, a participant shall become fully vested upon reaching normal retirement age, death, or permanent disability.

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account. The maximum loan period is five years unless for the purpose of acquiring a principal residence. Loan interest rates are determined by the Plan administrator by reviewing interest rates charged for similar types of loans by other lenders, which ranged from 4.25% to 9.50% during 2024 and 2023. Principal and interest is repaid ratably through payroll deductions.

### Payment of Benefits

Upon termination of service due to death, disability, retirement, or any other reason, a participant may elect to receive the value of the participant’s vested interest in their account in the form of either a lump-sum amount or an annuity. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions.

## Mandatory Cash-Out

If the amount of the participant's vested account balance to be distributed exceeds \$1,000 but is less than or equal to \$7,000 and the participant fails to timely elect a lump sum payment or direct rollover to a participant designated IRA, then the Plan administrator will roll the entire vested balance to an IRA established by the Plan administrator at a qualified institution. Vested account balances of less than \$1,000 are distributed in cash directly to the participant without the participant's consent.

## Forfeitures

Forfeitures of terminated participants' nonvested account balances may be used first to pay administrative costs of the Plan, and/or to restore previously forfeited participant account balances. Any remaining forfeitures may be used to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$35,842 and \$31,265, respectively. There were no administrative fees paid from forfeited nonvested accounts in 2024 and 2023.

## 2) **Summary of Significant Accounting Policies**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting based on the accounting standards as promulgated by the Governmental Accounting Standards Board.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related loan fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the Plan document.

## Payment of Benefits

Benefits are recorded when paid.

## Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. At any time, the employer may elect for the Plan to pay administration costs. Fees paid by the Plan for investment management are included in net appreciation (depreciation) in fair value of investments.

## Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through February 24, 2026, the date the financial statements were available to be issued.

### **3) Investments and Fair Value Measurements**

The Governmental Accounting Standards Board (GASB) Statement No. 72, *Fair Value Measurements and Applications*, provides the framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Fund.* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5) Plan Termination**

Although it has not expressed any intent to do so, the Employer, as the Plan's sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA provisions. In the event of the Plan termination, participants would become 100% vested in all their Employer contributions.

## **6) Tax Status**

The IRS has determined and informed the Nation by a letter dated July 12, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's management believes the Plan is no longer subject to income tax examinations for years prior to 2021.

## **7) Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity Management Trust Company, which serves as the Trustee of the Plan's investments. These transactions qualify as exempt party-in-interest transactions under ERISA. The Employer provides certain accounting and administrative services to the Plan for which no fees are charged.

For the years ended December 31, 2024 and 2023, fees paid by the Plan for administrative expenses, totaled \$195,280 and \$159,269, respectively. These fees include third-party administrative fees, loan fees, participant fees, and overnight fees.
