**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Capital Hospice (the Company) 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan originally effective June 1, 1993. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective September 1, 2019. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan administrator is responsible for the oversight of the Plan, determining the appropriate of the Plan's investment offerings and monitoring investment performance.

Eligibility: All employees are eligible to participate in the salary reduction arrangement in the Plan on the date their employment begins. All employees are eligible to participate in Company matching contributions after attaining age 21 and completion of 1 year of service. Employees can receive company contributions each paycheck following completion of eligibility.

Contributions: The Plan includes a salary deferral arrangement allowed under Section 403(b) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may, at its discretion, elect to make a qualified matching or profit sharing contributions to the Plan. For the years ended January 1, 2024 and December 31, 2023, the Company's matching contribution was 100% of participant deferrals up to 1% of the employee's eligible compensation. There were no discretionary profit sharing contributions for the years ended January 1, 2024 and December 31, 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRC limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's matching and profit sharing contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and their distributions. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company matching and profit sharing contribution portions of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after four years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

If the participant terminates for any other reason, they will be vested in nonelective contributions according to the following vesting schedule.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest comparable to the interest rate charged by similar commercial notes and are determined by the Plan administrator. Principal and interest is paid ratably through payroll deduction.

Benefit Payments: Upon termination of service, death, disability, or retirement, the participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions.

Forfeited Accounts: Forfeited nonvested accounts are used to reduce future Company contributions. Forfeited nonvested accounts as of January 1, 2024 and December 31, 2023 totaled \$0 and \$143,098, respectively.

Plan Merger: On January 1, 2024, the Plan was merged into Chapters Health System, Inc. Retirement Plan ("Chapters 403(b) Plan"), in accordance with ERISA §208 and IRC §414(l). In connection with the merger, all assets and participant account balances were transferred to Chapters 403(b) Plan.

Following the merger, the Plan ceased to exist as a separate reporting entity and, accordingly, these financial statements represent the final reporting period for the Plan. The Form 5500 for the year ended January 1, 2024 will be filed as a final return.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, other than the fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Administrative Expenses: The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements.

Benefit Payments: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of January 1, 2024 and December 31, 2023.

**NOTE 3 – 2023 CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying 2023 financial statements, including investments and notes receivable from participants held at December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”), Empower Annuity Insurance Company of America (“Empower”), and Mutual of America Life Insurance Company (“MOA”).

**NOTE 4 – FAIR VALUE OF INVESTMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Variable Annuities:* Variable annuities are valued based on prices or unit values for variable annuity investment options calculated by the annuity providers according to the methods described in the annuity contracts. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factors disclosed in the annuity contracts.

*Separate Account Funds:* Separate account funds value investments at fair value in accordance with U.S. GAAP. Fair value is an estimate of the price the separate account would receive upon selling a security in an orderly, arm’s-length transaction. Separate account investments consist solely of investments in mutual funds registered with the SEC and are carried at the net asset value at which the mutual fund shares are actively traded.

**NOTE 4 – FAIR VALUE OF INVESTMENTS (Continued)**

*Non Benefit-Responsive Investment Contracts:* The fair value of the contract has been determined to approximate contract value, based upon its lack of contractual maturities, the frequency of the re-setting of contractual interest rates to market rates, participant transactions typically being executed at contract value, and the credit quality of the issuer (level 3 inputs). Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

**NOTE 5 – TRADITIONAL FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT WITH PRINCIPAL**

The Plan held a traditional fully benefit-responsive investment contract with Principal Life Insurance Company (“Issuer”) that was reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

The Issuer maintained the contributions in its general account. The Issuer guaranteed the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than the guaranteed minimum interest rate, as shown on the contract specifications. The Issuer’s general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

**NOTE 5 – TRADITIONAL FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT WITH PRINCIPAL** (Continued)

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances, which would allow the Issuer to terminate the contract, include the Plan's uncured material breaches of responsibilities, misrepresentation of material information and the issuer discontinuing offering the contract to the public. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value.

As a result of the plan merger disclosed in Note 1, the investment contract with Principal was no longer fully benefit responsive as of December 31, 2023.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 – INCOME TAX STATUS**

The Internal Revenue Service issued an opinion letter dated March 31, 2017 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirement of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 1, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**NOTE 8 – PARTY IN INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. As of January 1, 2024 and 2023, the Plan is invested in a non benefit-responsive investment contract issued by Principal. Therefore, these transactions in such investments and the Plan's payment of trustee fees, record keeping fees, and investment management fees to Principal, Empower, and MOA qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 9 – DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the years ended December 31, 2023 and 2022, certain participant contributions were not remitted to the Plan within the time frame specified by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. These delinquent contributions have been reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions.

**NOTE 10 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through February 6, 2026, which is the date the financial statements were available to be issued.
