Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Butler County Children's Center, Inc. Employee Savings Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended June 30, 2025 and 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the

information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. 1. Plan Description

The following brief description of the Butler County Children's Center, Inc. (Company) Employee Savings Trust (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a qualified, defined contribution plan covering substantially all employees of the Company. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees become eligible participants once they reach 21 years of age and have completed one year of service, which is defined as 1,000 hours of service. Employees may enter the Plan on the first day of the Plan year or the first day of the seventh month of the Plan year.

Contributions

Participants may contribute, pre-tax or post-tax (Roth), a portion of their compensation from one percent up to a maximum allowable by the Plan document and in accordance with other limiting provisions of the Internal Revenue Code (Code) and other applicable legal limits. The Company contributes a discretionary contribution of 3% of the first \$10,100 of participant eligible compensation and 6% of eligible compensation in excess of \$10,100. The Company may designate all or a portion of its contributions as a qualified non-elective contribution, which is not subject to a vesting schedule.

Participant Accounts

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, and plan earnings (losses), and charged with an allocation of

any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants in the Plan are vested immediately in their contributions, qualified non-elective contributions, and actual earnings thereon. Employer contributions vest ratably over a five-year period based upon years of service. The vesting schedule is as follows:

Benefit Payments

Plan benefits are generally paid to participants at retirement, death, or disability. Normal retirement is at age 65; however, a participant is entitled to 100% of their account upon retirement at their early retirement age. The early retirement age is defined as age 55 or upon completing the 15th anniversary of Plan participation.

Participants or their beneficiaries may elect to receive retirement distributions as a single lump-sum payment or in monthly, quarterly, or annual installments over their remaining life expectancy. Participant account balances that do not exceed \$5,000 are distributed in a single lump-sum payment.

Hardship withdrawals may be made for eligible purposes as defined by the Plan and applicable federal regulations.

Forfeitures

Participant account balances which are not 100 percent vested upon termination of service are forfeited. Forfeitures may be used to reduce Plan expenses or used to reduce the

employer's contributions to the Plan. During the Plan years ended June 30, 2025 and 2024, forfeitures were not used to reduce plan expenses or reduce employer contributions. As of June 30, 2025 and 2024, forfeited nonvested accounts totaled \$10,548 and \$8,001, respectively.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. For all investments held, the custodian, Ameritas Life Insurance Company (Ameritas), calculates a daily unit value, based on either the daily credited interest rate (Ameritas Guaranteed Account) or the underlying market value of investments (pooled separate account). The value of a participant's fund balance is equal to the daily unit value multiplied by the number of units accumulated.

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

The cost of investments sold, distributed, or forfeited is determined using the specific identification method. Investment purchases and sales are accounted for on a trade-date basis. Interest and dividend income are recorded on the accrual basis.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation in fair values of investments. Fees related to the administration of participant distributions are charged directly to the participant's account.

Notes Receivable from Participants

Notes receivable from participants are not permitted in the Plan.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions payable as of June 30, 2025 and 2024 were \$0 and \$4,764, respectively.

Benefit Payments

Benefit payments are recorded when paid. There were no benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of June 30, 2025 and 2024.

Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

3. Interest in Investment Contract

The Plan has a deposit contract with Ameritas in which funds are maintained in a general account. The general account, Ameritas Guaranteed Account, received a minimum interest rate of 3.69% and 4.22% as of June 30, 2025 and 2024, respectively. The general account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Ameritas. The contract, which is fully benefit-responsive, is included in the financial statements at contract value. The contract value of the investment contract at June 30, 2025 and 2024 was \$727,987 and \$687,529, respectively.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the plan net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by Ameritas, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. If the contract is surrendered completely, a market value adjustment may be applied to the balance in the

general account. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (3) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants is probable.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Fair values for Level 1 investments are determined by reference to unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access. Fair values for Level 2 investments are determined by reference to quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 investments have significant unobservable inputs, as they trade infrequently or not at all.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimized the use of unobservable inputs. The Plan held no assets measured under the fair value hierarchy for the years ended June 30, 2025 and 2024.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The underlying assets of the Ameritas Separate Account G are record-kept using unit values and are invested in mutual funds and money market funds at net asset value per share as determined by investment managers under the so-called “practical expedient.” The practical expedient allows net asset value per share to represent the fair value for reporting purposes when the criteria for using this method are met. The pooled separate account consists of money market funds and mutual funds that are actively traded and easily redeemed at the request of participants. Interests in the pooled separate account can be redeemed at net asset value as of the measurement date and on a daily basis. There are no participant redemption restrictions for these investments. As the Ameritas Separate Account G offers a diverse portfolio of investments, the investment strategies of the underlying funds vary between each individual investment and can range from conservative allocations to aggressive allocations.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of the future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Information Certified by the Plan's Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2025 and 2024, and the net appreciation (depreciation) in fair value of investments and dividends and interest for the years ended June 30, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ameritas, the custodian of the Plan.

6. Related Party and Party-in-Interest Transactions

Recordkeeping and administrative services for the Plan are performed by Ameritas. As transaction fees and other fees are paid to Ameritas, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Administration fees paid by the Plan amounted to \$33,911 and \$23,051 for the years ended June 30, 2025 and 2024, respectively. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

7. Plan Termination

Although the Company has not expressed any intent to do so, it reserves the right to amend, modify, suspend, or terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants would become 100% vested in their accounts.

8. Income Tax Status

The Plan is a non-standardized Pre-approved plan. The Pre-approved plan received an opinion letter from the Internal Revenue Service on June 30, 2020 that stated that the Plan and related Trust are designed in accordance with applicable sections of the Code. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Further, the Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

9. Risks and Uncertainties

The Plan’s investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in the near-term could materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
