## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of American Academy of Pediatrics Employees' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

June 30, 2025 and 2024

### Note 1 - Plan Description

The following description of American Academy of Pediatrics Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of American Academy of Pediatrics (the "Academy"). Leased employees are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary 401(k) contributions up to the maximum tax-deferred limitations established by the Internal Revenue Code (IRC). The Plan also provides for participants to designate all or a portion of their contributions as Roth 401(k) contributions, which are after-tax contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching contributions of at least 100 percent of the first 3 percent of compensation deferred by the participant and an additional 50 percent of compensation deferred by the participant between 4 percent and 6 percent of the participant's compensation.

An additional employer discretionary profit-sharing contribution may be made to the Plan. For 2025 and 2024, the Academy made a discretionary contribution of 3.5 and 7 percent, respectively, of eligible compensation (as defined by the Plan) to all eligible participants in the Plan. The Plan is integrated with Social Security, and an additional discretionary contribution equal to 3.5 and 5.7 percent in 2025 and 2024, respectively, of compensation in excess of the Social Security taxable wage base (excess compensation) was made to the Plan. Participants who have completed one year of service, work at least 1,000 hours during the plan year, and continue employment through June 30 will be eligible to receive an allocation of the employer discretionary profit-sharing contribution. All contributions are subject to certain limitations imposed by the IRC, ERISA, and other regulators.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Academy's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Participants are also fully vested if employed with the Academy upon reaching age 65 or for reasons due to death or permanent disability. Vesting in the Academy's contribution portion of their accounts, plus actual earnings thereon, is based on years of service in accordance with the following table:

### Note 1 - Plan Description (Continued)

#### ***Payment of Benefits***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum or partial amount equal to all or a portion of the vested balance of a participant's account. Annuity form of payment, with options for spousal rights, is allowable only if the participants' interest in the Plan is attributable to transferred pension assets. Participants actively employed by the Academy who are 100 percent vested and have reached age 65 may elect to receive an in-service distribution of all or a portion of their account balances.

Participants actively employed by the Academy may request that all or a portion of their accounts be distributed in the case of qualifying financial hardship, as defined in the plan document.

Participants may also withdraw any part of their vested balances if such distribution meets the requirements of a qualified reservist distribution.

#### ***Redemption Restrictions***

The Minnesota Life Insurance Company unallocated contract has limits on the ability of the participants to transfer from the fund. A participant may transfer, out of the general account, up to 20 percent of the participant's general account accumulation or \$2,000, whichever is greater, once during any 12-month period.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future academy contributions. At June 30, 2025 and 2024, forfeited account balances totaled \$162,428 and \$177,429, respectively. In September 2025, employer discretionary profit-sharing contributions were reduced by \$174,175 due to forfeited nonvested accounts.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are equal to the prime rate plus 1.5 percent, as determined by the third-party administrator. Principal and interest are paid ratably through periodic payroll deductions.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Minnesota Life Insurance Company or its affiliates. Minnesota Life Insurance Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Academy has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value. The unallocated contract is not considered benefit responsive and is presented at fair value. The unallocated contract invests in the general assets of Minnesota Life Insurance Company; however, since there are no specific securities in Minnesota Life Insurance Company's general account related to this contract and due to the contract terms, including the frequency of the interest rate reset intervals, contract value approximates fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. See Note 4 for additional information.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Academy.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including February 18, 2026, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Minnesota Life Insurance Company (the "Custodian") holds the Plan's investments and executes all transactions. The balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
