Notes to Financial Statements

Note 1: Description of Plan

The following description of Good Shepherd Services, Ltd. 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed, defined contribution plan that operates under Section 403(b) of the Internal Revenue Code (IRC) covering all employees of Good Shepherd Services, Ltd. (the "Sponsor"). Employees can participate in the Plan as soon as administratively feasible following employment at the Sponsor. The investment committee of the Sponsor determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

In December 2024, the Plan's recordkeeper was changed from Definiti to The Retirement Advantage (TRA) and the Plan's Custodian was changed from Nationwide Trust Company, FSB ("Nationwide") to Voya Retirement Insurance and Annuity Company ("Voya").

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants with fifteen years of service may also make a special long service catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also allows for Roth contributions. Effective January 1, 2024, the plan document was restated to include an auto-enrollment provision whereby all employees hired on or after January 1, 2025 who have not made an affirmative deferral election will be automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants will have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. For those participants automatically enrolled, the Plan has an auto-escalation rate of 1% on the first day of each subsequent plan year until a deferral rate of 10% is reached.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Contributions (Continued)

The Sponsor may contribute a discretionary matching contribution to eligible participants, as defined in the plan document, equal to 25% of the first 4% of eligible compensation that a participant contributes to the Plan, including catch-up and Roth contributions. Rollovers are not matched. The Sponsor's discretionary matching contribution was \$35,946 for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participants' account is credited with the participant's contribution, Sponsor discretionary matching contributions, and allocations of plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferrals, rollover contributions, and the Sponsor's discretionary matching contributions, plus actual earnings (losses) thereon.

Payment of Benefits

On termination of service, if a participant's vested balance exceeds \$5,000, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a series of installment payments. If the participant's vested account balance does not exceed \$5,000, the Plan will distribute that portion in a lump-sum as soon as administratively feasible after the participant terminates employment with the Sponsor. Effective January 1, 2024, the Plan permits qualified birth or adoption distributions. In addition, hardship distributions out of the participant's voluntary contributions account along with earnings are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract (FBRIC)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and insurance companies. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, and all other expenses incurred in conjunction with the Plan are paid by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Voya fixed account: Fair value is equal to contract value plus any market value and surrender charge adjustments upon termination of the contract. This contract is not considered fully benefit-responsive. At December 31, 2024, fair value approximates contract value.

The fixed account is reported at contract value, which approximates fair value. Contract value represents the aggregation of contributions, plus interest, less withdrawals, if any. This investment is considered a Level 3 investment because none of the parameters for calculating fair value are available publicly. Disclosure of unobservable inputs to the fair value measurement has not been included for the investment because quantitative and observable inputs are not developed by the Plan when measuring fair value and have not been made available to the Plan by Voya.

Note 4: Fully Benefit-Responsive Investment Contract

The Plan has entered into a fully benefit-responsive investment contract with Symetra Life Insurance Company ("Symetra"). Symetra maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The general account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Symetra, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and FBRIC held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Symetra Life Insurance Company ("Symetra") as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and by Voya as of December 31, 2024, and for the period from December 23, 2024 to December 31, 2024, and Nationwide as of December 31, 2023, and for the period from January 1, 2024 to December 23, 2024, the Custodians of the Plan.

Note 6: Party-in-Interest Transactions

Certain plan investments were managed by Symetra, Voya, and Nationwide, the Custodians, as defined by the Plan. These transactions qualify as party-in-interest transactions and are not considered prohibited transactions under ERISA. Fees paid by the Plan for investment management services during the year ended December 31, 2024, were offset against earnings. Specific detail for management fees is not available from the Custodians.

The Plan also paid fees for administrative services to Definiti and TRA for the year ended December 31, 2024, which also qualify as party-in-interest transactions that are not considered prohibited transactions under ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8: Tax Status

The Sponsor adopted a volume submitter 403(b) plan with an IRS opinion letter which states the form of the plan adopted is in compliance with the applicable sections of the IRC. The plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
