Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Safe-Harbor 403(b) Thrift Plan for Employees of Union Community Care (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Safe-Harbor 403(b) Thrift Plan for Employees of Union Community Care (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution and Internal Revenue Code (IRC) 403(b) safe-harbor plan covering substantially all employees of Union Community Care (the Organization or the Plan Sponsor) except for those that are non-resident aliens, as defined, with no U.S. source income. A tax deferred annuity contract (TDA) from an earlier plan was previously rolled into the current Plan. New participants are not permitted in the TDA portion of the Plan and salary deferrals and employer contributions are not allocated to this part of the Plan. The balance in the TDA was \$1,014,642 and \$907,148 at June 30, 2025 and 2024, respectively. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management and the Investment Subcommittee (Subcommittee) are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings, monitor investment performance, and report to the Organization's Board of Directors.

The Plan is in operational compliance with the requirements of current laws and regulations. Formal amendments will be adopted by the prescribed deadlines.

Participation

Employees of the Organization are eligible to contribute elective salary deferrals and receive employer safe-harbor matching contributions on the first day of the month following their date of hire. There is no age requirement to participate in the Plan.

Contributions

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan agreement, not to exceed the maximum limit established by the IRC. Roth elective deferrals are also permitted and are matched in the same manner as pre-tax elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1 percent of eligible compensation, with an annual increase of 1 percent each year, up to 4 percent, and their contributions invested in a designated fund until changed by the participant.

For the year ended June 30, 2025, qualifying participants received an employer safe-harbor matching contribution equal to 100 percent of the first 3 percent, plus an additional 50 percent of the next 2 percent, of Plan compensation that the eligible participant contributed to the Plan. Employer base contributions are not permitted by the Plan.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Organization's safe-harbor matching contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in all contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive the value of the vested interest in his or her account as a rollover to another qualified plan or individual retirement account, or as a lump sum distribution net of applicable taxes and penalties. Upon termination of service due to separation, a participant will receive a lump sum payment without consent if the value of the vested interest in his or her account does not exceed \$1,000. Provisions are available to allow withdrawals of benefits prior to termination of employment as defined in the Plan agreement and in compliance with the IRC.

Forfeited Accounts

There are no forfeitures under the current Plan structure since all amounts vest immediately.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash Equivalent

Cash equivalent consists of funds held in the interest accumulation account of Mutual of America Life Insurance Company's general account and is credited with interest at a rate determined by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company reserves the right to change the interest rates applicable to amounts held in the interest accumulation account at its discretion. If funds are transferred to another funding vehicle or investment, they may be subject to market value adjustment.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management and the Subcommittee determine the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses.

Contributions

Contributions from Plan participants and the employer safe-harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Plan Loans from Custodian

Participants may borrow directly from Mutual of America Life Insurance Company, the custodian, using a portion of their account balance as security for the loan. The minimum loan is \$1,000 and may be up to the lesser of \$50,000 or 50 percent of the participant's account balance. The loans bear interest at a rate of 5.85 percent, which is commensurate with local prevailing rates as determined periodically by Mutual of America Life Insurance Company. Principal and interest are paid ratably through bi-weekly payments by the participant to Mutual of America Life Insurance Company. The Plan Administrator has concluded that these loans are not Plan assets. Accordingly, these loan balances are excluded from the statements of net assets available for benefits.

The balance of the Plan loans was \$57,185 and \$21,666 at June 30, 2025 and 2024, respectively. Under the borrowing terms, the loans are collateralized by the participant's account balance in an amount equal to 120 percent of the outstanding loan balance. At June 30, 2025 and 2024, \$68,622 and \$25,999, respectively, of Plan assets served as collateral to these loans. Interest paid to Mutual of America Life Insurance Company by participants on such loans during the plan year ended June 30, 2025, was \$2,720. There was no interest paid to Mutual of America Life Insurance Company during the plan year ended June 30, 2024.

In the event of default, such loans are reportable to Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the Plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan or attachment is otherwise permitted by applicable law. As of June 30, 2025 and 2024, there were no loans in default.

Subsequent Events

Plan management has evaluated subsequent events through February 24, 2026, the date the financial statements were available to be issued. See Note 10.

3. INVESTMENTS

Mutual of America Life Insurance Company, the custodian and recordkeeper, holds the funds for the Plan and maintains an individual account for each participant. Contributions made on a participant's behalf under the Plan are directly allocated to that participant's account and are invested, based on the participant's direction, in various investment options offered by the Plan.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted

quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Cash equivalent: Valued at cost and classified within Level 1 of the valuation hierarchy.

Pooled separate accounts: Comprised of mutual funds that are valued at the net asset value (NAV) of shares held by the Plan at year end. The publicly quoted prices of these investments are used in determining the NAV of the pooled separate accounts, which are not publicly quoted. NAV is used as a practical expedient to fair value, and shares may be redeemed on a daily basis.

5. INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental information was obtained by Plan management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, the custodian of the Plan:

- Investment balances included in the statements of net assets available for benefits at June 30, 2025 and 2024, and in the notes to the financial statements.
- Investment income included in the statement of changes in net assets available for benefits for the year ended June 30, 2025, and in the notes to the financial statements.
- Information included in the accompanying schedule of assets (held at end of year).

6. TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC and is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan has adopted a pre-approved safe-harbor 403(b) thrift plan provided by Mutual of America Life Insurance Company. The IRS determined and informed Mutual of America Life Insurance Company by an opinion letter dated March 31, 2017, that the form of the pre-approved plan, as then designed, was in compliance with applicable provisions of the IRC. The Plan has been amended since Mutual of America Life Insurance Company received the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes that the Plan is qualified, and the related accounts are tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

9. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

A related party is any party who can control or significantly influence Plan management or operating policies. Parties in interest are defined under Department of Labor regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investments advisors, legal counsel, and Plan auditor.

During the year ended June 30, 2025, the Plan made direct payments of \$6,049 to certain parties in interest for custodial, recordkeeping, and other administrative services, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan.

Mutual of America Life Insurance Company issues loans to Plan participants, which are secured by the participants' account balances, but are contractual agreements between Mutual of America Life Insurance Company and the Plan participant and are funded by Mutual of America Life Insurance Company's general fund. These transactions qualify as party in interest transactions.

Mutual of America Life Insurance Company receives revenue from the underlying mutual fund providers for services Mutual of America Life Insurance Company provides to the fund. This revenue is used to offset certain amounts owed to Mutual of America Life Insurance Company for its administrative services to the Plan.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

10. SUBSEQUENT EVENT

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in the 2026 plan year and beyond. Plan management is evaluating these provisions and will update the Plan's governance and operations.
