INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Carolina Community Actions, Inc. 403(b) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF PLAN

The following description of Carolina Community Actions, Inc. (“the Company”) 403(b) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan permits contributions to be made by all employees of Carolina Community Actions, Inc. except those who normally are scheduled to work less than 20 hours per week and less than one year of service. For nonelective contributions, employees will be eligible if they have completed 90 days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The plan administrator determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions. Each year, participants may contribute pretax annual compensation up to the amount permitted by the law, as defined in the Plan. Participants that have completed at least 15 years of service or who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company makes a non-elective contribution based on the Participant’s number of years of service. As of November 1, 2023 all employee and employer contributions are invested through the Mutual of America investment options. For the years ended December 31, 2024 and 2023, the Company made non elective contributions of \$340,737 and \$345,394, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, other 403(b) plans, other governmental 457(b) plans and traditional IRA accounts. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a guaranteed interest account, twenty-seven pooled separate accounts, and fifteen mutual fund accounts.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s non-elective contribution, (b) Plan earnings (losses), and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. The Company’s non-elective contributions portion of their accounts plus actual earnings thereon are based on years of continuous service, and a participant is 100% vested after three years of credited service.

Notes Receivable from Participants. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of the participant's account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.00% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator.

Payment of Benefits. On termination of service due to death, disability, retirement or separation from service, a participant may elect to receive either a single lump sum payment, payments over a certain period not exceeding life expectancy or payments from an annuity. The Plan also permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan Document.

Forfeited Accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,612 and \$0. For the years ended December 31, 2024 and 2023, forfeitures of \$0 and \$2,069 were utilized to reduce plan administrative expenses.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition. Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on participant is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. At December 31, 2024 and 2023, there were no amounts accrued for excess contributions.

Payments of Benefits. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Non-investment costs and certain administrative expenses of the Plan are paid by the Sponsor, which is a party-in-interest. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions under ERISA. Investment related expenses are offset against the related investment income.

NOTE C - INFORMATION PREPARED AND CERTIFIED BY TRUSTEES

As of December 31, 2024, the Plan's investments were held by the Trustees, Equitable Financial Life Insurance Company and Mutual of America Trust Company. As of December 31, 2023, the Plan's investments were held by the Trustees, Equitable Financial Life Insurance Company, Principal Trust Company, and Mutual of America Trust Company. The following information included in the accompanying financial statements was obtained from data that has been prepared and certified to as complete and accurate in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 by the trustees. For the years ended 2024 and 2023, the certifications were prepared on the cash basis.

NOTE D – FAIR VALUE MEASUREMENTS

FASB ASC 820 Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in the active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (PSAs): Valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities). While the majority of the underlying assets values are based on quoted prices, the net asset value (NAV) of the PSAs are not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on measurement date.

Guaranteed Interest Accounts: Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement. This fair value represents contract values adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

Changes in Fair Value Levels: The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan administrator evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of levels 1, 2, or 3.

NOTE E – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

As of December 31, 2024, the Plan holds a fully benefit responsive guaranteed investment contract with the Equitable Financial Life Insurance Company (“Equitable”). As of December 31, 2023, the Plan held fully benefit responsive guaranteed investment contracts with Equitable and the Principal Life Insurance Company (“Principal”). Both Equitable and Principal maintain the contributions in a general account of the respective company. Each account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The respective guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because these guaranteed investment contracts meet the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contracts are presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Equitable and Principal, represents contributions made under their respective guaranteed investment contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the Equitable investment contract at December 31, 2024 and 2023 was \$1,768,239 and \$1,777,285, respectively. The contract value of the Principal investment contract at December 31, 2024 and 2023 was \$0 and \$17,546, respectively. The crediting interest rate is based on a formula agreed upon with the respective issuer but may not be less than 1.5% (Equitable) or 1.5% (Principal). Such interest rates are reviewed from time to time by the respective issuer.

Certain events limit the Plan’s ability to transact at contract value with Equitable or Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan’s investment guidelines, (b) a material amendment to the contract without the issuer’s consent, (c) a violation of material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As detailed in Note B, the Plan sponsor pays for the Plan audit thus the transactions of both the Plan auditor and Plan sponsor are party-in-interest transactions. The Plan assets further paid \$22,896 of expenses for recordkeeping services of Mutual of America. Thus, Mutual of America is considered additional parties-in-interest.

NOTE G – CONCENTRATION OF RISK

For the year ended December 31, 2024, the Plan currently offers a guaranteed interest account, twenty-seven pooled separate accounts, and fifteen mutual fund accounts as investment options for participants. However, the following two funds make up 51% of the total net assets available for benefits: Equitable Guaranteed Interest Account and Mutual of America Clear Passage 2025 Fund. Individually, each of these funds make up 27% and 24% of the total net assets available for benefits, respectively. Therefore, these two funds represent material concentrated amounts.

NOTE H - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

NOTE I - TAX STATUS

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (the “IRC”). The Plan is relying on the IRS approval of the volume submitter 403(b) plan that it is utilizing. The IRS determined and informed Mutual of America Financial Group by a letter dated March 2, 2020 that the prototype Plan document was designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trusts are tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator believes the Plan has undertaken no uncertain positions as of December 31, 2024. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE J – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE K – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through February 26, 2026, the date the financial statements were available for issuance.
