### NOTE 1 - DESCRIPTION OF PLAN

#### Nature of the Plan

The following description of the Simulation Technologies, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan's Summary Plan Description for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of the Plan Sponsor, Simulation Technologies, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Eligibility

Participation in the Plan is available to all eligible employees of the Company that are age 18 or older.

#### Contributions

*Participant Salary Deferrals* - Participants may contribute up to 80% of before tax annual compensation, as defined by the Plan, up to a maximum amount established by the Internal Revenue Service (IRS). Effective June 15, 2025, participants may contribute up to 100% of before tax annual compensation as defined by the Plan, up to a maximum amount established by the Internal Revenue Service (IRS). Participants 50 years or older during the Plan year are eligible for catch-up contributions, up to a maximum amount established by the IRS.

*Participant Roth Deferrals* - Participants may designate some or all of their participant salary deferral as a Roth deferral. Once made, this election is irrevocable (that is, a participant Roth deferral cannot later be re-characterized as a pre-tax participant salary deferral). The amount of the participant Roth deferral is included in participants' income for tax purposes, and the income tax withholding amounts are deducted from the remainder of compensation, not from the participant Roth deferral amount.

*Employer Safe Harbor Match* - Each Plan year, the Company makes a contribution to all participants in an amount equal to 3% of eligible compensation. The Company made a safe harbor match contribution totaling \$831,440 to the Plan for the year ended September 30, 2025.

*Employer Discretionary Profit Sharing* - The employer may also elect to contribute a discretionary profit sharing contribution based on eligible compensation. The Company made a profit sharing contribution totaling \$4,012,026 to the Plan for the year ended September 30, 2025. Participants must be employed on the last day of the Plan year to share in discretionary profit sharing contributions.

### **NOTE 1 - DESCRIPTION OF PLAN - Continued**

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Safe Harbor contributions, discretionary profit sharing contributions, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately 100% vested in their elective deferrals and all employer contributions.

#### **Investment Options**

A participant may direct employee contributions in 0.01% increments among a diversified mix of investment options available to the Plan. Participants invest in the trust fund, which is held by Vanguard Fiduciary Trust Company (the Trustee). Vanguard Fiduciary Trust Company is also the recordkeeper. Participants may make changes to their investment elections at any time.

#### **Payment of Benefits**

Benefits commence upon one of several dates: normal retirement, late retirement, date of disability, death, or termination of employment. Benefits are distributed by means of either direct rollover, partial, or lump-sum distributions.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000, reduced by the excess (if any) of the highest outstanding balance of loans during the one-year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the loan is made, or 50% of the present value of the participant's account balance. Participants can only have one outstanding loan at any point in time. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of 5.25% - 10.50%, which is commensurate with local prevailing rates and determined by the Plan Administrator at the time of issuance. Principal and interest are paid ratably through payroll deductions.

#### **Forfeitures**

Forfeitures are retained in the Plan and may first be used to pay administrative expenses or to reduce future employer contributions. Forfeitures available for use at September 30, 2025 and 2024, totaled \$42,675 and \$2,302, respectively. No forfeitures were used during the year ended September 30, 2025.

### **NOTE 1 - DESCRIPTION OF PLAN - Continued**

#### **Hardship Withdrawals**

Participants are allowed withdrawals in the event of hardship due to immediate and heavy financial need as permitted by the U.S. Treasury regulations.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation of fair value of investments. Administrative expenses of the Plan can be reduced by forfeitures. Administrative expenses recorded in the Plan represent processing fees, distribution fees, participant loan origination fees and annual maintenance fees paid directly from the Plan to the Plan's custodian. Loan and distribution fees are deducted directly from the participants' accounts.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through January 23, 2026, the date the financial statements were available to be issued.

#### **Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued**

#### **Fair Value**

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### **Concentration of Market Risk**

As of September 30, 2025 and 2024, approximately 11% of the Plan's net assets were invested in one registered investment. The underlying value of the investments are dependent on the performance of the individual investment holding and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the registered investment balances in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

### **NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, Vanguard Fiduciary Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments at fair value and notes receivable from participants, included in the statements of net assets available for benefits as of September 30, 2025 and 2024.
- Investment income, interest income on loans, and net appreciation in fair value of investments, included in the statement of changes in net assets available for benefits for the year ended September 30, 2025.
- The schedule H, line 4i - schedule of assets (held at end of year) as of September 30, 2025, included in the supplemental information.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

### **NOTE 4 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities may occur in the near term and those changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

### NOTE 5 - FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at September 30, 2025 or 2024.

- *Money market funds*: Valued at amortized cost which approximates fair value.
- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common stock*: Valued at the daily average as reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan assets are shares of mutual funds which are managed by the trustee, Vanguard Fiduciary Trust Company, and therefore, these investment transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee totaled \$88,392 for the year ended September 30, 2025. The Company performs all administrative duties for the Plan.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 8 - TAX STATUS**

On November 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself, and the Plan has been modified since the determination letter. However, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained upon examination by the tax authorities.

The Company has concluded that as of September 30, 2025 and 2024, the Plan had no significant uncertain tax positions or material amounts of unrecognized tax benefits that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.
