Notes to Financial Statements

Note 1: Description of Plan

The following description of the Eau Claire Co-op Oil Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Eau Claire Co-op Oil Company (the "Company") who have two months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligible employees include all regular employees of the Company over the age of 18. Employees are eligible to participate in the Plan on the first day of the month coinciding with or next following the date subsequent to completing 60 days of service. Company contributions also require 60 days of service.

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements.

Contributions

Each year, participants may contribute up to 100% of pre-tax or post-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Eligible employees are auto-enrolled at 4% of eligible compensation, with annual increases of 1% up to a maximum of 12%. The Company makes a safe harbor contribution of 3% of the employee's compensation. Additional profit sharing amounts may also be contributed at the discretion of the Company. For the year ended June 30, 2025, the Company made safe harbor contributions of \$518,895, and profit sharing contributions of \$1,884,872 to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor contributions, and allocations of (a) the Company's profit sharing contribution, (b) Plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor contributions plus actual earnings (losses) thereon. Vesting in the Company's discretionary profit sharing contribution portion of a participant's account is based on the number of years of service.

Company profit sharing contributions vest according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years	0 %
2 years	20 %
3 years	40 %
4 years	60 %
5 years	80 %
6 years or more	100 %

Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through ACH and payroll deductions.

Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive an amount equal to the value of the participants vested interest in his or her account in either a lump sum amount or in annual installments if the account balance is greater than \$7,000. If the participants vested account balance does not exceed \$7,000, it can only be distributed in a single lump sum payment. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2 and ad-hoc partial distributions for post-severance distributions.

Forfeitures

At June 30, 2025 and 2024, forfeited nonvested accounts totaled \$113,218 and \$60,929, respectively. These accounts will be allocated as an additional Company profit sharing contribution or will be used to pay administrative expenses of the Plan, in accordance with the Plan document. For the year ended June 30, 2025, forfeitures of \$60,929, were allocated to participants as an additional Company profit sharing contribution subsequent to year-end.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through February 25, 2026, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of June 30, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common trust fund - Putnam Stable Value Fund: Valued at the NAV as a practical expedient to estimate fair value. The Putnam Stable Value Fund was based on the underlying unit value of assets reported by the traditional and synthetic guaranteed interest contracts with various crediting formulas. The stable value fund invested in investment contracts issued or sponsored by various insurance companies and commercial banks.

Collective investment trust funds: Valued at NAV as a practical expedient to estimate fair value. The funds were based on the underlying unit value of assets reported by the investment trust. The funds are not mutual funds and seek to provide total return by investing in investment grade, fixed income securities.

Note 3: Fair Value Measurements (Continued)

Pooled separate accounts: Fair value is estimated using the NAV per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of underlying investments held by the pooled separate accounts.

Note 4: Information Prepared and Certified by the Custodian/Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by The Standard Insurance Company and Empower Trust Company, LLC (the Custodian/Trustee of the Plan).

Management has obtained certifications from The Standard Insurance Company as of June 30, 2025 and for the period December 12, 2024 to June 30, 2025, and Empower Trust Company, LLC as of June 30, 2024, and for the period July 1, 2024 to December 11, 2024.

Note 5: Party-in-Interest Transactions

Certain Plan investments are managed by Orgel Wealth Management. Empower Trust Company, LLC was the Trustee and recordkeeper for the Plan through December 11, 2024. Fees incurred and paid by the Plan for investment management and recordkeeping services are paid from Plan assets. These transactions qualify as party-in-interest transactions.

Starting December 12, 2024, The Standard Insurance Company is the Custodian and record keeper, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for investment management and recordkeeping services are paid from Plan assets. These transactions qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company's discretionary contributions.

Note 7: Tax Status

The Company adopted a non-standardized plan document with an IRS opinion letter, which states the plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended, since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.
