On behalf of Palm K-MAX HEALTH PRODUCTS CORPORATION, we respectfully submit this letter regarding the late filing of Form 5500 for the plan year 2024, EIN 95-4776286, Plan Number 285399.

We sincerely apologize for the delayed submission. Palm is a trade-based company that was significantly impacted by the sudden and substantial increase in import tariffs. As a result of these unexpected economic pressures, the company was forced to temporarily cease operations. During this period, key management personnel responsible for administrative and compliance matters were no longer in place, which unfortunately led to the delay in filing.

The delay was not intentional and was not due to willful neglect. Rather, it arose from extraordinary business hardship and operational disruption beyond our reasonable control.

Upon stabilization of the company's operations, we promptly reviewed our compliance status, completed the required filing, and have taken corrective actions to prevent recurrence. These measures include reestablishing administrative oversight, implementing compliance tracking procedures, and assigning clear responsibility for future ERISA reporting obligations.

Palm is fully committed to maintaining compliance with all applicable reporting requirements. Given that this was an isolated incident resulting from severe and unforeseen economic circumstances, we respectfully request consideration for a waiver or reduction of any penalties that may be assessed.
