Scope and nature of the ERISA Section 103(a)(3)(C) audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 13, 2024 and December 31, 2023, and For the period from January 1, 2024 to December 13, 2024, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedule required by ERISA

The supplemental schedule of delinquent participant contributions for the year ended December 13, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF THE PLAN

The Fellers 401(k) Plan (the “Plan”) is an Internal Revenue Code (“IRC”) 401(k) defined contribution plan, which was adopted as of January 1, 2002. The Plan covers all eligible hourly and salary employees of Fellers, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

Employees become eligible to participate in the Plan upon completion of at least one hour of service within a 90-day period following the employee’s commencement date. Employees may begin participating in the Plan on the first day of the month immediately following or coincident with the first day the employee meets the service requirement.

The Plan Administrator is responsible for oversight of the Plan. The Plan is administered by the Company and Willis Towers Watson PLC, which serves as the Plan’s third-party administrator (“TPA”). Empower Retirement, LLC (“Empower”) serves as the trustee and record keeper of the Plan.

Contributions

Participants may contribute, on a pre-tax basis, from 1% to 100% of their eligible compensation each pay period, subject to limitations of the IRC. Participants may also make rollover contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Except for Roth contributions, the Plan does not allow for after-tax contributions.

The Company may make discretionary matching and profit-sharing contributions to the Plan. No such discretionary matching or profit-sharing contributions were made during the years ended December 13, 2024 and December 31, 2023, respectively.

Administrative Expenses

Expenses of administering the Plan are paid by the Plan unless paid by the Company. All expenses paid by the Plan are allocated proportionately among the investment funds and the participant’s balances. The Company paid no expenses related to the Plan during the years ended December 13, 2024 and December 31, 2023, respectively.

Forfeitures

Forfeitures of contributions are used to offset future Company contributions or administrative expenses of the Plan. The balances of forfeitures available to offset future Company contributions and administrative expenses as of December 13, 2024 and December 31, 2023 were \$23,972 and \$18,903, respectively.

Participant Accounts

Each participant’s account is credited or charged, as applicable, with the participant’s contributions, an allocation of the Company’s contributions, if any, and an allocation of investment earnings and losses and administrative expenses. Participants direct their contributions, including any Company contributions, into several investment options. Plan earnings and losses are allocated to the participants’ accounts daily based on the ratio of each participant’s account in each investment fund to the total of all participants’ accounts in each investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

Vesting

Participants are immediately vested in their own contributions plus or minus any earnings or losses thereon. Participants are also immediately vested in any Company contributions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or attainment of normal retirement age (age 65), a participant (or the designated beneficiary in the event of death) may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Payments are made as a lump-sum distribution to participants with account balances less than \$1,000. Participants with account balances greater than \$1,000, but less than \$5,000, have their account balance automatically rolled over to an individual retirement account, unless the participant elects to receive their account balance in a lump-sum payment. Participants with account balances greater than \$5,000 will have their account distributed within 60 days after the end of the Plan year in which the participant is terminated. In addition, hardship distributions are allowed from a participant's voluntary contributions prior to separation of service, if certain requirements are met.

Notes Receivable from Participants

All participants are eligible to borrow funds from the Plan, and all applications are subject to the review and approval of the Plan Administrator. Participants are limited to two notes outstanding at any time. Notes may be made for a minimum of \$1,000 and a maximum of the lesser of \$50,000 or 50% of the vested interest in the participant's account. The notes bear interest at the prevailing rate used by commercial lending institutions plus 2.0%, mature no later than five years from the origination date (unless for the purchase of participant's principal residence), and are fully secured by the participant's irrevocable pledge of up to 50% of his or her account balance in the Plan. Principal and interest are paid ratably through weekly payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value based on quoted market prices or NAV practical expedient (see Note E). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recognized on a trade-date basis. Interest income is recorded on an accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 13, 2024 and December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable to Participants

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. The Plan had excess contributions during the year ended December 31, 2023. The Plan distributed the excess contributions to the applicable participants prior to May 15, 2024. The Plan had no excess contributions during the year ended December 13, 2024.

NOTE C - PLAN MERGER

Effective December 13, 2024, the Plan merged into the LifeSight Pooled Employer Plan (the "Pooled Plan") and all assets were transferred to the Pooled Plan. From that day onward, all benefits payable under this Plan will be governed by the terms of the Pooled Plan. On December 13, 2024, \$8,718,682 of assets were liquidated and transferred and \$1,697,745 of assets were transferred in-kind. Accordingly, the Plan has no assets as of December 13, 2024 and the statement of changes in net assets available for benefits is a short period covering January 1, 2024 through December 13, 2024 as the Plan has a normal year-end of December 31.

NOTE D - MERGER AND TRANSFER AGREEMENT

During the year ended December 31, 2023, in connection with the merger of Interwest Distribution Company, LLC and Fellers, LLC, the Interwest Distribution Company, LLC 401(k) Plan (the "Interwest Distribution Company, LLC Plan") and the Fellers 401(k) Plan entered into a Merger and Transfer Agreement (the "Agreement") effective February 10, 2023. Under the terms of the Agreement, total Interwest Distribution Company, LLC Plan assets of \$2,704,521 were transferred to the Plan on April 14, 2023.

NOTE E - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 13, 2024 and December 31, 2023.

Money market and mutual funds: Valued at fair value based on published market prices as of the close of business on the last business day of the Plan year, which represents the NAV of shares held by the Plan.

Self-directed brokerage account: Priced at end of day market values of individual holdings in the participants' accounts based on holdings of common stock and money market shares.

Collective trust funds: Valued at fair value using the NAV practical expedient as determined by the Plan based on the current fair values of the underlying assets of the funds.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F - TAX STATUS

The Internal Revenue Service ("IRS") has informed the TPA by a letter dated June 30, 2020, that the prototype plan document used by the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of submission for the prototype plan opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with

the applicable requirements of the IRC and, thus, the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 13, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. Such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

For the year ended December 13, 2024, there are no investments held with any party-in-interest.

NOTE I - INFORMATION CERTIFIED BY EMPOWER

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate for the respective plan year in which it served as trustee:

- Investments, at fair value and contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 13, 2024 and December 31, 2023.
- Net depreciation in fair value of investments, dividends, and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 13, 2024.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE J - NONEXEMPT TRANSACTIONS

The Plan identified no untimely remittances related to the 2024 Plan year. The Plan identified \$9,560 of untimely remittances according to Department of Labor's (DOL) regulations during. The Plan corrected and restored participant accounts for the Delinquent Contributions and associated lost earnings using the DOL Voluntary Fiduciary Correction Program and are included in the Totally Fully Corrected Under VFCP and
