Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1 – Plan Description

The following description of the Cabin Creek Health Systems, Inc., 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Cabin Creek Health Systems, Inc. (the “Center”). Fidelity served as the custodian of the Plan through October 7, 2021, on which date substantially all Plan assets were transferred to a new custodian, Empower Trust Company. Approximately \$16,900 and \$16,500 of plan assets remained in Fidelity at June 30, 2025 and 2024, respectively. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan does not cover employees covered by a collective bargaining agreement. Effective July 1, 2026, the Plan’s definition of compensation will be amended to exclude group term life insurance and other taxable fringe benefits including educational assistance.

Contributions

The Employer contributes a non-elective 3% safe harbor amount to the plan based on a percentage of each participant’s compensation annually. A discretionary profit-sharing contribution may also be made annually (2% for the year ended June 30, 2025) to eligible employees who are employed at the end of the plan year.

Employees may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed the maximum allowable under the *Internal Revenue Code* (the “IRC”). Participants may contribute to the Plan a specific percentage or dollar amount on a pre-tax or post-tax basis. The Plan includes an automatic salary deferral feature of 3% of compensation which applies unless a salary deferral agreement is already in effect. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts

Each participant’s account is credited with the Plan Sponsor’s safe harbor and discretionary contributions, if any, the participant’s contributions, and investment earnings and losses. Accounts are charged with withdrawals and an allocation of Plan administrative expenses. Allocations are based on participant earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their employee contributions and safe harbor employer contributions plus actual earnings thereon. Vesting in the Center’s discretionary contribution is based on years of continuous service in which a participant completes 1,000 hours. A participant is 100% vested in their profit sharing account upon the attainment of their normal retirement age, death, permanent disability, or upon the completion of three years of credited service. As of August 1, 2022, the 1,000 hour requirement is no longer present to receive the discretionary amount.

Forfeitures

Forfeitures of a terminated participant's non-vested account balance following a break in service are first applied to pay administrative expenses under the Plan. The remaining forfeiture balance is used to reduce employer contributions. During the year ended June 30, 2025, there were approximately \$15,600 of forfeitures used to pay Plan fees. At June 30, 2025, approximately \$4,000 is available to reduce future contributions or pay plan expenses as applicable.

Plan Termination

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Payment of Benefits

Upon termination of service, a participant whose vested account balance is equal to or less than \$1,000 is required to receive a lump-sum payment, including interest, with or without participant's consent. If the vested portion of a participant's account balance is greater than \$1,000, the participant may receive a lump sum payment. Partial withdrawals and installments are allowed only with respect to minimum required distributions, over a period not exceeding the participant's or, if elected, their beneficiary's life expectancy. Such installments and payments would begin as soon as administratively feasible after the close of the Plan year, after termination of employment or upon reaching normal retirement age.

Income Tax Status

The Plan adopted a non-standardized defined contribution pre-approved plan which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since that time, however, the plan administrator believes that the Plan is designed and continues to operate in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in conformity with the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

All of the administrative expenses of the Plan are paid by the Plan after applying participant forfeitures.

Subsequent Events

Subsequent events have been evaluated through February 23, 2026, the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

U.S. government securities: Valued using pricing models maximizing the use of observable inputs for similar securities.

Collective Trust Funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Stable value collective trust fund: Composed primarily of fully benefit-responsive investment contracts and valued at the net asset value of units of the collective trust. The fund is to provide consistent returns and provide capital preservation. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchase and sales) may occur daily. If the Plan initiates a withdrawal that will exceed \$1,000,000, advance written notice of five days is required. Full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner, if the balance would exceed certain thresholds set by the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
