Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the ICES, Inc. / Connecticut Transportation Solutions, LLC 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the ICES, Inc. / Connecticut Transportation Solutions, LLC 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at year end) and nonexempt transactions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note A - Description of the Plan

The following description of ICES, Inc. / Connecticut Transportation Solutions, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of ICES, Inc., and Connecticut Transportation Solutions, LLC (collectively the “Company”) who have attained age 18 and have completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Directors is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Administration

The Company is the Plan’s named fiduciary and plan administrator. The Company has appointed Principal Life Insurance Company (“Principal”) as the custodian of the plan and certain officers of the Company to act as the Plan trustees. Principal holds the Plan’s investments and executes investment transactions. The Plan’s record keeper is Principal Life Insurance Company. Principal prepares statements for participants, which include amounts of contributions, investment income, disbursements and fair value of investments. Principal also calculates distributions and forfeitures in the event of a participant’s termination of employment.

Contributions

Participant’s salary reduction election:

The Plan allows each participant to defer a percentage of their annual compensation, as defined by the Plan. Participants may designate all or a portion of their contributions as Roth deferral contributions. In accordance with the IRC, participant contributions were limited to \$23,500 and \$23,000 in plan years 2025 and 2024 and remain subject to periodic adjustments by the Internal Revenue Service (“IRS”). Participants who will reach age 50 by the end of the tax year can make catch-up contributions of up to \$7,500 in plan years 2025 and 2024. Participants who are age 60 to 63 can make catch-up contributions of up to \$11,250 for the plan year 2025. The Plan has adopted an Eligible Automatic Contribution Arrangement feature which applies to all eligible participants who have not made a salary deferral election (including an election not to defer) and as such, the Plan will have 3% of their eligible compensation withheld and deposited into the Plan, unless the participant affirmatively elects a different amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer contribution:

The Company may, at its discretion, make matching contributions to the Plan. For the plan years ended June 30, 2025 and 2024, the Company elected not to make any matching contributions. The Company may also make an additional discretionary nonelective contribution to the Plan at the option of the of Company's Borad of Directors. Employees are eligible to share in an allocation of the Company's matching and discretionary nonelective contributions as of the beginning of the calendar quarter following the completion of one year of service, as defined by the plan. Eligible employees must also be actively employed on the last day of the plan year to receive a matching contribution or share in the discretionary nonelective allocation. For plan years ended June 30, 2025 and 2024, the Company elected to make discretionary nonelective allocation contributions of \$110,000 and \$100,000 in each year, respectively. Participants also direct the investment of Company contributions.

Participant accounts

Each participant's account is credited with the participant's deferrals and the Company matching contributions, as well as allocations of the Company's discretionary nonelective contributions and Plan earnings. Plan contributions are participant directed and are invested in one or more investment vehicles available to participants under the Plan. Earnings and losses are determined by individual investment vehicle performance. Participant accounts are also charged an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability and early or normal retirement (as defined), participants shall become 100% vested in the Company contribution portion of their account. A participant becomes 20% vested after 2 years of service, 40% after 3 years of service, 60% after 4 years of service, 80% after 5 years of service and 100% after 6 years of service..

Investment options

The Plan is participant directed. The Plan currently offers a variety of mutual funds, pooled separate accounts and investment contracts as investment options for the participants.

Notes receivable from participants

The Plan provides for loans to participants which are repaid through payroll deductions. Loans (i) will bear a reasonable rate of interest, (ii) are secured by the participant's account, (iii) are available to all participants on a reasonable equivalent basis, (iv) are limited to the lesser of (a) 50% of the participant's vested account balance or (b) \$50,000 and (v) provide for repayment over a period not to exceed five years unless such loan is used to purchase a primary residence. The loan interest rate, determined at the date of the loan, is set at 1% above the prime rate. Principal and interest are paid ratably through monthly payroll deductions.

Payment of benefits

On termination of service for any reason, participants with a vested account balance of less than \$7,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date. In-service distributions may also be made to participants who have not separated from service and have attained the age of 59 ½ or have 10 years of service. Age 59 ½ in-service withdrawals are permitted to be made from all of the participant's accounts. In-service withdrawals for participants with 10 years of service are permitted to be made from the employer discretionary portion of the participant's account.

Hardship withdrawals

Withdrawals from a participant's salary deferral portion of their account may be made in the event of financial hardship, in accordance with the provisions specified in the Plan.

Forfeitures

Forfeited nonvested accounts totaled \$1,682 and \$523 at June 30, 2025 and 2024, respectively. Forfeited non-vested balances may be first used to pay Plan expenses and any remaining forfeitures will be used to reduce future employer contributions. During the plan years ended June 30, 2025 and 2024, respectively, \$28,137 and \$19,839 of forfeited nonvested accounts were used to pay Plan expenses.

Note B - Summary of Significant Accounting Policies

Basis of presentation

The financial statements of the Plan are presented on the accrual basis of accounting. Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The fair value of assets is determined using various methods, which are impacted by a number of factors, including the availability of observable market data over the contractual term of the underlying assets. For some of the Plan's assets, fair value is determined based on directly observable market data or data available for similar assets in similar markets. For other assets, the fair value may be determined based on these inputs as well as other assumptions related to estimates of these assets, such as the creditworthiness of the issuer. Changes in net unrealized appreciation or depreciation are captured in the carrying value of the underlying investments in the Statements of Net Assets Available for Benefits in accordance with US GAAP guidance. Dividends are recorded on the ex-dividend date.

Plan investments in mutual funds are stated at fair value based upon quoted market prices. Shares of common/collective trust funds are valued at net asset value.

Risk and uncertainties

The Plan provides the participants with options of investing in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Notes receivable from participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. No allowance for loan losses has been recorded as of June 30, 2025 and 2024. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Contributions

Employee and employer contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings.

Plan expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair values of investments.

Payment of benefits

Benefit payments are recorded when paid.

Note C - Fair Value Measurements

Accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described below:

Level 1 Inputs: Valuation based on quoted prices in active markets for identical assets or liabilities that a reporting entity has the ability to access at the measurement date, and where transactions occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 Inputs: Valuation based on inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, that is markets in which there are few transactions, prices are not current, or prices vary substantially over time.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs: Valuation based on inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at June 30, 2025 and 2024.

Shares of Registered Investment Companies

The Company determined that valuation measurement inputs of these equity securities required no adjustment from quoted prices in the market. As such, the Plan's investments in mutual funds reflect unadjusted quoted prices from active markets. Accordingly, the Company classified these Plan investments within Level 1 of the hierarchy framework.

Pooled separate account

Pooled separate accounts are valued using the accumulated unit value, which is based on the fair value of the underlying assets of the account. The accumulation unit value is deemed equivalent to NAV, which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. Participant transactions (purchases or sales) may occur daily.

Note D - Fully Benefit Responsive Investment Contract

The Plan is invested in the Principal Life Insurance Company Fixed Income Guaranteed Option. This investment contract meets the fully benefit-responsive investment contract criteria and, therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The balance of the traditional investment contract as of June 30, 2025 and 2024 was \$539,356 and \$433,447, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestiture or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from the contract. Examples of such events include the following (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under contract, (3) a material misrepresentation, (4) a material amendment to the agreements without the consent of the issuer.

Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditor not to extend audit procedures to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note F - Related Party Transactions

Certain Plan investments are shares of mutual funds, units of pooled separate accounts or an investment contract managed by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”). Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

Total administrative expenses paid to the custodian and third party administrator were \$72,071 and \$55,810 for the plan years ended June 30, 2025 and 2024, respectively. The Company pays directly any other fees related to the Plan's operations. The Plan allows participant loans which are also considered party-in-interest transactions.

Note G - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full termination, partial termination, or the complete discontinuance of contributions by the Company, all amounts credited to the affected participants' combined accounts shall become 100% vested.

Note H - Tax Status

The prototype plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter on June 30, 2020, in which the IRS states that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note I - Nonexempt Transactions

During the plan year ended June 30, 2025, the Company erroneously forfeited vested assets of a participant's account. The forfeited assets were then used to pay plan expenses. The Company corrected this oversight in January 2026 by restoring the forfeited assets including lost earnings attributable to the forfeiture to the effected participant's account. The Company also paid the applicable excise tax to the IRS.

Note J - Subsequent Events

The Plan administrator evaluated subsequent events through February 9, 2026 which is the date the financial statements were available to be issued.
