Independent Auditor's Report

To the Board of Trustees
Van Drivers Local 264 Pension Fund

Qualified Opinion

We have audited the accompanying financial statements of the Van Drivers Local 264 Pension Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits - liquidation basis as of June 30, 2025 and 2024, the related statements of changes in net assets available for benefits - liquidation basis for the years then ended, and the related notes to the financial statements.

In our opinion, except for the omission of information described in the Basis for Qualified Opinion paragraph, the financial statements referred to in the first paragraph present fairly, in all material respects, the net assets available for benefits - liquidation basis as of June 30, 2025 and 2024, and the changes in its net assets available for benefits on a liquidation basis for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Qualified Opinion

As described in Note 1 to the financial statements, because of the Plan becoming insolvent, the Pension Benefit Guaranty Corporation ("PBGC") is providing funds to cover funding deficiencies. For terminated multiemployer plans that have nonforfeitable benefits totaling \$50 million or less (which is the case for this Plan), the PBGC requires plan sponsors to perform an actuarial valuation only every five years. As such, the Board of Trustees has not requested that Plan actuaries perform a valuation as of July 1, 2024. Therefore, the Plan's financial statements do not present information regarding the Plan's accumulated plan benefits as of June 30, 2024, and the changes in accumulated plan benefits for the year then ended. In our opinion, presentation of that information is required to conform with accounting principles generally accepted in the United States of America. The Board of Trustees has not quantified the amount of, or changes in, the Plan's accumulated plan benefits; and in the absence of an actuarial determination, these amounts and their effect on the financial statements are not reasonably determinable.

Emphasis of Matter

As described in Note 1 to the financial statements, the Plan has been terminated by amendment effective October 23, 2012. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting from the "ongoing plan basis" to the "liquidation basis" for periods after October 31, 2012. Since the assets of the Plan are primarily presented on a current value basis and are of a short-term and liquid nature, there is little difference in the two bases of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements - Liquidation Basis June 30, 2025 and 2024

Note 1 - Description of the Plan

The following brief description of the Van Drivers Local 264 Pension Fund (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan of Benefits for more complete information.

General

The Plan was formed in 1961, and is a multi-employer pension plan covering member of Teamsters Local Union No. 264 (“Union”) who are employed by three Western New York employers contributing to the Plan under terms of the collective bargaining agreements with the Union. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by a Joint Board of Trustees, consisting of members appointed both by the employers and the Union.

Plan Termination

Effective October 23, 2012, the Plan was terminated by amendment by Plan Trustees in accordance with Section 4041A of ERISA. As a result of the termination, there will be no new participants in the Plan and no additional pension credits or vesting service can be earned, and participants cannot age into benefits for which they were not eligible on the Plan termination date.

Plan Insolvency

The Plan’s actuary estimated that the Plan would become insolvent during the plan year beginning July 1, 2018. For the Plan year in which the Plan is expected to become insolvent, pension benefits to participants in pay status are required by the Pension Benefit Guaranty Corporation (“PBGC”) to be reduced to a level where Plan assets and any estimated additional revenue would be sufficient to pay benefits and administrative expenses for the full Plan year. A participant’s benefit, however, cannot be reduced to a level that is lower than the benefit guaranteed by the PBGC. Effective July 1, 2018, benefits were reduced accordingly, and insolvency occurred in the Plan year beginning July 1, 2019.

The PBGC’s guaranteed benefit formula became effective July 1, 2019. As a general rule, the PBGC’s guaranteed benefit is calculated as follows: for each year of credited service under the Plan, the maximum guarantee of monthly benefits is limited to 100% of the first \$11 of the employee’s accrual rate, plus 75% of the next \$33 for each year of credited service or a maximum of \$35.75 per year of credited service. For purposes of calculating the guaranteed benefit, credited service is limited to one year in any plan year. In addition, the Plan may no longer provide the pre-retirement death benefit to a participant’s surviving spouse. Only those benefits which were non-forfeitable prior to insolvency of the Plan are guaranteed.

PBGC Funding

As a result of the Plan becoming insolvent, the PBGC is providing funds to cover funding deficiencies. The Plan sends the funding request to the PBGC on a quarterly basis to cover the funding deficiency for that period. The amounts received from the PBGC are considered to be loans to the Plan, and a security agreement is in place for such loans. The security agreement states that the PBGC will retain a security interest in all future employer contributions (payments in lieu of withdrawal liability) and withdrawal liability payments. Funding received is reflected as a non-current loan payable in the statements of net assets available for benefits.

The trust in which Plan assets are held will continue to administer payments of benefits funded primarily by amounts received from the PBGC.

Note 1 (Continued)

Pre-Termination Plan Provisions

Contributions

Until October 23, 2012, the Plan was funded by contributions from participating employers pursuant to collective bargaining agreements with the Union. The employers contributed an amount per week credited to each participant in accordance with the respective collective bargaining agreement. Additionally, employees were required to contribute \$5 for each week employed by his or her employer. The Plan is no longer subject to the minimum funding requirements of ERISA.

Pension Benefit

Participants with five (5) or more years of service were entitled to monthly pension benefits beginning at normal retirement age (65) calculated as follows:

The Plan allows for a maximum of 30 years of credited service. Participants may elect to receive their pension benefits in the form of a joint and survivor annuity. If a participant terminates before rendering 5 years of service, they forfeit the right to receive the portion of their accumulated plan benefits attributable to the employers' contributions. In addition, an employee shall be fully vested in his contribution at all times.

Death Benefit

If an eligible participant died before retiring, his or her spouse would receive a monthly benefit equal to 50% of what the participant would have received if he had retired and elected an immediate joint and survivor annuity on the date of his death.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are stated on the accrual basis and include all material accounts receivable and payable, all other significant liabilities, and deferred items. Prior to termination of the Plan, financial statements were presented on an "ongoing plan basis" of accounting. Accounting principles generally accepted in the United States of America require that financial statements of a terminated pension plan be prepared on a "liquidation basis" of accounting commencing with the date of termination (October 23, 2012). Since the assets of the Plan are primarily presented on a current value basis and are of a short-term and liquid nature, there is little difference in the two bases of presentation.

Note 2 (Continued)

Use of Estimates

The Trustees use estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, actuarial values, disclosure of contingent assets and liabilities, and the reported additions and deductions from Plan net assets available for benefits. Actual results could differ from such estimates.

Receivables

Receivables are recorded at their estimated realizable value.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

The Plan has evaluated subsequent events through February 20, 2026, the date these financial statements were available to be issued, for potential recognition or disclosure in the financial statements.

Note 3 - Receivables

Withdrawal Liability

The Plan had a withdrawal liability receivable from one employer that was paying its withdrawal liability at quarterly payments of \$1,324. The last payment was received on May 31, 2025.

Note 4 - Transactions with Affiliated Funds and Parties-In-Interest

Affiliated Entities

The Plan reimburses the Union for administrative expenses in accordance with an office sharing and administrative services agreement. Shared expenses are allocated by the Union to the Plan based on estimates. Shared costs allocated to the Plan amounted to \$12,642 and \$8,072 for the years ended June 30, 2025 and 2024, respectively. Shared costs payable to the Union at June 30, 2025 and 2024, are reflected in the statements of net assets available for benefits.

Note 5 - Tax Status

On November 17, 2015, the Plan received a favorable determination letter from the Internal Revenue Service indicating that it continues to qualify under Section 401(a) of the Internal Revenue Code. The Trustees believe that the Plan, including amendments subsequent to the IRS determination, is currently designed, and operated in compliance with the requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. Management believes that the Plan is no longer subject to income tax examination for the years prior to June 30, 2022.
